Thank you for brining to our attention the recent Canada Border Services Agency's ruling that the Alcohol Infused Whipped Cream you import into Canada is a food additive and not an alcohol product subject to federal excise tax. In your email you asked to be excused from the excise tax and that British Columbia delist this product and cease provincial markup.

Section 62 of the British Columbia *Liquor Control and Licensing Act* allows testing of products to determine whether they are sufficiently denatured to be sold without provincial government control or markup. This product was tested and a determination was made that this product must remain listed through the BC Liquor Distribution Branch complete with provincial markup.

The BC Liquor Distribution Branch will adjust your account so that you will no longer be charged the federal excise tax on Alcohol Infused Whipped Cream. This will be retroactive to 7 November, 2012, the date of the Canada Border Services Agency ruling letter.

Hi Gord,

Pure Global Imports has been marketing Alcohol Infused Whipped Cream in British Columbia and the product is listed through LDB. As you know, under section 62 of our Act we can test items to determine whether they could reasonably be used as a source of beverage alcohol. A focus group tested various flavours of this Alcohol Infused Whipped Cream and determined that it is not terribly onerous to consume and would very likely be attractive to minors. In addition, it did not take a large amount of the product to begin to become intoxicated. Therefore it had to be listed through your branch.

Attached is a ruling in letter form from the Canada Border Services Agency that appears to declare that this product is a dairy non-alcohol product. I have written the CBSA for a fuller explanation of their letter as we don't fully understand what it means. (Sorry their attached pdf letter is upside down. It came to us that way. I have also cut and pasted some legal info I dredged into a word doc as that may be helpful as well.)

The importer wrote your branch asking back the excise tax they have paid and that the product not be listed. He has written us saying "I have been advised that this ruling is National and takes precedence over any Provincial classification." Naturally this raises some concerns on our end. The whole email trail is below.

We are trying to determine jurisdiction here. We feel the province has jurisdiction but the CBSA ruling is at odds by not calling it an alcohol product. Barry suggested asking you for your take on this and perhaps Catherin Sloan's as well. I personally feel that we can declare it a alcohol confection if we have grounds.

Good afternoon Carole.

My name is Terry and I work in the Policy and Communications division of the British Columbia Liquor Control and Licensing Branch. I am seeking clarification on the attached letter.

Pure Global Imports has been marketing alcohol infused whipped cream in British Columbia. Under section 62 of our Liquor Control and Licensing Act we can test items that do not fall under what would be considered traditional beverage alcohol to determine whether products could reasonably be used as a source of beverage alcohol, especially by minors.

A focus group tested various flavour of this alcohol infused whipped cream and determined that unlike denatured cooking wine and other denatured non-beverage alcohol products this product is not onerous to consume and would very likely be attractive to minors due to its flavouring. In addition, it did not take a large amount of the product to become intoxicated. Therefore it was determined that in British Columbia this product would be treated as a beverage alcohol and sold through the liquor distribution system like any other beverage alcohol product. To not treat this product in this manner potentially opens the door for this product to be sold in non-controlled environments such as grocery stores, with easy access by minors.

The importer claims that you have determined that this product is not an alcohol product and should be exempt from excise tax and not be controlled as an alcohol product in our province. Naturally this raises some concerns.

As we do not know your legislation and policy can you comment on the exact meaning of your letter so we know what direction we should take. Alcohol sales are generally a provincial matter but we seem to be in a grey area here.



Further to our conversation, I have faxed you the same documents I sent to Stephanie Watts at LDB. There appear to be various issues here and I am hoping for some direction and/or clarification.

While at one of my Licensee Retail Stores on Wednesday, February 29th, an issue arose in relation to the above noted product.

My licensee did have concerns about the product and on review it appears there are a number of issues.

I also believe that BC Wine Shops, and/or their agent, is fully aware of the issues as they requested my licensee not discuss it with her liquor inspector.

The faxed documents include:

- 1. BC Wine Shop Package
  - You will noted one page is for PURE Global Imports and states to order the product: e.orders@bcwineshop.com
  - BC Wine Shop is not permitted to sell anything except BC Wines (if this is classified as a liquor product)
- 2. Hillebrand Westlink BOL 22058 (Distribution Warehouse where product was shipped from Alberta)
- Pure Global Imports Invoice # BCW1023 between my licensee and Global Imports (the product was ordered through BC Wine Company)
  - While it appears that the wholesaler is invoicing the licensee directly, the invoice # points directly to BC Wine Company
- 4. Email between my licensee and Karin Tower
  - d. Tower's signature appears over BC Wine Shop and Pure Global Imports Inc., indicating she is possibly an agent for both.
- 5. Internet Blurb (you can watch the video if you pull it up) out of Boston expressing concerns about the product
- 6. LCLA s.62(3)(3.1)(7) in relation to:
  - e. Licensee Retail Stores, and
  - f. Sale of High Alcohol content products in BC.
  - g. The product can be used/eaten/added to drinks, etc. directly from the can and is very appealing to the 'younger' clientele

There are a number of issues that need to be addressed I think.

- a. The product is not licensed through LDB for sale as an alcohol product in BC
- b. If it is not an alcohol product it needs to be approved through LCLB
- c. BC Wine Shop is not permitted to sell this product (even indirectly?)
- d. My licensee was advised that there were already 170,000 cases sold in BC as of approximately 2 plus weeks ago so I expect it could be considerably more now.
- e. It may not be a product, even under a different classification, that can be sold in LRS's.

i.e. However, your store must not resemble a convenience store, and you may not stock other items, such as milk and newspapers.

I think the issues are varied here – I have dealt with this from the perspective of my licensee and both of us would just like some clarification to make sure we are on the right track.

Your assistance in clarifying the legal aspects around this product would be appreciated.




- 62 (1) If a medicinal preparation contains liquor as one of its necessary ingredients, and also contains sufficient ingredient or medication to prevent its use as an alcoholic beverage, this Act does not apply to or prevent
  - (a) the compounding or sale of the medicinal preparation by a pharmacist if it is compounded from liquor purchased by the pharmacist under section 8 or under a permit held by the pharmacist, or
  - (b) the purchase or consumption of the medicinal preparation by a person for strictly medicinal purposes.
  - (2) Despite subsection (1), and subject to the *Pharmacy Operations* and *Drug Scheduling Act* and the regulations under that Act, the general manager may direct the manner in which a medicinal preparation containing liquor sufficient to be used as an alcoholic beverage must be sold, distributed and kept for sale.
  - (3) If a toilet, confectionery, culinary, herbal remedy, cleaning or disinfecting preparation contains liquor and also contains sufficient other ingredients or medication to prevent its use as an alcoholic beverage, this Act does not apply to or prevent the sale of that preparation to a person who purchases it for use as a toilet, confectionery, culinary, herbal remedy, cleaning or disinfecting preparation or for resale for a similar purpose.
  - (3.1) Despite subsection (3), the general manager may, in accordance with the regulations, direct the manner in which a toilet, confectionery, culinary, herbal remedy, cleaning or disinfecting preparation containing liquor sufficient to be used as an alcoholic beverage must be sold, distributed and kept for sale.
- (4) To determine whether a medicinal, toilet, confectionery, culinary, herbal remedy, cleaning or disinfecting preparation referred to in this section contains sufficient ingredients or medication to prevent its use as an alcoholic beverage, the general manager may have a sample of RECEIVEL

the preparation purchased or obtained from a person analysed by an analyst appointed or designated by the minister or the general manager for the purposes of this Act.

- (5) If a certificate purporting to be signed by the analyst referred to In subsection (4) shows that the analyst finds the sample analysed by him or her does not contain sufficient ingredients or medication to prevent its use as an alcoholic beverage, that certificate is conclusive proof that the preparation is not a preparation the sale or purchase of which is permitted by this section, without proof of the signature or official position of the analyst by whom the certificate is made.
- (6) A person who purchases or sells a preparation that is not a preparation permitted by this section to be purchased or sold commits an offence and, without limiting the liability of corporations under section 48, in the case of a purchase or sale by a natural person the liability on conviction is a fine of not less than \$500.
- (7) A person must not sell a preparation described in subsection (1), (2), (3) or (3.1) without taking reasonable measures to ensure that the preparation is being purchased for the intended purpose and is not being purchased for use as an alcoholic beverage.
