**ISSUE:** Conservation Lands and overlapping Range Act tenures

#### **BACKGROUND:**

Conservation lands are properties secured for fish and wildlife conservation purposes and administered by the Ministry of Forests, Lands and Natural Resource Operations (FLNR). The primary purpose of conservation lands is to conserve and manage important habitat for the benefit of regionally, nationally or internationally significant fish and wildlife species

The majority of these lands were originally acquired by government via one of the following means:

- 1. Fee simple acquisition of private land (by the Crown and HCTF) via purchase, exchange or donation
- 2. Fee simple acquisition by a private landowner (e.g. Nature Trust of BC) and leased to the Crown
- 3. Crown land transfer of administration from another ministry
- 4. Wildlife Management Area (WMA) designation under the *Wildlife Act* (note: administration of WMA lands was first acquired by one the above three means).

At the time of purchase, fee simple leased lands were free and clear of any grazing or hay cutting authority. A number were acquired with the specific purpose of extinguishing range tenures or acquiring control over future range use to meet wildlife objectives. Key partners in these acquisitions included MoE, The Nature Trust of BC, the Habitat Conservation Trust Foundation, Ducks Unlimited Canada, The Land Conservancy of BC and the Canadian Wildlife Service. The legal agreements used to secure the lands (including purchase and sale, lease or management agreements) may contain conditions that preclude or constrain grazing or hay cutting activities. Consent from the Wildlife Act Regional Manager is required for use of land or resources for these lands and lands where administration was transferred and did not have an existing Range tenure. Approval by the land owner is required for fee simple leased land.

Range use activities can result in long-term (50+ yrs), persistent impacts to native plant communities and wildlife.

It has been determined that Range Act tenure boundaries cover a large area of conservation lands across the province. A recent preliminary GIS analysis of overlapping Range Act tenures and conservation properties has found approximately 57 administered conservation land parcels out of approximately 240 sites affected by overlaps with range tenures.

All conservation lands are recorded in the Crown land registry system (Tantalis) for at least 10 years. Prior to that leased lands were shown as private land. A conservation lands' layer was created close to a year ago in the BC Government Warehouse (BCGW). This information has not been recognized in the status reporting process for some range tenures. It is not known if there are other tenure types that have similarly not been recognized.

Amendments to the Range Act have come forward in the spring legislative session and are through first reading. Changes include extending certain 5-year Range Act permits and all 10-year licences to longer term (15-25 year) licences with continual 'evergreen' renewal clauses.

There is an inconsistent approach to how we are managing Conservation Lands and overlapping Range Act tenures across the province. There is also an apparent lack of trust between Conservation and Range program staff, both at the headquarters and local level.
