Good morning Steve, welcome to your new position. I am contacting you on an urgent matter related to the Great Bear Rainforest announcement anticipated in early February:

- The RSP lead people associated with the GBR have been in contact with Vivian Thomas in the Premier's Office. February 4 was discussed as announcement date but I understand that Vivian is uncertain about Minister Thomson's and the Premier's availability for that day. Vivian suggested that the announcement may have to shift to the second week in February. This potential shift in dates concerns us and we feel that February 4th is the preferred date for a variety of reasons:
 - O Moving into the second week of February for the announcement will mean the event will get lost in the Throne Speech and Budget Speech media focus. The GBR decision is significant and will get North American attention and praise for the BC government, and it would be shame to miss this opportunity. A February 4 announcement would reduce this challenge.
 - The 10 year anniversary of the GBR agreement is February 6. It would be a shame to lose
 the leverage associated with having this announcement out the door prior to the 10
 year anniversary.

- o There are many people throughout BC, Canada and internationally waiting for this announcement, and they are getting anxious as rumours get out about another delay in the announcement. If you recall the announcement was going to be in late November and another delay will really take the edge from an incredible announcement that deserves a lot of praise for the BC government.
- o If the date shifts much past February 4, key NGO staff who has been working on this file for years will not be available (Valerie). She has set personal plans a few days after the February 4 date and to not have her able to attend after her contribution doesn't seem fair to her.

In closing, I would appreciate the opportunity to spend some time with you to give you a sense of what I am hearing re various environmental, post-carbon issues around the province --- perhaps over breakfast as we have done previously. Could you arrange for your office to contact me to arrange this.

Dear Norm & Steve,

As always, it was good to see you yesterday at the Kelowna Chamber of Commerce event. It was a great opportunity to go around the table and share and compare thoughts and ideas.

During our conversation about water providers in the City of Kelowna, it was mentioned that the provincial policy is not to force amalgamation of irrigation districts. I want to take this opportunity to point out the other provincial policies within the act that do empower the province to restructure irrigation districts.

Section 6.4.1 of the policy states: "The ministry will encourage municipalities having improvement districts within their boundaries to assume responsibility. In many cases, municipalities and improvement districts have established cooperative relationships, but municipalities are encouraged to plan for eventual assumption of responsibility."

The province wants amalgamations to be voluntary, but there are criteria to support a proactive approach to amalgamation.

Section 6.4.1 of the policy also notes the ministry will take a proactive role to restructure improvement districts which are:

- Experiencing problems with infrastructure
- Having serious management problems
- Facing irreconcilable conflicts with municipalities
- Not complying with legislation

The province's financial policy also supports the goal to see irrigation districts incorporated into local government authorities by stating the only way irrigation districts will receive funding is through local governments.

I look forward to the next steps in the process as we move toward a robust integrated water system that provides all Kelowna residents with reliable drinking water at equitable rates, while also meeting the needs of agriculture.



Wanted to follow up on our proposed event for next Wednesday at the Natural Resources Forum that Cynthia flagged this morning.

We've been working with BC Hydro on options to mark the completion of construction for the Dawson/Chetwynd Area Transmission project.

From speaking with BCH, GCPE and the Natural Resources Forum organizers, we think there is an opportunity in the conference schedule to leverage the line completion into a short media avail that tells the story about how government and BC Hydro are supporting the development of the natural resource industry. This is a critical transmission line for industry in the region.

The conference organizers have suggested that immediately following Jessica MacDonald's panel appearance on the Wednesday, herself, Minister Bennett and Minister Bernier (local MLA) would hold a media avail in the conference media centre from 11:45 to noon.

They would announce the completion of the project, discuss the economic impact of construction and the now completed line, and have one or two validators from industry who will be benefiting from the line speak as well (i.e. Shell).

Everyone would speak for two to three minutes, leaving a short window for questions, with a hard stop at 12:05 so the organizers can escort media back to the keynote lunch (organizers said keynote speech won't be until around 12:30).

BC Hydro can provide visual support with banners of pictures of the line and construction, and can provide B roll to TV stations as well. There would also be a call in line for Dawson Creek or provincial media to call in and listen.

- The report demonstrates both the progress the industry has made in health and safety and the work the industry faces in the future to make mining in B.C. safer and more sustainable.
- The 2014 report highlights an increase in mine both mine visits and mine inspections ministry inspectors conducted 1,228 inspections in 2014 compared to 904 inspections in 2013, with mine visits increasing to 1,809 in 2014 compared to 1,201 in 2013.
- The number of geotechnical inspections also increased to 38, compared to 31 in 2013.
- Injuries at B.C. mines remained low in 2014, a testament to industry and government's commitment to health and safety in the mining sector.
- The Ministry of Energy and Mines aims for timely, open and honest communications with the public.

KEY FACTS:

The Ministry of Energy and Mines released the 2014 Annual Report of the Chief Inspector of Mines on December 31, 2015. Specific highlights of the 2014 report include:

- Increases in mine visits and inspections.
- No increase in the annual injury rate from 2013.
- Reductions in the number of days of work lost to injury.
- A decrease in the number of dangerous occurrences.
- Three mining-related fatalities in 2014.

On Mount Polley:

On August 4, 2014, public confidence in mining in the province was shaken when a breach occurred at the tailings storage facility (TSF) at the Mount Polley mine, near the town of Likely. This incident was unprecedented and had farreaching consequences.

Shortly after the breach, three separate investigations were launched. An independent expert engineering panel was established to determine the root cause of the breach, and the Chief Inspector of Mines (CIM) and British Columbia Conservation Officer Service also began conducting investigations. As well, on August 18, 2014, the CIM issued an order to have mining companies complete and submit a Dam Safety Inspection for every TSF at a permitted mine at an accelerated deadline of December 1, 2014.

Because the CIM's investigation was ongoing as of the end of 2014, the annual report does not provide details on the outcomes of this investigation but instead directs readers to the Mount Polley breach web page.

On Mine Visits and Inspections:

The annual report provides a summary of Mine Management System (MMS) data, including the number of mine visits and inspections conducted and orders issued by MEM to mines in 2014. When and where inspections take place is determined by MEM inspectors. Because data in MMS is frequently updated, reports generated from this system are best viewed as a snapshot in time (i.e., data is subject to change).

Mine visits include site visits done by MEM staff and contractors for the purpose of conducting inspections as well as audits, meetings, investigations or training.

Inspections are prioritized based on several factors, including the safety and compliance record of individual operations; scale of operations; dangerous occurrences; availability of inspectors; and when an operation was last inspected.

On Fatalities:

There were 3 mining-related fatalities in 2014:

- On March 17, 2014, a service worker was fatally injured at Teck's Coal Mountain Operations (located about 30 km southeast of Sparwood) when he was struck by frozen mud, which dropped from the raised box of a haul truck.
- On September 16, 2014, the driver of a welding truck and a passenger were killed at the Swansea Ridge Quarry (located about 16 km south of Cranbrook). As of December 2015, MEM's investigation of this incident is ongoing.

Background:

The Chief Inspector of Mines is appointed by the Minister of Energy and Mines to administer and enforce the Mines Act and the Health, Safety and Reclamation Code for Mines in British Columbia. The Chief Inspector is also the Executive Director of the Health, Safety and Permitting Branch of the ministry's Mines and Mineral Resources Division. The Office of the Chief Inspector and the Ministry as a whole works closely with industry, workers and communities to ensure that mineral exploration and mining activities are conducted responsibly.

The Annual Report of the Chief Inspector of Mines is a requirement set out in Section 36 of the Mines Act and is compiled with the assistance of Ministry of Energy and Mines staff and contractors.

As promised, here's some information pertaining to an opportunity to make an announcement January 20 in Prince George with regard to CAUSES. This would be in addition to the work you have already done with Jeff regarding the Premier's remarks at the luncheon.

- Causes is an initiative established through support of the Mining Community (\$3M pledged) to provide genome sequencing, clinical evaluation and genetic counselling to families of children dealing with rare and undiagnosed
- Established just over a year ago, Causes aims to sequence 500 children. To date, 70 children have been screened and results are beginning to come in.
- The opportunity for an announcement is that the Doran family of Prince George is the first to have a diagnosis through this program. Their 5-year-old daughter Collyns is one of only six children in the world to have the rare disease for which she was diagnosed. The family learned of the diagnosis on December 23rd.
- We wanted to find out whether you might be open to working with us to do a media announcement in Prince George either prior to or right after the lunch.

UBC economists propose fund to combat housing unaffordability in B.C.

Economists at UBC's Sauder School of Business and Vancouver School of Economics, along with colleagues from Simon Fraser University, are calling on the provincial government to address housing affordability in the Lower Mainland with a tax targeting property owners without ties to the local economy.

The group, led by real estate economists Thomas Davidoff, Joshua Gottlieb and Tsur Somerville, is recommending that the provincial government create a B.C. Housing Affordability Fund (BCHAF). Local residents would receive money raised through an annual surcharge on owners of vacant properties and owners who are not Canadian taxpayers.

"The goal is to support those living in parts of the province that have seen skyrocketing real estate prices, while also making our local markets less attractive to investors who wish to avoid taxation or park cash," said Davidoff.

The economists propose funding the BCHAF with an annual 1.5-per-cent surcharge targeting owners of vacant properties or those with limited participation in the Canadian economy. For example, the owner of a vacant \$10-million home would face a \$150,000 BCHAF contribution each year.

Most homeowners and landlords would be exempt from the surcharge. As an incentive to move unoccupied suites into the rental market, the policy also allows for owners to receive exemptions for rental income they receive from non-family members reported to the Canada Revenue Agency.

The economists suggest a localized approach that allows each municipality within the province to choose whether to implement the BCHAF. Funds raised from absentee owners within a particular jurisdiction would go directly to all taxpayers who declare residency within the same locale – including property owners and renters – in the form of equal lump sum payments.

Based solely on the current vacancy data, the researchers estimate the BCHAF would raise a minimum \$90 million per year in Vancouver alone.

"We are certain the sum would actually be much higher as current systems for data collection don't provide a full picture of vacancy rates," said Davidoff. "An added bonus of the BCHAF reporting process is that it will help us gain a much more accurate picture of the problems of homes left vacant and property owners who do not or have not paid their share of Canadian taxes."
