Dear Mr. Fischer:

I hope that you will have your staff review the joint plans of Translink and the City of Vancouver for the construction of the Broadway Subway, especially given the new CAMF that was agreed upon by yourself and the Auditor General of BC. I am certain that Translink will claim that there are no other options when in fact the City of Vancouver has its Downtown Streetcar Project. The October 5, 2006 Report to the Planning and Environment Committee estimated that a double track line from Main and Terminal to Fir and 3rd to be \$100million (in 2006). I estimate that in today's dollars and with the extra track put on the Arbutus Corridor to Broadway and Arbutus the costs will be \$200 million. The Broadway Subway is estimated at over \$2 billion. Translink calls their technology 'rail rapid transit' which is a heavy rail transit vehicle not a light rail transit vehicle. The heavy rail vehicle is a wider body and hence carries a heavier load on the same tracks as LRT. Why the doublespeak with the use of RRT is beyond me but the right away from Main and Terminal is already in place and can handle the wide body cars. This review will be a good chance to test implementation of the new CAMF.
