Dear Minister James,

Re: Supplementary Funding Request – Elections BC

The Select Standing Committee on Finance and Government Services has recommended that access to supplementary funding for the 2017/18 fiscal year be provided to Elections BC.

On December 21, 2017, the Committee considered the Chief Electoral Officer's supplementary funding proposal of \$2,405,331 for additional operating expenses for the 2017/18 fiscal year to the first instalment of the annual allowance to registered political parties pursuant to the Legislative Assembly's adoption on November 30, 2017 of the *Election Amendment Act, 2017* (Bill 3). The Chief Electoral Officer explained that the first instalment of the annual allowance, payable on January 1, 2018 (and deferred to January 2, 2018 due to the statutory holiday) would be as follows: New Democratic Party of BC – \$993,882.50; BC Green Party – \$415,483.75; and BC Liberal Party – \$995,965.00.

The Committee carefully considered this request, and has recommended that Elections BC be granted access to supplementary funding up to **\$2,405,331 for operating expenditures** in 2017/18.
