#### GCPE ENV - CONFIDENTIAL ISSUES NOTE

#### Background:

- The carbon tax was implemented on July 1, 2008 and applies to the purchase and use of fuels in B.C., covering about 70% of provincial emissions.
- The tax was introduced at \$10/tonne in 2008, and increased \$5 each year until it reached the final scheduled increase at \$30/tonne in 2012.
- In 2013, Government committed to freezing the carbon tax at \$30 per tonne for five years.
   The carbon tax puts a price on carbon emissions to:
  - Encourage individuals and businesses to use less fuel and reduce their greenhouse gas emissions;
  - o Send a consistent price signal;
  - o Ensure those who produce emissions pay for them; and
  - o Make clean energy alternatives economically attractive.
- Analysis indicates the economic impact of British Columbia's carbon tax varies by industry, and some industries are more impacted than others.
- As part of the Pan-Canadian Framework on Clean Growth and Climate Change, Canada announced a federal carbon price beginning in 2018:
  - o For jurisdictions with an explicit price-based system, the carbon price should start at a minimum of \$10 per tonne in 2018 and rise by \$10 per year to \$50 per tonne in 2022.
  - o Provinces with cap-and-trade need (i) a 2030 emissions-reduction target equal to or greater than Canada's 30 percent reduction target and (ii) declining (more stringent) annual caps to at least 2022 that correspond, at a minimum, to the projected emissions reductions resulting from the carbon price that year in price-based systems.
  - The overall Federal approach will be reviewed by early 2022 to ensure that it is effective
    and to confirm future price increases. An interim report will be completed in 2020 which
    will be reviewed and assessed by First Ministers.
