Once in Penny, they can be accessed as follows:

- Go to Reports → Employee T4.
- This will display the most recent T4 (2017).
- Click 'Printable Version' at the bottom right hand corner of the T4.
- After selecting Printable version, press the Print icon to print (top left corner of screen).
- Other T4 years can be viewed by clicking the buttons to scroll forward or backward. Please note that not all previous T4s have been loaded into the system.
