The previous and current MO prefers that MLA queries filter in through the MO whenever possible. This ensures consistent messaging, that MO is aware of the issues, and that MO can vet whatever response is sent out.

- Directly by Phone: For MSP issues however, there are additional options: MLAs can use a 1-800 number that was setup strictly for MLA MSP queries.
- Request to handle sent to Finance MO: Most will filter in their request that FIN resolve on behalf of the MLA (Reply Direct) or for MLA Bullets. It would require a Consent Form.
- 3. MLA Office handles directly: If the MLA's office would like to handle directly, they can, but again, a Consent Form would be required. The MLA's assistant can't call Ministry staff to discuss a constituent's personal financial information. We aren't allowed releasing that

information without consent forms as it is confidential and private information.

Also, it is possible the MLA would be redirected to submit their request for information through the MO to ensure the MO is aware of the request. Branch staff have been instructed to redirect MLA requests for information through the MO as this is previous and current MO's preferred way to receive the requests from MLAs.

If it's a simple request, and the MLA's office provides a consent form, the program area may provide them with information or direction. So up to you if you'd like them to forward through us or handle directly.

Also – just an FYI – HIBC falls under Health.

HIBC manages the database and applications for premium assistance, etc. They handle changes to information, which will impact billing.

It seems that a foreign person (ie. a parent, other relative or unrelated person) can purchase a BC home together with a BC-resident person and register title, say 1% as to the non-resident and 99% as to the BC resident. This places the foreign buyer on title and control of the property may be exerted through a secondary agreement (whether declared or not). They might also be the source of funds for the entire purchase.

However, the 15% extra property transfer tax only applies to the 1% interest of the foreign buyer.

So foreigners can effectively use a Canadian-resident "agent" to purchase the property and there is effectively no additional cost.

Perhaps this is a loop hole that is now being exploited.

Many communities have different ways of doing business or interacting. s.22

I believe it is abusive.

The solution might be to charge the 15% tax on the full property price where a foreign buyer holds any interest on title or otherwise.

Alternatively, it may be time to ban foreign buyers from acquiring BC property entirely - including residential, commercial, farm land or otherwise - at least until we can re-balance our communities and ensure that there is affordable rental or other housing for the thousands of Canadians living in BC.

Good luck with your new responsibilities and challenges! I hope the BC NDP can find new innovative ways to raise funds sufficient to maintain the prosperity of BC without continuing to sell our province and its assets - land, businesses or otherwise - to foreign interests.

Thank you for taking my call this morning. As I mentioned, I took a screen shot of the language in the budget update and will copy that in below.

The Budget 2017 Update announced that the PST rate on electricity will be reduced to 3.5 per cent from the current 7 per cent at a date to be specified by regulation, and then eliminated completely on April 1, 2019. I understand that Government intends to provide at least one month of notice before the 3.5 per cent rate takes effect.

Provincial sales tax revenue growth is expected to average 4.3 per cent annually over the three year fiscal plan, in line with expected increases in nominal GDP and consumer expenditures on taxable goods and services. The forecast incorporates a two-year phase out of tax applied to electricity purchases to help businesses become more competitive and support increased investment, growth and job creation. The forecast assumes that the tax rate on electricity purchases is reduced to 3.5 per cent from 7.0 per cent during 2017/18 and effective April 1, 2019, electricity purchases are fully exempt from provincial sales tax.
