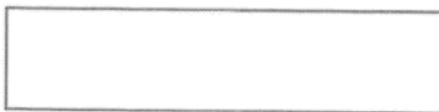

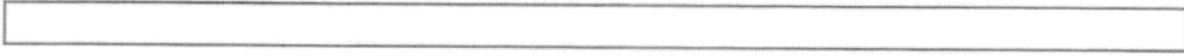

The ABLE Financial Empowerment Network is a national coalition of over 4,600 members from community organizations, financial institutions, academe, foundations, and governments engaged in reducing poverty through financial empowerment initiatives that improve the financial wellbeing of low-income and vulnerable community members.

We currently chair the national ABLE Steering Committee and are the organizers for this year's ABLE Financial Empowerment conference, in partnership with Family Services of Greater Vancouver. The conference will be May 8-9, 2018 in Richmond at the Radisson Vancouver Airport. We would like to invite Minister Shane Simpson to be a keynote speaker and to share your government's vision and plans for poverty reduction in British Columbia. If you could kindly connect me to the appropriate person in his office, that would be a great help.

We would also welcome a chance to connect with your office to discuss how our work can potentially help to advance some of the government's key priorities – particularly with respect to poverty reduction and building household financial security, but also potentially in other areas. The programs and interventions we are developing and piloting have been integrated into many complementary public services in the United States —e.g. employment, settlement, welfare, housing and health care – where there is strong evidence that they measurably improve outcomes. We are currently planning a trip to BC and Alberta in late January/early February, so could meet then if you like.

Finally, with IIROC's support, we are mounting a research symposium March 9, 2018 on growing income volatility and household financial vulnerability in Canada. This will feature leading edge research on the problem, as well as emerging solutions, from the United States (Federal Reserve, JPMorgan Chase Institute, Aspen Institute, Center for Financial Services Innovation) and Canada (Statscan, TD, Capital One, Mowat Centre, Carleton University, Common Wealth). This will be an invitational event targeted to 50-60 senior decision-makers from the federal and provincial governments, financial institutions and regulators, Statscan and relevant think tanks and academic centres concerned with household financial health and economic growth. We would be pleased to extend an official invitation to someone in your office and to a senior official from your department if you would like to suggest some names.

Thanks very much for your help and I look forward to connecting in person in the new year, your schedules permitting.

In the meantime, I wanted to take the liberty of introducing you by email to Liz Mulholland, CEO of Prosper Canada, a national charity dedicated to expanding economic opportunity for Canadians living in poverty through program and

policy innovation. As a leading champion of financial empowerment, Prosper Canada works with government, business and community partners to develop and promote financial policies, programs and resources that transform lives and foster the prosperity of all Canadians.

IIROC has partnered with Prosper Canada in the past on financial literacy initiatives. Earlier this year our Board approved funding of over \$240,000 from our Restricted Fund (monies collected through enforcement fines levied upon individuals and firms that have breached IIROC rules) for Prosper Canada to carry out three research initiatives to shed light on household financial vulnerability in Canada, and potential solutions. As part of this initiative, IIROC will co-host with Prosper a symposium in 2018 inviting a broad range of stakeholders (including government partners) to discuss key findings and a further examine how disruptive forces have impacted those working to build the financial resiliency of Canadian households. We believe that the final research report will help policy makers, educators, regulators and financial services providers better understand the programs in their communities, engage in broader community discussions and mobilize local solutions. We would be happy to have representatives from the BC Government participate in this symposium and will send you details once things are firmed up.

As well, I know Prosper Canada would like to involve the Minister in the May 8-9, 2018 ABLE Financial Empowerment Conference to be held in Vancouver with the support of Family Services of Greater Vancouver. That is why I offered to introduce Liz to both of you by way of this email. IIROC may also be participating in this conference in Vancouver and it would be great to continue to work together on financial empowerment and financial education.

Finally, Liz is also hoping to be in BC early in the new year, so we are hoping that there might be a good opportunity for all of us to connect on issues of mutual importance.
