Mr. Tuck,

I know that, as a lawyer, you must sometimes do anything to justify your high salary. Certainly, some of the time you must do good work. I grant you that. But on this file, you are proposing further frustration for an applicant. I propose the path of common sense. You must have more important files. So do I. But I am not letting this go, on principle. The new government must not act like the old government. It promised not to. But is it fulfilling those promises?

You see, Mr. Tuck, this file would not be where it is today had I been treated reasonably and respectfully, as any government should treat any citizen, regardless of whether he or she is in the media. I simply wanted to know whether the government had a solid business case to spend more than \$700 million on a project announced just months before the provincial election. What were the costs? What were the benefits? What did the business case say? I had a right to see them.

Instead, I was met with resistance right off the bat. I was sent a bogus claim that it would take 41 hours to find and retrieve the records.

Forty-one hours.

There was no way that it would take 41 hours to find a couple of reports that resided on the hard drive or network of someone in the office of the minister or deputy minister. The records would have been easily located, but someone in the government decided to frustrate the public's right to know. Because they did not want scrutiny before the election. Someone in government decided to trample on democracy and transparency. For what benefit? I can only speculate. Re-election is the most logical. Personal financial benefit? Potentially.

I was asking for records that were created electronically and, reasonably, within the fall of 2016. I was not asking for every single draft of the cost-benefit analysis or business case. I was not asking for correspondence. I was simply asking for two reports that could have actually been in the form of one report. I have a little bit of experience making FOI requests, Mr. Tuck, and I can tell you that I had never been told it would take 41 hours to find contemporary reports of this nature.

Had the elected and appointed officials had the will to search, they could have found this report in much less than 41 minutes. This whole file could have and should have been started and completed within the three hours to which I am entitled.

I oppose everything you propose in your letter of today; I would be glad to introduce evidence that shows numerous times my well-presented fee waiver requests were rejected, and I can show proof that fee waiver requests are used as another tool of delay by public bodies that want to slow down the process to avoid timely disclosure.

Again, I suggest a common sense path of reconciliation. For the public body to admit that its behaviour on this file was wrong and that it will not engage in such egregious behaviour again.

I have copied the current Finance minister and Citizens Services minister (responsible for IAO) on this file, as it is important that they set and follow policy that adheres to both the letter and spirit of public disclosure laws.

In closing, I remind you of important words that should always guide you and every public body:

In Audit and Compliance Report F16-01, the Commissioner wrote: "The public body should not act as a gatekeeper of records but instead should be a conduit for providing an applicant with all of the information they are entitled to under FIPPA. Any practice that discourages applicants from making and pursuing access requests frustrates the purpose of the legislation."

In OIPC Order 04-19, the adjudicator wrote: "The duty to provide access to records under the Act is not defined by the willingness of the public body or its staff, contractors or agents."
