I asked the iCollaborate (eApprovals support) team about eApps not working on iPads, and this is what they said:

- Users must use the Chrome browser on iPads (not Safari).
- They must have the eApprovals home page marked as a Bookmark and then they navigate
 accordingly from within Chrome. If an item has been assigned to them, they go to the My
 Items tab.
- It is recommended that users only action (approve/not approve/send to) the eApprovals items on the iPad and not edit the attachments (they would need MS Word and/or Excel installed to edit attachments).

If they have tried using Chrome and it still doesn't work, please let me know.
