My name is Elaine Alec and I met you at the BC Cabinet and First Nations Leadership Gathering. I presented on the Community Healing, Safety and Well-Being panel with Tracy Porteous and Chastity Davis, 2 wonderful spirits that I have had to honouring working with and learning from over the past year in my role as UBCIC Women's Representative.

I also met with various ministers and Premier John Horgan at the one on one sessions to talk to them about the work that UBCIC is doing on "Pathways to Safe Places"

I am pleased to let you know that every single minister minus one, gave me the same messaging and mentioned your name and the great work you are doing.

The fact that they all had the same information and messaging gave me hope, as I've worked with many governments on various levels and know how hard it is to get all ministries on board and communicating.

They all mentioned the 16 days of action and your leadership. They also told me that the person I needed to connect with is Mitzi Dean.

One of my goals through this work is to request childminding rooms available at our political meetings to support women in leadership (as well as men, I have seen our men in leadership attend meetings with their children as well)

Thank you for the work you have done in advocating for Gender Equality. Your voice has made a difference, I felt it in my 15 minute sessions with Ministers from Health, Mental Health and Wellness, MCFD, Public Safety and the Premiers office.

I look forward to finding out more about the work you do and any opportunities that we may



have to partner and work together.

My background has been in planning, community engagement, facilitation and mediation with communities who are in third party management and conflict. I have also advised federal governments on cross-departmental planning and integration of services and know how difficult it can be to get everyone working together and I am so happy to see that on an important matter such as creating safe spaces for women, that so many are on board and understanding of the urgency and need.

I think I'll end here for now and look forward to further discussion.
