Following the recent media hype surrounding the ICBC deficit projected for the fiscal year ending in 2018 I looked at the financial statements available over the internet. My read was that there was an almost 1 billion dollar loss for the 15 month period ending in 2017 so why the sudden shock and hype. Further, while the notes to the financials show a consistent 4.5 to 5% return on the 14 billion dollars investment portfolio I don't see where this appears in the statement of P&L Is this an unrealized gain? The reports I have seen from actuaries assessing insurance companies have always contained opinions on solvency and recommendation for MCAP. The report attached to the statements does not. Where is the Superintendent of Finance (federal) in all this? Surely an insurance corporation showing this kind of financial distress would have garnered more than a little attention from his department. I am concerned that the media swallows the surface story without doing any real investigation and I know that it has caused more than a little angst from the people I have spoken with since the story broke. Any answers that you can provide would be appreciated. You have my permission to share this email with anyone you feel could provide insight.

Dear Mr Horgan

To day I completed my draft Income Tax returns for the 2017 tax year. This past year has proven to be rewarding in many ways. There exists, however, one section in the BC Tax Credit form that has not changed for over a decade. This deals with the base income a single person has when they apply for The Provincial Sales Tax rebate.

I am thankful that the federal and provincial governments believe that seniors should receive a moderate pension income. Consequently, through the OAS and GIS programs we often see increases throughout the year to reflect standard of living costs. Furthermore, in January the people who deal with CPP increase pension allowances to reflect the yearly standard of living costs.

A problem arises when one calculates his or her total income and then compares what BC believes is the recommended base rate for the Provincial Sales Tax Rebate. \$15,000 may seem like a great deal when calculating a rebate, however this past year my total income was just over \$17,900. Nevertheless, my rebate will be around \$16.00 and that barely reflects a tiny portion of the amount I pay in annual PST amounts.

In 2006 \$15,000 was a low-moderate amount for a yearly income. In 2017, one could argue that \$15,000 is extremely low.

I would appreciate the province reviewing the base rate for yearly income as it relates to the PST rebate policy. I would also appreciate a revision of the senior supplement program. I wonder if the cost of doing banking, for less than \$6.00 a month is worth the expense. Could that amount be tied to the annual cost of living index for energy and food. It certainly would make more sense.

Thank you for considering these matters. I have completed questions on poverty reduction as well as on the voting changes. Keep up the great work you are doing for this province. It really is wonderful to have you in government.

It is our constituent's understanding that these logs disclose information about the types of health services that individuals are accessing, including how much the government has spent on them. He is worried and concerned that if this is the case, it means that the public can have access to the types of healthcare services that he and his family are receiving, if the public searched for it. From my knowledge, and I shared this with the constituent, these logs are disclosing the salary of employees who have worked in the ministry, and it is unlikely that these records are disclosing information about the types of services individuals are receiving.

Any type of information you have on the Public Accounts and the attached records would be appreciated.

One of my business partners weighed in on this topic today and had this to add. So, I'm passing it along:

This level of incremental taxation is a cost that a company like ours cannot simply 'absorb'. The food industry is brutally competitive. Costs cannot simply be passed on to our customers, particularly when we export much of our product outside of BC. Our customers will simply choose to do business with someone else. Our customers outside of BC will have little regard for our 'BC issues'. If another supplier in Alberta or Ontario or Quebec is more competitive, that is who they will choose.

The logical outcome for us, given the cost of this tax, is to eliminate \$40,000 from our payroll. This means at least 1 FTE will have been vaporized by your new policy.

I'd be interested in what your reply would be to the individuals who find themselves unemployed because of this.

I wanted to provide some feedback on the speculation tax. First item, I am a US Citizen and Canadian Permanent Resident living in s.22

From the press accounts of the speculation tax, sounds like it will cause problems for US Citizen's like me living in s.22 In particular, the US taxes its citizens on worldwide income regardless of their residency. The US / Canada tax treaty pretty much allows for income taxes paid to Canada (and BC) to count against US taxes due, so net net I end up with little or no tax due in the US.

The speculation tax, as described in the press, will upend that. In particular, it sounds like all homeowners will be charged a tax of 2% of the assessed value of their property and will receive a credit against their income taxes for the amount of property tax paid. So, in theory, someone paying BC taxes will end up not paying an extra tax (assuming their BC income tax was higher than the speculation tax). However, this approach share shifts the tax from an income tax, which counts against US tax liability, to a property tax, which doesn't. Furthermore, under the new tax law in the US, property taxes are no longer deductible. The net result is that I will likely end up owing substantial US Taxes because my BC income tax liability went down and I will see no relief on the US taxes for the increased property taxes.

I will be honest, I will not be able to afford to stay in s.22 if this plays out the way I fear.

I respectfully request that the government reconsider the approach so that it is more 'friendly' under the various tax treaties. One option, for example, would be for the income tax paid to be a credit against the property tax due rather than the other way round.

Hi Solenn,

I am writing on behalf of Chastity Davis, Chair of the Minister's Advisory Council on Indigenous Women (MACIW). MACIW was formed in 2011 and their focus has been on stopping violence against Indigenous women. MACIW meets quarterly for 2 days and advises government on how to improve the lives of Indigenous women. With the new mandate letters and the focus on implementing UNDRIP, TRC, and the Tsilhqot'in decision, MACIW has received many requests for guidance concerning engaging Indigenous people, as well as their feedback on government initiatives.

For about the last year or so, MACIW has been looking at the negative impacts of natural resource development on Indigenous women and ways to mitigate these impacts. One method is through incorporating Indigenous Gender-Based Analysis (IGBA, or GBA+) into environmental (impact) assessment practices. Chastity, Chair of MACIW, has been working with a cross-ministry working group on industrial work camps as well as the Environmental Assessment Office to explore how IGBA could be incorporated into environmental assessments. This approach still leaves gaps and does not capture all the development projects that have negative impacts. It is important to note that there are positive impacts for women, if there are sufficient wrap around supports. IGBA, if it is done in a fulsome manner – meaning quantitative and qualitative research, following participatory community research principles, occurring early on and on-going throughout the project - has potential to

mitigate some of the negative impacts ahead of time.

MACIW has also advised the BC Family Information Liaison Unit several times this past year as they developed their services to support families of missing and murdered Indigenous women and girls.

I have attached three primary documents related to IGBA, just in case you haven't come across them.
