Dear Mr. Norm Letnick, M.L.A.,

Good morning. First off, I wish to thank you in advance for any assistance you can offer, with our trying to obtain a collector number through the Motor Fuel and Carbon Tax Consumer Taxation Programs Branch, BC Ministry of Finance.

This process has definitely been an eye opening experience of dealing with our provincial government vs the Alberta provincial government as well as a struggle with ours. The process has been off and on going since July 21<sup>st</sup> of 2017.

To begin with, I applied for the collector number from the BC Ministry of Finance using form FIN142 (Application for Appointment as a Collector), July 21<sup>st</sup>, 2017. Accompanying this form was FIN151 (Authorization or Cancellation of a Representative), which granted me authorization to be the representative for s.21 in the application process and any future correspondence or communication.

We heard nothing back until I inquired into the status of our application August 31<sup>st</sup>, 2017. Then, David Lin, IFTA/ Motor Fuel/ Carbon Tax Section, requested information as to which company the application was made under as we were linked with several numbered companies. I provided the information within a few minutes. Sept 6<sup>th</sup>, we provided the original forms again with an explanation as to why we had not put volumes on the form. (We were unsure as to what the volumes would be and did not want to incorrectly report volume amounts). David asked Ryan to look into it.

September 11<sup>th</sup> I finally heard from Ryan Reynolds saying he had asked someone to call us as the form was filled in for BC only not Alberta, I had not received a call from anyone but told Ryan that our intent was to import from Alberta.

I should say that by this time we had everything that was required for the Alberta government side, filled in, filed, set up and returned to us as well as had several calls and emails from them checking on whether we were starting yet as there had been no action on the file.

I contacted Ryan, apologizing for the confusion on the BC only and importing from Alberta mistake and asked for assistance on filling in the form when I didn't know the volumes we would be doing and did not want to report drastically inaccurate information.

What I got in return, was basically a long winded request for a letter of intent to be provided on behalf of s.21 and a link to a guide that did not work (this is not an uncommon occurrence. I often receive emails from the Ministry with links that do not work or search online and try links there that are not working properly).

After several emails back and forth that were quite long winded with questions and not very informative answers, I received an email on the 28<sup>th</sup> from Ryan checking on the status of the letter. I then sent the letter of intent out on September 29<sup>th</sup>. I was not sure at this point if we were actually applying for the right thing as the clarification between deputy collector and collector was really not being explained very clearly to me. (I have since found out from an independent source, what the difference actually is and that we really need to be applying for both. Deputy collector to cover current dealings and collector to cover what our intentions are in the future with out growth).

October 11<sup>th</sup>, I received an email from Ryan that the application had been made inactive and would remain on file should we wish to reapply at a later date.

As we were doing a lot of building on the new brand of s.21, and the plan was to have the application moved to this company, not much was done with it until April of this year at which point I emailed Ryan with a request to "resurrect" the application. At the same time I asked for information on what to do about getting a South Coast Transit Tax Number, as we had started to deliver to a location in the Lower Mainland, but we had to pick up at locations outside of that zone. In doing this we needed to make sure that the SCTT was submitted properly to the

Ministry. Only part of the information was given and we ended up with issues that have since been resolved but took almost 2 months. But we still have not gotten any closer to getting the application for either deputy collector or collector completed.

Now we wish to set this up for s.21 which will actually be the company that will be operating the fuel division but as we haven't been able to get anywhere with s.21 what will happen with s.21


