Dear Ms. Dean -

Approximately two years ago, myself and others formed a non-profit society to attempt to improve the infrastructure, delivery, sustainability and growth of minor hockey for girls aged 5 - 20 in the greater Victoria region. This is the Capital Region Female Minor Hockey Association (CRFMHA). Full details on the background and rationale are documented in the proposal on our website.

Our initial attempt to establish the program in 2017 was rejected by Vancouver Island Minor Amateur Hockey Association (VIAHA).

We have subsequently applied to BC Hockey for membership in November 2018. Earlier this month, they published their Female Hockey Report, which reflects many similar approaches to what we originally proposed. It is available on our website (or theirs). Note - it is dated Dec 24, 2018 but it was not published until Feb 1, 2019.

We've been advised that BC Hockey Board will be making a decision about the CRFMHA proposal on Tuesday. We are prepared for various outcomes, but in the event of a favourable outcome, we will be considering a media release and wonder if you would consider issuing a

supportive statement we could include in the release, given your position as the Parliamentary Secretary for Gender Equity.

I'd be happy to discuss the proposal in more detail if you wish.
