Hi Alyssa – Great questions:

1. **Primary author** is the person who is requesting the meeting (so not Admin Person from Ministry ABC but Private Citizen from XYZ Group would be the Primary Author).

If you'd like to also have an additional author for the person who sends the request, you can add them as an **additional author** by clicking the Green Plus icon.



2. More than 1 incoming on the same meeting request?

Ultimately, the decision is yours! don't set process for MO Meeting Request logs, so it is up to the MO. However, at the Ministry, CLIFF logging process is: **1 incoming = 1 CLIFF log**.

Reason for this is:

- Accurate Reporting for statistics on number of incoming requests
- To reflect the work that you do accurately (volume of incoming meeting requests you process)
- Accurate Searching for the correct piece of incoming (staff often look by Date Written and may not find it if an initial request was in April and the followup was in June...other staff may not search within the April log for the June incoming if it's merely attached as an additional attachment).
- **FOI Searches** – FOI searches request all incoming on xyz issue within October-December 2018. If an incoming received in October but is 'added' to a September log, it will not be captured in a CLIFF search for a Freedom of Information request by the media, political parties or the general public.

Exceptions:

- Incoming email with PDF attachment where a hard copy letter of the PDF is also mailed. Log as 1 CLIFF log – exact same incoming.
- Forward from MLA James of email also sent to FIN MINISTER? Log as 1 CLIFF log

In your case...this may be a consideration:

There may be times where you need the followup email in the original email (clarification, etc.). I'm not sure of process for handling meeting requests...are they printed? Is CLIFF updated, etc. Assessment may be required to determine best course of action for your work, which I'm happy to discuss options with you for...just let me know when you're free and we can chat about process, I can help create templates for your logging if you want different ones, etc. For example, could you simply add Log Notes indicating that there's an additional incoming under CLIFF 123456 and that the person requested a new meeting date. The additional Meeting logs could be logged as FYI only. If so, I could create a template for you called **Meeting Followups** that are FYIs and that you close right away, or whatever your process requires. Or....you can just add them to the original CLIFF Log. 😊 Up to you. The only real issue is if ever anyone is looking for a Specific email in CLIFF by last name AND date. "The January 9th email from John Doe" or if you use CLIFF to search for FOI Searches by date range.

1. Implement a minimum dollar-per-day, \$365 annual fee for Tobacco Retail Authorization permits.
2. Increase tobacco taxes by \$13 per carton of 200 cigarettes to match the leading rate in Manitoba (\$68.19) and curb tobacco use. Tax rates on other tobacco products should be increased proportionately.

Their lead (Jenny Byford) is also in Victoria and able to review the benefits at any time, as well as participate in related budget announcements or discussions.
