The first tentative agreement amongst the research universities was reached last night – UVic has signed an agreement with their Professional Employees Association (PEA) bargaining unit, covering approximately 900 employees.

The agreement is consistent with the 2019 mandate, and includes some modest employer priorities around exclusion of supervisory and confidential roles from the bargaining unit, "critical skills" adjustments to assist with the recruitment and retention of key staff in IT and project management, and improved scheduling and leave flexibility.

This agreement is also notable as it is our first with the PEA under this mandate.
