Olav/Louise

Both the DM and Tax Policy have requested that where possible the final screen of spec tax declarations for which no exemptions are identified, provide an estimate of the tax amount for which the person will be billed. For example – something along the lines of... “Based on the information provided, it is estimated that you owe [tax amount]. The due date for the payment of tax is July 2, 2018. A notice of assessment for the tax owing will be mailed to you and will include instructions on payment options”.

Ideally this would be doable for all taxpayers. However, the DM said, if it could at least be done for individuals that are BC residents that would be sufficient.

Steven and I chatted briefly about this and I understand that in order to do this, we may need to add a couple additional questions to the declaration.

I committed to checking on the feasibility of this in terms of timing and cost. Can you please advise early next week the impact of this request.
