MCFD 2018/19 Year-end Status

All MCFD

- FY18/19 Budget: **\$1.793 billion**
- Adjusted Budget: **\$1.847 billion**
- FY18/19 YE Spend Total: **\$1.828 billion**

Total Variance:
\$19.091 million under target
(1.0% of MCFD budget)

Child Care Only

- FY18/19 Budget: **\$400.634 million**
- Adjusted Budget: **\$432.968 million**
- FY18/19 YE Spend Total: **\$426.490 million**

Total Variance:
\$6.748 million under target
(1.6% of Child Care budget)

"Under target" refers to Adjusted Budget amount.

All MCFD:

- Includes CRT contingencies of \$2.5 million.
- "Adjusted budget" includes contingencies access and Supplementary Estimates.

Child Care Only:

- "Adjusted budget" includes contingencies access and Supplementary Estimates.

• CCOF/CCFRI:	\$3.569 million
• ACCB:	\$2.918 million
• Other Programs:	<u>\$0.261 million</u>
Total:	\$6.748 million under target

Budget 2019 Pressures and Options

- FY19/20 Budget: **\$2.065 billion** (up 15.2% over FY18/19), with a further \$69.200 million allocated through notional contingencies.
- Caseload, Child Care Implementation, and Indigenous Child Welfare are all areas of financial pressure for FY19/20.

Budget 2019 Pressures and Options
