More than 280,000 B.C. children are eligible to receive the grant. To date, about 60 per cent of eligible parents have not signed up for the \$1,200 grant.

#### Quick facts

- The BCTESG is available through 56 financial institutions, including credit unions. - RESPs can be left open for up to 36 years and can be used by beneficiaries to pay for full-time or part-time studies in a qualifying college, university, trade school, or apprenticeship programs.
- In the event that the RESP is closed or the beneficiary chooses not to pursue a post-secondary education or training program, the BCTESG will be returned to the Province of British Columbia.
- All RESPs grow tax free, and money paid out of an RESP is taxed based on the income of the student. Since many students have little or no income when they attend post-secondary education, they can usually withdraw the money without paying tax.
- The BCTESG has been offered since August 2015.
