	Each board is mandated to establish and operate a police force within its municipality. The board submits to the municipality's council for approval an annual detailed estimate of money required to provide policing in the municipality for the next year.

Composition of Board:	Composition:  Each board consists of the Mayor of the municipality concerned, one person appointed by the municipal council (CABRO sets term only), and up to seven members appointed by the Lieutenant Governor in Council.					
Compensation:	Police Board members are not remunerated, they serve as volunteers. Members are reimbursed for any reasonable travelling and other out-of-pocket expenses incurred in discharging duties as a Board member.					
Term Length:	Under subsection 24(2)(a) of the Police Act a person appointed to a municipal police board under section 23 holds office for a term, not longer than four years, that the Lieutenant Governor in Council determines. Under subsection 24(3) of the Act, members are limited to a term of six consecutive years.
