BC BUDGET 2022 LOCK-UP

On behalf of Minister of Finance Selina Robinson, you are invited to join the 2022 BC Provincial Budget Lock-Up on Tuesday, February 22nd at the Victoria Conference Centre.

This year, Budget Lock-up is in-person only with no remote participation option; however, it will be significantly different to previous years to ensure the safety of all participants. It is critical that you read all of the information below carefully.

To secure your place in the lock-up, you will need to RSVP no later than 5:00 p.m., Friday, February 4th using the [web registration form](#). This date is firm, and the invitation is void after the deadline.

We are closely monitoring the COVID-19 situation in B.C., and we are prepared to adjust the event as needed to ensure the health and safety of participants. More details on safety protocol are below, but please note that this protocol may change.

Due to COVID-19 restrictions, we are significantly reducing the number of invited guests from previous years and limiting capacity to approximately 160 guests and government officials. The convention centre has capacity to hold many times this number during non-pandemic times, which will ensure ample space for safe distancing. Large equipment such as printers, display items and signage will not be permitted.

Members of the media will be stationed in a separate building, the Crystal Gardens, located immediately across the street from the convention centre.

Lock-up day registration opens at approximately 8:00 a.m., and lock-up will end at approximately 2:00 p.m., at which time Minister Robinson will deliver the budget speech in the legislature. Staggered arrival and departure times will be scheduled to reduce lines and crowding and may require staying in the room for 30 to 60 minutes after the lockup ends. You will receive an email with specific times for arrival and departure closer to the day.

COVID-19 Safety Protocol

The safety of participants is our top priority.

Proof of double vaccination is required. You must provide your [BC Vaccine Card](#) and government-issued photo identification, such as your driver's licence or BC Services Card, to enter.

Additional health and safety protocol include:

- Attendees must wear masks at all times, except when eating and drinking.
- No mingling or leaving your assigned seat except to get food or use the washroom.

- Distribution of printed materials is not permitted. Please do not bring a printer or any materials to distribute to any other attendees.
- No large items such as displays or pop-up banners that may obstruct pathways are allowed.
- A mandatory COVID screening questionnaire will be sent to all participants 48 hours prior to lock-up.
- Physical distancing measures will be strictly enforced.
- Attending lock-up is not permitted for anyone who is ill or showing COVID symptoms.
- Refusal to abide by COVID-19 safety measures on site will result in your immediate removal from the event.

These protocols may be adjusted closer to the event date. All attendees will be updated with any changes. Please note that the above protocol list may change or grow, and all protocol is mandatory.

Security Protocol

Placeholder names will not be accepted and people who have not been confirmed to attend the lock-up will not be able to enter.

To ensure budget security, you will be asked to sign an electronic confidentiality waiver when you register, confirming you will not leave or communicate with persons outside the lock-up area through any means until the Minister of Finance has begun her speech in the Legislature.

Cell phones and all other electronic transmitting devices will not be permitted in the briefing area and must be checked in at the registration desk. Cell phones can be picked up once the embargo lifts.

Computers are permitted, but wireless transmitting functions must be turned off.

Do not bring printers or any printed materials to distribute.

Frequently Asked Questions

WHAT IS A BUDGET LOCK-UP?

Each year in February, B.C.'s government introduces the province's Budget and Fiscal Plan. One of the main components of the day is the budget lock-up.

Beginning in the morning of budget day, members of the media, stakeholders, and government officials gather at a designated venue known as the budget lock-up.

At the lock-up, media and stakeholders have the opportunity to review the budget, examine supporting documents, hear a presentation from the Minister of Finance, and pose questions of clarification to government officials prior to the public release of the budget.

Strict confidentiality rules are in effect during the lock-up, and the use of cell phones or other transmitting devices is prohibited.

Following the lock-up presentation, the Minister of Finance delivers the budget speech in the Legislature. The lock-up ends after the Minister has begun the budget speech in the Legislature. Due to this timing, those present for the budget lock-up are not able to attend the budget speech.

WHAT WILL I RECEIVE AT THE LOCK-UP?

You will be given paper copies of budget materials, and a USB with a digital copy of the documents.

HOW CAN I ASK QUESTIONS OF GOVERNMENT OFFICIALS DURING THE LOCK-UP?

Senior government officials will be on hand to answer your questions after the Minister's budget presentation. Officials will be stationed around the room and organized by subject area. Attendees can line up in a physically-distanced manner to ask questions. Responses from ministry officials are for background information only and are not for attribution.

WHAT CAN I EXPECT IN TERMS OF STAKEHOLDER AND MEDIA INTERACTIONS?

Stakeholders and members of the media will be located in separate buildings to reduce crowding and allow for physical distancing.

When you register, you will have the option to consent to be available to be interviewed by media at the lock-up. A list of consenting organizations will be provided to media, and media may request to interview you in a scrum in the afternoon. You will be contacted in advance if you have been requested. **Please note:** your consent does not guarantee media will request you for an interview.

Interviews will be by video link between the two buildings through broadcast stations set up to accommodate stakeholders speaking to and being recorded by media. It is not possible to customize these broadcast stations and display signs and props of any kind are not permitted.
