- On Monday, February 27, the Canadian federal government issued a ban on TikTok from government phones having identified concerns with the application and have recommended that other governments examine it closely.
- We recommend that all organizations, public bodies and Crowns review the app for privacy and security risks to determine the best course of action to protect their networks, systems, and data.

For what it is worth... according to CPPM chapter 1:

Crown corporations, public bodies and funded agencies are expected to follow the spirit and intent of policy requirements.

So technically they should follow suit.

Not sure if BCPavC has access to Compass but this is the article they published when the ban was announced (below).

Ultimately, they will have to do the risk analysis of having their data potentially exposed to a foreign nation. I have also provided links to the National Post article about the Federal Govt ban.

TikTok temporarily banned on government devices

Due to the growing number of national and international concerns regarding its elevated privacy and security risks, the social media application TikTok is temporarily banned on provincial government-issued mobile devices.

This application is not used in the day-to-day work of government employees and there is no expected impact to services. There is no knowledge of imminent threat to government devices or information at this time.

Why now?

The federal government has identified concerns with the application and recommended that other governments examine it closely. Since this time, the Office of the Chief Information Officer (OCIO) has collaborated with other provinces and territories to share information and examine the risks to determine if implementing a ban is the right decision for British Columbia.

Why not other apps like Twitter and Instagram?

TikTok has been identified by the U.S., Canadian and European governments as an application with elevated privacy and security risks. These other applications have not been identified as having unreasonable risks to government networks, systems and data.

What happens next?

The OCIO is contacting employees with the app installed on their government-issued

devices. Employees will be directed to remove the app as soon as possible and government devices will be monitored for further installations of the app. The Information and Privacy Commissioners of B.C., Alberta, Quebec and Canada have launched an investigation into the privacy policies and practices of the social media platform, with a particular focus on how TikTok obtains valid and meaningful consent from its younger users.
