ISSUE: The Minister of Finance has approved the expansion of the SVT to 13 new

municipalities for the 2024 tax year.

BACKGROUND:

The SVT originally applied in core urban municipalities in the regional districts of Capital, Metro Vancouver, Fraser Valley, Central Okanagan, and Nanaimo. Those communities experienced near-zero vacancy rates and disproportionately high housing prices.

In July 2022, the Province announced the SVT expansion (effective January 1, 2023) to include six additional municipalities: District of Squamish, District of North Cowichan, Town of Ladysmith, City of Duncan, Town of Lake Cowichan, and Village of Lions Bay.
