Resource Management objectives

Resource stewardship is responsible for natural resource management objectives.

We provide interdivisional coordination in the implementation of practical and innovative approaches to addressing resource stewardship challenges and opportunities.

We work to achieve the integration of stewardship principles and elements that enables the Ministry to realize the Ministry's Vision.

We are responsible for:

- Legal designations for habitat values; e.g., Wildlife Habitat
 Areas, Ungulate Winter Range, Fisheries Sensitive Watersheds,

Wildlife and Fisheries Management

The Resource Stewardship Division is responsible for managing wildlife and fish. This responsibility includes managing for conservation and stable population of wildlife and the use wildlife.

We manage through:

- 1. Legislation and Regulation requirements Policy & procedures (use and allocation),
- 2. Species management plans,
 - Wolf management plan should be finalized soon
 - Kootenay-Boundary Mule Deer Management Plan just completed
- 3. Inventory and population/stock assessments,

Significant funding to support big game inventory since 2011

- 2011: \$865K to help remove barriers to development
- 2012: \$895K with \$500K from LBIS
- 2013: \$400K plus \$250K for fish stock assessment
- 2014: \$1M to be allocated to big game (\$750K) and fish (\$250K)
- 4. Technical and scientific support on allocation of wildlife including hunting, trapping, falconry, captive wildlife, wildlife viewing and support on recreational opportunities for angling,
- 5. Research fish & wildlife populations, and
 - \$430K this year for moose with MFLNRO contributing \$350K
- 6. Wildlife Health Program



BC manages wildlife for conservation, and Aboriginal, resident and commercial harvest

We manage the guiding industry by:

- 1. Requiring non-residents to use a licenced guide;
- 2. Issuing authorization for exclusive commercial use areas (territories) for up to 25 years;
- 3. Allocation and quotas for wildlife harvests, which is sometimes seen as a limitation and others time viewed as an advantage;
- 4. Licencing Guides to ensure quality guiding;
- Requirements and condition on guiding activities, for the protection of BC's wildlife; and
- 6. Requirements for reporting to manage the harvests and help with population estimates.

Many changes have occurred in the last few years. We are looking forward to some changes currently in the legislature now; such as, Corporations being able to hold certificates

Can there be improvements? We are working on it.

The Economy

The Guiding Sector contributes to tourism in BC.

4,000-5,000 hunters from outside BC each year.

Tourism is the fastest growing industry – estimates for 2012 is \$13.5 billion.

And, though your sector is relatively small it:

- 1. Contributes \$116 million to the economy, yearly
- Provides jobs in the smaller communities there are 240 guides, approximately 1000 assistant guides, wranglers, cooks, etc.
