Good Morning David.

I was talking this morning to Heather MacKnight and to MOTI regarding the PMV T2 Terminal expansion proposal.

FLNR wants to make sure that we are, from the beginning, part of both the EAO and CEAA processes. We would also like to make sure that the FLRN application process and the EAO are concurrent permitting. To that end we need to know when is the best time to have PMV submit an application for a Land Act tenure for the T2 terminal site, and also for other sites that will be used for habitat mitigation for T2. We especially want to determine who is going to take the lead on First Nations Consultation for the EAO Certificate, the CEAA authorization and how that will relate to the FN Consultation that FLNR must undertake as part of the Land Act review process. Again this is something that we would like to see run as part of the concurrent permitting process.

We understand that one of PMV's proposed mitigation site is in the nearby Wildlife Management Area. Use of this area would require two Statutory Decisions, the first from the Regional Manager (Director) of Resource Management) who must approve any use within the boundaries of the WMA and then from the Manager of Authorizations for the Land Act tenure and authorization to use the Crown land. However in light of your earlier note to Heather MacKnight on your use of either a "class assessment" or "class waive-out" it appears that the mitigation areas might not come under the original EAO Certificate process. Would that also include the proposed mitigation within the WMA,

I would like to discuss this with you further. Please let me know when would be a good time for us to talk, thanks

Dear Chief Williams and Councillors:

I am writing Chief and Council regarding the proposed Roberts Bank Terminal 2 Project (RBT2). Port Metro Vancouver (Proponent) proposes to build a new container terminal at Roberts Bank in Delta, British Columbia (BC). RBT2 will involve creating additional land area on the seaward end of the existing Roberts Bank causeway and widening that causeway.

The Honourable Leona Aglukkaq, Minister of Environment and Minister responsible for the Canadian Environmental Assessment Agency (CEAA), announced January 7, 2014, the referral of RBT2 for an environmental assessment (EA) by an independent review panel. Information on the federal EA can be found at the following link: <a href="http://www.ceaa-acee.gc.ca/050/details-eng.cfm?evaluation=80054">http://www.ceaa-acee.gc.ca/050/details-eng.cfm?evaluation=80054</a>.

RBT2 constitutes a reviewable project pursuant to Part 8 of the Reviewable Projects Regulation (BC Reg. 370/02), under the BC *Environmental Assessment Act* (Act) since it is a new marine port facility that involves dredging and filling more than two hectares of submerged land. As such, and pursuant to section 10(1)(a) of the Act, the Executive Director has ordered that RBT2 be referred to the Provincial Minister for a determination of the assessment's scope, procedures and methods under section 14 of the Act.

I have attached the signed section 10 Order for your information; in addition, the signed section 10 Order is now posted on the Environmental Assessment Office's (EAO) website and can be accessed at the following link http://www.eao.gov.bc.ca/.

The majority of anticipated effects and mitigation measures are within federal jurisdiction. It is anticipated that during the course of the federal review panel process, sufficient information for the provincial assessment may be produced through the Proponent's Environmental Impact Statement, panel public hearings and comments provided by government agencies, First Nations, interested parties and experts, the general public, the Panel Report and federal Ministerial decision.

As such, and in order to avoid duplication and to ensure an efficient and effective EA, the Province intends to rely principally on the federal EA by review panel for the information needed for assessment, including consultation conducted by CEAA with First Nations whose asserted or established Aboriginal rights or Treaty rights (Aboriginal Interests) are potentially affected.

Towards this end, I have attached a draft section 14 Order outlining the scope, procedures and methods for the EA for RBT2 that the Honourable Mary Polak, Minister of Environment, is considering.

As you will be already aware, the federal panel process includes: a five month pre-panel phase; 14 month panel phase; and a five month post-panel phase. The intention of the draft section 14 Order is to direct the Executive Director of EAO to consider the panel's EA report and other additional information that he determines to be required to complete his review during the five month post-panel phase and to inform his recommendation to the Provincial Ministers.

The Executive Director would coordinate consultation with CEAA, where possible, to summarize his understanding of the issues including how Aboriginal Interests may be impacted and how those impacts may be addressed, and would provide this information to First Nations for comment prior to making a recommendation to Ministers. The Executive Director would make a recommendation to provincial Ministers within 30 days of receiving notice of the decision of the federal Minister of Environment pursuant to section 52 of the Canadian Environmental Assessment Act, 2012, including any extension to the date under that Act.

I am writing seeking your comments and I ask that you please review the draft section 14 Order, in particular, section 4.1.3 which outlines the proposed Provincial approach to consultation with potentially affected First Nations. It is envisioned that the Province would attend federal consultation meetings with First Nations as appropriate.

Should Tsawwassen First Nation wish to provide comments on this approach, I would ask that you please provide correspondence to me by November 20, 2014.

Further, should the Proponent seek authorizations from other provincial agencies in relation to RBT2, EAO will endeavour to coordinate consultation activities with other provincial agencies.

The proposed Project would involve widening and creating additional land area at the seaward end of the existing causeway.
- B. The proposed Project constitutes a reviewable project pursuant to Part 8 of the Reviewable Projects Regulation (B.C. Reg. 370/02), since the proposed Project is a new marine port facility that involves dredging and filling more than two hectares of submerged land.
- C. Under section 10(1)(a) of the Act, the Executive Director is authorized to refer a proposed Project to the Minister for a determination of the assessment's scope, procedure and methods under section 14 of the Act.

### NOW THEREFORE:

Pursuant to section 10(1)(a) of the Act, the Executive Director orders that the proposed Project be referred to the Minister for a determination under section 14 of the Act.

### PART A - GENERAL PROVISIONS

### DEFINITIONS

- "Aboriginal Groups" means those First Nations who have Aboriginal Interests that may be affected by the Project and that are identified by the Agency in the Guidelines.
- "Aboriginal Interests" means the Firsts Nations' asserted or determined Aboriginal rights, including title, and treaty rights.
- "Agency" means the Canadian Environmental Assessment Agency.
- "Guidelines" refers to the Agency-approved "Guidelines for the Preparation of an Environmental Impact Statement for the Roberts Bank Terminal 2 Project, January 7, 2014 identifying the information that must be included in the Proponent's Environmental Impact Statement made to the panel.
- "Ministers" means the Minister of Environment and the Minister of Transportation and Infrastructure.
- "Project" means the project as scoped under section 2.
- "Proponent" has the same meaning as on page 1 of this order.
- "Report" means the document that will be produced by the federal panel following the close of its hearings concerning the proposed Project.

### PART B - SCOPE OF THE PROPOSED PROJECT

### SCOPE OF THE PROJECT

2.1 The scope of the proposed Project is the same as the scope determined by the Agency as described in the Guidelines.

### PART C - SCOPE OF THE ASSESSMENT

### SCOPE OF THE ASSESSMENT

- 3.1 The scope of the assessment for the proposed Project will include consideration of:
  - 3.1.1 The scope of factors established by the Federal Minister of Environment in the terms of reference issued to the federal review panel;
  - 3.1.2 Potential adverse environmental, economic, social, heritage, and health effects of the proposed Project, including cumulative effects, and practicable means to mitigate such potential adverse effects; and

3.1.3 Potential adverse effects of the proposed Project on an Aboriginal Group's Aboriginal Interests, and, to the extent appropriate, ways to mitigate or otherwise accommodate such potential adverse effects.

### PART D - ASSESSMENT PROCEDURES

### 4. ASSESSMENT PROCEDURES

### 4.1 Overall approach

- 4.1.1 The Executive Director will rely principally on the federal review panel environmental assessment of the proposed Project for the information needed for his assessment.
- 4.1.2 If the Executive Director determines that additional information or assessments are required to complete his review, he will require the Proponent to provide this additional information or will otherwise ensure the information has been provided in advance of the referral of this project to the provincial Ministers.
- 4.1.3 The Executive Director will rely on consultation conducted by the Agency with Aboriginal Groups whose Aboriginal Interests are potentially affected; and will also ensure that the following information is obtained in advance of the referral of this project to the provincial Ministers:
  - identification of specific Aboriginal Interests that may be impacted by the proposed Project;
  - the nature of the potential impact on Aboriginal Interests;
  - how the potential impacts can be avoided or mitigated;
  - Aboriginal Groups' views of avoidance or mitigation measures;
  - · residual impacts on Aboriginal Interests;
  - · any measures to address those residual impacts; and
  - any other concerns raised by Aboriginal Groups regarding the proposed Project.

Upon receipt of this information, the Executive Director will summarize his understanding of the issues and will provide this information to Aboriginal Groups for comment prior to making a recommendation to Ministers.

4.1.4 The Executive Director will consider in the assessment relevant information created by the Gateway Transportation Collaboration Forum to the extent such information is available prior to referral to provincial Ministers for decision as described in section 4.2.

### 4.2 Ministerial Referral and Decision

- 4.2.1 The Executive Director will review the information generated under section 4.1 during the 150 days (5 months) timeline for the federal Minister's decision statement (post-panel phase) from the date of submission of the federal review panel's report to the federal Minister.
- 4.2.2 The Executive Director must make a recommendation to provincial Ministers within 30 days of receiving notice of the decision of the federal Minister of the Environment pursuant to section 52 of the Canadian Environmental Assessment Act, 2012, including any extension to the date under that Act.
