Dear Gregg Stewart:

Your request under the *Forest and Range Practices Act Forest Service Road Use Regulation* section 6(3) to erect a traffic control device on a forest service road (FSR) has been thoroughly reviewed. Crown Land Opportunities and Restoration Branch is hereby authorized to the following:



- To address public safety issues during and following mine reclamation, a gate may be
 installed at approximately 0+030 km on the Britannia Creek FSR (8321.01) immediately
 after the intersection with Highway 99.
- The Permit Holder will ensure that the gate shall be adequately marked and clearly visible to the operator of a motor vehicle from a safe stopping distance. This includes warning signs which shall be located (facing up and down traffic) to the District Manager's satisfaction, to give operators adequate warning of the obstruction.
- A sign shall be maintained at the gate advising the public of the contact person(s)
 responsible for the gate; and all pertinent and emergency contact information that may be
 required during closures.
- The Permit Holder shall supply two (2) copies of gate keys to the Sea to Sky District and Wildfire Management Branch and the Road Use Permit Holders at no cost. You are encouraged to contact the various emergency service providers (including Fire, Ambulance, Police, and Search and Rescue) to inform them that the gate will be closed into the future and who the emergency contact is.
- The costs of all gate maintenance and any eventual removal of the gate will be borne by the Permit Holder

Hi Dave,

I have a question out of curiousity...see attached harvesting area that RichPly is proposing to work on this summer. Presumably RichPly has the tenure rights to harvest this area, however, I note that the western extent is within 50 to 100m of

one of the key areas of our mine site. If you look at the appraisal map, on either side of 0+689 is what we call the 2200 level area of the mine. It contains a relatively large waste rock debris pile from the former mining operations and also includes one of two key plugs for the underground mine workings. These plugs hold back acidic mine water from the ~210km of underground workings and redirects that water to report out of the lower plug (at the 4100 level adit) where it is piped directly to our water treatment plant. I'd have to confirm, but I'm going to suggest that the western extent of RichPly's harvest area lies immediately above either the plug or the tunnel to the plug that was installed in 2001.

An environmental map reserve and a no staking claim have been set up that covers this area, however, I suspect those came into effect after RichPly had already received their TFL for Britannia. I would need to seek expert advice on whether the work proposed contains any risk for the plug, but if that was the case, is there anything that could be done regardless? I wonder if we should sit down and review all of the TFL's granted for the Britannia area and determine if any other locations are at risk.

Hello Geoff, I thought I might reach you today after receiving your email. Here are two detailed maps we are working with which provide two options for us to access our MS2 harvesting area. The Mount Shear Main was a road left open for MINE USE during 1990s Watershed Restoration works. It is not our preferred access as almost 400m of it parallel within the Riparian Mgmt Area, 100m is right along side of Britannia Creek. However, government policy currently forces us into the "least cost" application for timber appraisal purposes. Since Mount Shear Main (old southern access route) is an existing road and appears to be the least cost it is how we will proceed with application to MNRO.

If possible and you over on this side in the next week(s) we should sit down and come up with a coordinated plan. Not sure how your budgeting works but mine needs to be in play in the next 15 days. I will request that you come to the table with some \$ as it appears that the cost of re-access will not cover the domestic value of the timber being logged. I still prefer re-establishing access at the existing crossing using the bridge panels onsite. Your direction and tentative support is requested.

From my conversation pre xmas with Gerry and John, I determined that Gerry has identified contaminated material that needs to be recovered from the 2200 site and John confirmed that no detailed site plan for bridge replacement has been accomplished to date. John has been made aware of our concern that the locking mechanism on the gate should be simple and easy. I requested he consider a push button lock with door nob type opening.

Hi Dave. I am sending this email to summarize information I have found out about the new gate planned for the Britannia FSR and to respond to your concerns around the potential impact of the gate to your operations on TSL A86049. I have also been advised that Richply may be hauling logs out of Britannia in 2014.

I recently spoke with Geoff Sinnett, Senior Program Geoscientisthttp://dir.gov.bc.ca/gtds.cgi2
esearch=&updateRequest=&view=brief&sortBy=title&for=people&attribute=title&matchMethod=is&searchString=Senior+Program+Geoscientist
of LNG, Crown Land Opportunities & Restoration in Victoria. He informed me that a new gate will be installed at the start of the Britannia FSR at Hwy 99 early in the new year. BCTS was not aware of these plans at time of TSL advertisement. He said this gate is to replace the irreparably damaged gate that was previously there for several years and is needed to address the numerous trespass, theft, damage, health & safety and potential violence incidents in the Britannia area. It is currently his intention to have the gate stay locked at all times, however we discussed the challenges that RUP holders such as yourself would face if this was the case. Further communication between all parties is required. He also advised of mine reclamation works happening in summer 2014 which would involve rock trucks travelling back & forth from the Jane Basin area in the back of the Britannia valley. I told him that your hauling frequency will be posted.

I also spoke with Malcolm Schulz about the gate and confirmed that authorization to install this gate was granted by the District Manager in September 2013 - see attached letter. This gate is being installed and managed by the mines people and becomes their responsibility. Note that your RUP states: "The Permittee must work with the mine's property owner with regards to the use of the gate at 0+ 000 on the Britannia Creek Forest Service Road. The Permittee may be required to ensure the gate is closed at all times."

It is important that all road users communicate to ensure safe road use for all. I recommend contacting Geoff to discuss the gate installation. \$.22 Here is contact information for Geoff and the person covering for him \$.22

The existing access appears to meet the Ministry's requirement however there appears to be a growing use of this access by the public. Therefore additional improvements may be required in the future, such as, and not limited to, improved deceleration lane, raised delta traffic island to direct north bound traffic entering onto Highway 99 and associated signage.

It has also been noted on occasion, that excessive gravel/soils being tracked out onto the highway from this access as well as surface water draining onto the highway. This will need to be monitored and rectified if/when necessary.

PERMIT TO CONSTRUCT, USE, AND MAINTAIN ACCESS TO A PROVINCIAL PUBLIC HIGHWAY

PURSUANT TO TRANSPORTATION ACT AND/OR THE INDUSTRIAL ROADS ACT AND/OR THE MOTOR VEHICLE ACT

BETWEEN:

("The Minister")

AND:

Ministry of Forests, Lands & Natural Resource Operations 101-42000 Loggers Lane Squamish, British Columbia V8B 0H3 Canada

("The Permittee")

WHEREAS:

- **A.** The Minister has the authority to grant permits for the auxiliary use of highway right of way, which authority is pursuant to both the Transportation Act and the Industrial Roads Act, the Motor Vehicle Act.
- B. The Permittee has requested the Minister to re-issue a permit pursuant to this authority for the following purpose:

The installation and/or operation and maintenance of an Industrial access intersecting with the Sea to Sky Highway 99 (Controlled Access Highway), for a Forest Service Road identified as: Britannia Creek Forest Service Road #8321, south of Britannia Beach. Old DAS permit No. 01-004-12352 to serve for Industrial and some recreational use developing from Hwy 99, as shown on drawing.

C. The Minister is prepared to issue a permit on certain terms and conditions;

ACCORDINGLY, the Minister hereby grants to the Permittee a permit for the Use (as hereinafter defined) of highway right of way on the following terms and conditions:

- 1. The Minister shall designate an official ("the Designated Ministry Official") who shall act as the Minister's agent in the administration of this permit in the manner hereinafter set out.
- 2. The 'Use' shall be carried out according to the reasonable satisfaction of the Designated Ministry Official.
- 3. The Permittee will at all times indemnify and save harmless Her Majesty the Queen in Right of the Province of British Columbia, as represented by the Minister of Transportation, and the employees, servants, and agents of the Minister from and against all claims, demands, losses, damages, costs, liabilities, expenses, fines, fees, penalties, assessments and levies, made against or incurred, suffered or sustained by any of them, at any time or times (whether before or after the expiration or termination of this permit) where the same or any of them are sustained in any way as a result of the Use, which indemnity will survive the expiration or sooner termination of this permit.
- 4. The Permittee shall make diligent attempts to determine if there are other users of the access and/or right of way in the vicinity of the Permittee's location whose use may be affected. It shall be the responsibility of the Permittee to contact any such users before exercising any of the rights granted hereunder and to attempt to reach an accommodation. In order to restrict the number of accesses to this Controlled Access Highway, a shared use agreement may be necessary.
- 5. The Permittee shall take reasonable care to prevent any damage or interference with any Use authorized by this permit in the carrying out of the construction, extension, alteration improvement, repair, maintenance or operation of any work adjacent thereto, but the Minister shall not be responsible for any damage regardless.

- 6. The Minister at the absolute discretion of the Minister may, at any time, cancel this permit for any reason upon giving reasonable notice; provided, however, that in the case of default by the Permittee or in the case of an emergency no notice shall be necessary. The Minister shall not be liable for any loss incurred as a result of permit cancellation.
- 7. The Permittee shall be responsible for replacing any survey monuments that may be disturbed or destroyed by the Use. Replacement must be by a British Columbia land surveyor at the Permittee's expense.
- 8. The Permittee shall remove any mud, soil, debris, or other foreign material tracked onto the highway from the access authorized herein. Such removal shall be at the Permittee's expense and shall be done at any time the material unduly inconveniences traffic and/ creates a hazard to the public including motorist, cyclists and pedestrians, in any event, daily.
- 9. The Permittee acknowledges that the issuance of this permit by the Minister is not a representation by the Minister that this permit is the only authority needed to carry out the Use. The Permittee shall give deference to any prior permission given for use of the right of way in the vicinity of the permit area, shall obtain any other permission required by law, and shall comply with all applicable laws regardless of their legislative origin.
- 10. At the end of the term of this permit, or when the permit is cancelled or abandoned, the Permittee shall, if so requested by the Minister, remove all installations and shall leave the site as near as reasonably possible in the condition it was in before this permit was issued or such other condition as shall reasonably be required by the Designated Ministry Official. If the Permittee refuses to comply with these obligations, the Minister may perform them as required and the Permittee shall be liable to the Minister for the costs of doing so.
- 11. The rights granted to the Permittee in this permit are not assignable without the consent of the Minister.

British Columbia this

- As a condition of this permit, the permittee unconditionally agrees with the Ministry of Transportation and Infrastructure that the permittee is the prime contractor, as described in Section 118 of the Workers Compensation Act, for the purposes of the work described by this permit, at the work location described in this permit, and that the permittee will observe and perform all of the duties and obligations which fall to be discharged by the prime contractor pursuant to the Workers Compensation Act and the Occupational Health and Safety Regulation.
- 13. Periodic inspections and maintenance of any access culvert where present is the responsibility of the Permittee.
- 14. Sight distance brushing meeting Ministry standards is the responsibility of the Permittee.

This industrial access permit will expire in 5 years from the time of issue. A review of conditions at that time will determine if any further improvements will be required before re-issue.

This permit will expire on January 7, 2019

Thanks for getting back. It just may be that it is a FLNRO lock, Just wanted to make sure it wasn't one of yours.

Richmond Plywood is still considered the Primary (primarily because they go the furthest back and have long-term interest in the area), although we have shifted the responsibility of the maintenance of that gate to the mines remediation folks (i.e. Geoff Sinnett) seeing as they were pushing hard to restrict access to the area for safety reasons. In a letter from the District Manager authorising the installation of that gate, it stipulates the following:

- The Permit Holder will ensure that the gate shall be adequately marked and clearly visible to the operator of a motor vehicle from a safe stopping distance. This includes warning signs which shall be located (facing up and down traffic) to the District Manager's satisfaction, to give operators adequate warning of the obstruction.
- A sign shall be maintained at the gate advising the public of the contact person(s) responsible for the gate; and all pertinent and emergency contact information that may be required during closures.
- The Permit Holder shall supply two (2) copies of gate keys to the Sea to Sky District and Wildfire Management Branch and the Road Use Permit Holders at no cost. You are encouraged to contact the various emergency service providers (including Fire, Ambulance, Police, and Search and Rescue) to inform them that the gate will be closed into the future and who the emergency contact is.
- The costs of all gate maintenance and any eventual removal of the gate will be borne by the Permit Holder

Afternoon Brian...as discussed..

On May 16th, 2014 I was patrolling on the Britannia Creek FSR and was stopped by the cutting foreman. He requested us to tow a vehicle from the exit

onto the highway. A pickup truck was parked on the highway right of way and on the shoulder of the FSR. The haul trucks have to make a hairpin turn to

get onto the highway north bound. The parked truck made it difficult for them the negotiate the tail logs without hitting the pickup truck while making the swing of the turn.

Since it was on the right of way, I notified the RCMP and they towed the vehicle off. The pickup was parked in that spot by the owner for the purpose of accessing the FSR

with ATV/motorcycle. I realize that with the impending gate and signage that motorized recreationalist will not be welcome. The NROs have often noted a number of vehicles parking here continuously since the snow left.

I expect it won't be long before the motorized groups will carve a trail around the gate. I also recognize that as a mine site, the Mine Manager is the only person that can give permission to

Access the area. Hence, part of the reason for the impending gate is to reduce recreational access.

I spoke to Jessie in Transportation. He advises that since it is side road access for industry, he would preferred that the user post the signs. He considers the pullout access as the FSR even though it is in the highway right of way.

I'm requesting a consideration for MFLNRO Engineering to post no parking signs in the entrance area and prevent the conflict between the recreational access and logging trucks. The no parking signs should also come with an approval letter from the DM for the NRO to tow if found inside the no-parking area.....

I understand that signage is being developed for the gate. I might suggest that the Mine Inspector could be consulted to determine if signs from their office could be affixed to the gate to. I've CC'd Don McDonald for his contact to the Mine Inspector

I believe we have spoken in the past with regards to access on the Britannia Creek (and ultimately the Furry Creek) Forest Service Road.

As you are probably aware, the District Manager has approved a traffic control device (a gate) at the start of the Britannia Forest Service Road to the folks responsible for the remediation of the mine site. After viewing the site, and having experienced several Search and Rescue related incidents, there is consensus of the legitimacy of the safety concerns to the public in both watersheds. The authorisation comes some pretty specific conditions that must be followed including signage, maintenance expectations....and who should receive keys for access. Because the Britannia Mines Manager will be responsible to maintain this structure, they have also been tasked with distributing keys. Some will be given to emergency organisations and, I anticipate some will be "loaned out"?

Anticipating organised groups like yourself requesting access, I have forwarded an example of a "sign out sheet" we use in the District to loan out keys. I suspect they would like to do something similar but have not heard back. Best to touch base with Harry Carruthers (Britannia Mines Manager) at 604-916-1101.

Hello Dave and Malcolm. Further to Dave Southam's authorization letter of September 11, 2013, attached is a draft of the sign we plan on having constructed for the Furry Creek entrance to Britannia. Our maintenance contractor has suggested that we weld it onto the gate to protect it from vandalism. The authorization letter requires signs facing both up and down traffic, but a sign welded onto the front of the gate wont be visible to drivers from the inside of the gate. Would we therefore also need another sign placed on the inside of the gate, or uphill of the gate, to warn of the obstruction?

We are also planning on placing a sticker on the inside of the gate with a message "For assistance unlocking gate, contact Miller Capilano Maintenance Corporation at 604.892.1010. A fee of \$100.00 will be charged for the unlocking service."

Please advise on the attached proposed sign and sticker, and on the requirements for a sign on the inside of the gate facing uphill (e.g. would a sign with the text "Warning – Locked Gate" be satisfactory, and if so, could it be on the gate itself or would it need to be before the gate for more advance warning?).
