Here's some draft wording for the front end of the app:

You can help inform management of moose populations!

BC is a big province and counting moose with aerial surveys is very expensive \$.17 ... so some moose populations are surveyed every 5 years and many only every 10 – 15 years. The more information wildlife biologists have, the better they can manage moose populations in BC, and that's where you come in. By recording your sightings of moose on this app while you're hunting you will be monitoring trends in the population that will help inform moose management.

Rules for contributing data include:

- 1. Record the number of hours spent in the MU when moose might be seen, whether in a vehicle or on foot.
- 2. Only record moose seen on that day. Do not report anything if you did not hunt on a particular day.
- 3. Do not record observations of tracks, spoor, or moose beds. Only report moose actually seen.
- 4. Record the number of bulls, cows, and calves observed during the day as well as any moose for which age/sex classification was not possible. If uncertain whether the moose was a cow or a calf, report "unidentified" on the App form.
- 5. If you don't see any moose some days it is important to record that information as well. Reporting not seeing moose is just as important as reporting when you see one.
- 6. Record moose observations even if outside the range of cellular communication. The date-stamped observations will be sent up when the hunter returns to an area with cellular or WiFi coverage.
