Dear Jonathan:

On July 3, 2015, a check cruise was conducted on A16869, CP216, Block COL778 by Sean Muise and Aline Lachapelle from the Haida Gwaii District, and was also attended by Derek Drake of Tecfor as per your request.

The check cruise indicated that, within the plots visited which were completed by Abacus Forest Management Ltd. (plots 2, 3, 4, 5, 8 and 32), the standards of the *Timber Pricing Branch Cruising Manual* (2014) have not been fully met. Two checked plots were noted to contain a tree tallied as Tree Class 3 (dead potential) by the cruiser that was assessed during the check as being less than 50% sound (dead useless), and therefore should not have been tallied. Plot 32, tree 3 was referenced on the cruise cards as being "55%", but no further rationale on how this was calculated was provided.

Two tree tally changes in 27 checked trees exceeds the allowable error of 1 tree tally change in 50 checked trees, as stated in Table 3-2 of the *Timber Pricing Branch Cruising Manual* (2014). Therefore, a recruise of those plots in this block which were completed by Abacus Forest Management Ltd. must be completed to verify that all cedar trees tallied as Tree Class 3 in the original cruise have been assigned the proper Tree Class. These include all count plots completed by Abacus which contained cedar, plus the following measure plots: 1, 5, 7, 23, and 30.

The plots in this block completed by Kerley and Associates that were checked (plots 12 & 13) indicated that, within the plots visited, the Standards of the *Timber Pricing Branch Cruising Manual* (2014) have been met – no recruise work is required in plots 10-19.

The check cruise summary attached to this letter details the cruise attributes measured during the check, and several photos are included below to document the two trees assessed as less than 50% sound.
