Hi Stefanie,

Thank you for your email below regarding a Controlled Alien Species (CAS) transitory permit application to bring 2 tigers, 1 lynx and 1 jaguar into BC for the purpose of commercial filming.

Yes I did have a great holiday season – I hope yours was good as well.

Is the lynx a Canadian lynx? The reason I am asking is that lynx (*Lynx canadensis*) is designated as wildlife in BC and, as such, a <u>wildlife</u> permit to lawfully import into BC and possess and transport live wildlife will be required in addition to a CAS permit to possess the 2 tigers and 1 jaguar in BC.

Wildlife permit applications are processed by FrontCounter BC through one of their regional offices (locations: http://www.frontcounterbc.gov.bc.ca/locations/). If the commercial filming will be taking place in the Lower Mainland, the location of the FrontCounter BC office that a wildlife permit application should be submitted to is in Surrey.

If the lynx is not a Canadian lynx, for example a Eurasian Lynx (Lynx lynx) or a Iberian Lynx (Iberian lynx), it would be considered a CAS individual and would be included in a CAS permit application along with the 2 tigers and 1 jaguar.

Regarding the CAS transitory permit application for the 2 tigers and 1 jaguar, I recommend you submit a CAS permit application as soon as possible so that I can initiate the CAS permit application without delay.

Our office cannot guarantee that the application and adjudication process for a CAS permit will be complete by February 10, 2016; however, we will do our best to expedite the process so that a CAS transitory permit application package can be forwarded to the Director of Wildlife for consideration by no later than February 10, 2016.

For your convenience, I have attached a blank CAS transitory permit application that needs to be completed in its entirety and returned to our office by return email.





It is a 9acre lot with 3 acres dedicated to training and housing animals broken up by several smaller gated and secured facilities on the property for properly housing animals.

This facility has previously housed tiger, so they are familiar with proper care and maintenance for the animals along with the trainers who will be close to the animals at all times.







EMERGENCY PLAN BOWMANVILLE ZOOLOGICAL PARK

Purpose: This policy outlines the responsibilities and actions of staff if an animal escapes from its containment, or in the event of an animal attack on the public or a staff member.

Policy: While every effort is made to contain animals, it is necessary to have procedures in place in the event an animal escapes from its containment. This policy outlines the measures to be taken for the protection of the public, staff and animals should an escape or attack, take place. In all cases of animal escape or attack the priority is **public and staff safety.**

Animals involved in the filming that may require a capture plan is 1 jaguar who have come from the Bowmanville Zoological Park, 340 King St. East, Bowmanville, Ontario.

Procedure: In the event of an animal escape or attack, staff that observe or discover the incident shall immediately report to the head animal trainer. If possible one person should go to report to appropriate personnel, while a member of the staff stays at a safe distance observing the animal and its actions. If a member of the public or staff is at risk of attack or has been attacked, it is critical for emergency services to be alerted so medical help can be available as soon as possible. Staff at the scene shall keep the animal under observation from a safe location, attempt to close off doors or gates where possible to contain the animal, without putting themselves at risk administer first aid to any injured person until assistance arrives, and assist with crowd control. The head animal trainer will delegate a person to go and procure the bear spray and capture gun and dart kit, while they determine whether or not the animal can be contained without sedation. Darts will be prepared with the appropriate drug dosages for the animal, and the head animal trainer will decide whether it is appropriate to administer a dart. If other capture techniques are not possible, a dart will be administered by one of the trained animal care personnel. If a dart is administered, the zoo veterinarian will be contacted by cell phone and will stay in cell phone contact during the darting procedure. The animal will be sedated and transported back to its holding, and then reversal of the sedation will be performed if necessary.

Veterinary Care: Our animal trainer staff have been rigorously instructed on the use of Capchur rifles, drug administration and reversal, and drug effects on the cardiovascular and respiratory system. Furthermore they have had extensive target practice with the Capchur rifle and have demonstrated accuracy with dart administration. The zoo veterinarian is available by cell phone and will where possible make her way immediately to the area of recapture.

Notification of Authorities: Authorities will be notified immediately if there has been an animal attack causing human injury, or if there is imminent risk to humans during an animal escape.

Activity co-ordination: The venue and animal care staff will, at the beginning of each date, discuss responsibilities, and exchange cell phone numbers to be used in the event of an emergency. Venue security staff will be in charge of crowd control in close proximity to the animal in question, and venue security will be in charge of entrance-way crowd control.

Impossible Recapture: As all animals that are used have been desensitized to being around humans and being handled by trainers there should never be an instance where recapture is impossible. If this becomes the case this call will be made by the owner of the zoo only.

Good Evening Everyone,

After receiving a few emails in regards to making changes to my current Controlled Alien Species (CAS) application or doing a new application all together I wanted to share information directly from the permit officer, Nurie so that we are all on the same page, working together. I spoke with her this evening, she reiterated the following points about the CAS permit application process.

The CAS permit application process has been put in place by the government for the safety and protection of the public in addition to the animals coming into British Columbia. Due to the potential danger involved with the importation of CAS species there is a lengthy application process that all applicants must adhere to. Upon submitting an application it is received by a permits officer. Once the officer feels that all criteria has been submitted from the applicant it is then passed along to a review panel. This panel consists of a number individuals who review the application and submit any additional questions they may have back to the permit officer. This information is then relayed from the officer to the applicant. As the safety of the public and animals are the review panels top priority this may take a number of days. If there are no further questions on the part of the review panel then the Director of Wildlife then grants the permit. If there are additional questions then the applicate has a number of days to provide a response. The response is then reviewed by the panel. If there is sufficient information provided then the Director of Wildlife grants the permit.

On the application itself, it states that there is a 90 business day turn around for any CAS application that is submitted. This is due to the priority of safety regulated by the British Columbia government. Based on the relationship that Bowmanville Zoo has created with Nurie, the permit officer and her department they are working on processing the application as quickly as possible. There are no additional fees pay to expedite the process. It is solely based on goodwill.

As the applicant, only Bowmanville Zoo can obtain information from the application or request amendments to the application. With that being said please understand that any changes made by Bowmanville Zoo to the application will cause a delay in the permit as additional information will need to be provided to the review panel. Applications are reviewed in sequential order, therefore if a new application is submitted it will be placed behind our current application.

The current application is 194 pages in length and is very complex. It covers topics such as specialized animal training, fire arm training, capture recapture protocols and emergency escaped animal procedures.

Bowmanville Zoo has a long lasting relationship with the British Columbia government and we have been ensured that they are doing their very best to get the permits to us as quickly as possible but they also need to ensure that all of the appropriate steps are being taken for the process put in place by the government. Any efforts to contact the permit office outside of Bowmanville Zoo to will only frustrate the process.

If you have any questions or concerns please feel free to contact myself and I will be happy to answer them for

you.

CAS PAC Member # 2 - Provincial agency responsible for Natural Resource Law Enforcement and Public Safety

Unless I am missing something, they did not in any way address the concerns I raised. There is no mention of immediately reporting escapes to the Conservation Officer (COS), for providing transport schedules and facilitating inspections. In fact the response seems to completely disregard the COS and its concerns and only mentions involvement of local police and the SPCA.

CAS PAC Member # 3 - Provincial Wildlife Veterinarian

I have heard that there are already animals in transit. I am not sure if this is an issue or if it is in agreement with Bowmanville Zoo's statements that they would only ship animals as required once the permit was in place. I don't have any further issues at this time.

Please provide your comments or any additional relevant information that you would like the Director to consider in response to the following additional feedback from the Lower Mainland regional office:

There is still a level of incompleteness with elements of their Emergency Preparedness Plan. Likely due to their inexperience with the local landscape and Lower Mainland geography, I note that they do not provide the city or municipality for the various emergency contacts.

They provide and seemingly mix City of Vancouver Police Dept and RCMP detachment information without being complete as to locations for each office – Vancouver, North Vancouver (and Burnaby too it appears). They seem to not be aware of the separation and alienation (transportation corridor/bridge) between these two "Vancouver" communities. Local knowledge vetted into this revised application would have caught these fundamental aspects... and another in the bullet below too. Again, a continuing fundamental oversight in this revised application.

In one part of the revised application the "Local Hospital" is given as in North Vancouver and in another the "Local Hospital" is given as Burnaby Hospital. At least they provide the complete address for Burnaby Hospital as

opposed to the address provided for Lion's Gate. There needs to be agreement within the revised application. Perhaps there are indeed two "Local Hospitals"? If, so, we still have a fundamental-level problem with relative completeness.

The revised application provides no reference or acknowledgement for the Conservation Officer Service (COS); nor local contact info. Nor the Report All Poachers and Polluters (RAPP) line either. It appears they may consider the COS as within a catch-all compliance category as "police". This is a fundamental failure.

A fair bit of the information supplied within the forty-one (41) page revised application can be considered as only peripherally applicable.

The revised application is 'getting there', but still has some fundamental omissions and errors. When it comes to public safety provisions, I think an application must be both totally accurate and complete. This revised application still falls short.

<u>CAS PAC Member # 1 - Provincial agency responsible for animal welfare (member credentials: Chief Scientific Officer, PhD, RPBio)</u>

In speaking with our Ontario colleagues, it has come to our attention that the Bowmanville Zoo has been suspended from CAZA following an investigation into recent activities related to their film work.

A recent statement confirming this is not on the CAZA website that I can find, so I suggest the Ministry contact CAZA before any further consideration of this application (this statement dates back to Dec): http://www.newswire.ca/news-releases/statement-from-canadas-accredited-zoos-and-aquariums-563280261.html

Further, there is a provincial animal cruelty investigation in progress of the owner of the facility.

We strongly opposes this application on the basis of animal welfare, public safety, and diligence of process – for all 18 CAS animals. Although we have previously supported with caution CAS transitory permits for the film industry, this application disregards the intent of the CAS process entirely. There are no specific questions for the applicant to respond to, as they cannot satisfy the fundamental concerns.

The application is lacking in significant important detail (e.g. same enclosure proposed for different animals, definition of day and night for enclosure use), has incorrect information (e.g. Dr. McQuisten location), does not specify the arrival and departure dates and total "temporary" duration of each animal (which may be months at a time); rather the applicants assume that bringing in dozens of dangerous animals (some CAS, others unrestricted) under supervision of one animal wrangler in BC who does not possess CAS permits (application withdrawn in March 2010) and does not have CAS approved facilities, is eligible for this permit status. Further, the request was made in an unreasonable time frame to gather full detailed histories on the locations and animals, despite both the Bowmanville Zoo and the animal wrangler knowing the CAS application process.

Of significant note, both the Bowmanville Zoo and the BC animal wrangler have been the subject of multiple animal cruelty complaints and investigations. Although CAZA accreditation is not required for this permit, given that Bowmanville Zoo was recently suspended from this member association after an investigation of their practices with animals in this permit application, the Ministry should take this into serious consideration. The Ontario SPCA is also actively investigating the practices of the Bowmanville Zoo based on recent complaints, which is public knowledge. The fact that this filming is not taking place in Ontario, where there would be no CAS permit requirements, should also raise many questions. During the first season of this TV series filmed in the US, there was considerable attention raised by the media, public and animal advocacy organizations like PETA, and the same would be expected to occur in BC.

In BC, inspection visits to the proposed property for off-set housing of the CAS animals has been refused numerous times since 2006 and there is currently an open animal cruelty file for the property address. As obtaining a warrant to enter this property is challenging, there are serious concerns for the welfare of animals at this location now, and any future animals, as entry to the property cannot be gained without property owner consent or a warrant. As the AHA animal monitor has no ability to comment on off-set housing, care, training, transport etc., from previous experience managing the AHA program in the province, this program offers no assurances for the welfare of film animals.

Beyond the welfare issues of transport, housing and negative reinforcement training practices, the risk of potential escape or injury of an animal, or film set staff, is too high and sheer number of large cats (8 lions, 3 tigers, 2 leopards, jaguar, lynx) is an unreasonable request. Given the recent escape of a large cat in BC, even the best made safety and enclosure plan is not a guarantee of recapturing a hand-raised captive wild animal. The CAS permit process was established to ensure public safety, however approval of this application would undermine this.

<u>CAS PAC Member # 2 - Provincial agency responsible for natural resource law enforcement and public safety</u>

The Conservation Officer Service (COS) is mandated to protect the safety of the public and the environment from controlled alien species in the Province of BC. The applicant wishes to bring CAS into BC that can be risk to both public safety and the environment. As such I find the public safety plan to be inadequate in that it only commits to reporting escape of CAS if it is deemed to be a threat to public safety. Notification to the COS will need to be immediate if any escape occurs. Furthermore, the COS is concerned that the CAS can be safely contained at their temporary housing facility, during transit and at the film sets.

The COS should be provided with transport routes and schedules and be able to inspect housing, transport and filming facilities if necessary. The COS will need to be identified as the primary public safety and law enforcement agency to deal with escaped CAS in the plan.

The housing plan does not specify how the animal will be housed but it is in the enclosure document.

Please confirm that the daytime holding area will not include public access.



REPORTING REQUIREMENTS:

Within 72 hours of a CAS individual leaving British Columbia, the permit holder MUST submit to the Fish and Wildlife Branch via fax (250-387-0239) or by email (FishandWildlife@gov.bc.ca or ControlledAlienSpecies@gov.bc.ca) an affidavit by a person other than the permit holder (e.g. veterinarian, registered professional biologist) attesting to the fact that the CAS individual, identified as on the face page of this permit, has left British Columbia and the date of departure.

GENERAL CONDITIONS:

- The permit holder must comply with all laws applicable to the activities carried out under this permit.
- This permit extends to the permit holder's employees and volunteers, but only when they are engaged in the activities authorized by this permit on behalf of the permit holder.
- The permit holder must not authorize an employee or volunteer under the age of 19 to handle a CAS individual.
- 4. The permit holder must ensure that no person handles a CAS individual under authority of this permit unless the person has at least 2 years of experience working with controlled alien species of that taxonomic Family.
- 5. Application of this Act to controlled alien species

6.6 (1) Sections 3, 82 (4), 89, 93, 94 (1), 95 and 107 (2) apply in relation to controlled alien species as if those species were wildlife.

Release or escape of animals

- 77 (1) A person who releases or abandons an animal or from whose captivity an animal escapes
 - (a) is, despite section 11 (4) of the *Livestock Act*, liable to the government for loss or damage to wildlife or wildlife habitat caused by the animal, and for all costs incurred by the government in pursuing, recovering, holding or destroying it, and
 - (b) is not entitled to any compensation from the government if the animal is destroyed under section 79
 - (2) If a person releases or abandons an animal, other than a domestic animal, the person commits an offence.
 - (3) If an animal, other than a domestic animal, escapes from the possession of a person, the person commits an offence if he or she fails to make every reasonable effort to recover the animal.
 - (4) This section does not apply if the person is authorized by the regional manager to release the animal.

Destruction of animals

79 (1) An officer may kill an animal, other than a domestic animal, that is at large and is likely to harm persons, property, wildlife or wildlife habitat.

Documents not transferable

- 81 Except as authorized by regulation or as otherwise provided under this Act, a licence, permit or limited entry hunting authorization is not transferable, and a person commits an offence if the person
 - (a) allows his or her licence, permit or limited entry hunting authorization to be used by another person, or
 - (b) uses another person's licence, permit or limited entry hunting authorization.

Failure to pay fine

- 85 (1) This section applies if a person
 - (a) fails to pay, within the time required by law, a fine imposed as a result of the person's conviction for an offence under this Act or the Firearm Act, and
 - (b) has been served with notice of this section.
 - (2) In the circumstances referred to in subsection (1),
 - (a) the person's right to apply for or obtain a licence, permit or limited entry hunting authorization under this Act is suspended immediately and automatically on the failure to pay the fine,
 - (b) all licences, permits and limited entry hunting authorizations issued to that person under this Act are cancelled immediately and automatically on the failure to pay the fine, and
 - (c) the person commits an offence if, before that fine is paid, the person
 - (i) applies for, or in any way obtains, a licence, permit or limited entry hunting authorization under this Act, or
 - (ii)does anything for which a licence, permit or limited entry hunting authorization under this Act is required.

Entering premises

- 89 (1) For the purpose of ensuring that this Act and the regulations are being complied with, an officer may enter and inspect any premises or enclosure in which live wildlife or live fish is kept but, at the request of the owner or occupier, the officer must produce proof of identity.
 - (2) Despite the *Trespass Act*, an officer exercising duties under this Act may enter any land, whether enclosed or not but, at the request of the owner or occupier of the land, the officer must produce proof of identity.

Production of licence or permit

- 97 If a person who is required to hold a licence, permit or limited entry hunting authorization issued under this Act
 - (a) fails to produce it for inspection to an officer on request, or
 - (b) fails or refuses to state his or her name and address to an officer on request,

the person commits an offence.

REGULATIONS

Possession

3 A person must not possess a prohibited species individual unless the person holds a permit authorizing the possession of that prohibited species individual.

Breeding

- 4 (1) Subject to subsection (2), a person who possesses a prohibited species individual must prevent the prohibited species individual from breeding.
 - (2) A person who possesses a prohibited species individual referred to in subsection (1) may allow the prohibited species individual to breed if
 - (a) the person operates a zoo or is an educational or research institution,
 - (b) the person holds a permit authorizing the person to allow that prohibited species individual to breed, and
 - (c) the breeding is in accordance with a management plan approved by a regional manager.

Release prohibited

5 A person must not release a restricted species individual or a prohibited species individual or allow a restricted species individual or a prohibited species individual to be released.

Shipping or transportation

5.1 A person must not ship or transport in British Columbia a prohibited species individual unless the person holds a permit authorizing the shipping or transportation of the prohibited species individual.

This excerpt from the Permit Regulation, made under the Wildlife Act, is relevant:

8 A person who holds a permit under the Act or the Permit Regulation commits an offence if he or she fails to comply with a term of the permit.

Purpose: This policy outlines the responsibilities and actions of staff if an animal escapes from its containment, or in the event of an animal attack on the public or a staff member.

Policy: While every effort is made to contain animals, it is necessary to have procedures in place in the event an animal escapes from its containment. This policy outlines the measures to be taken for the protection of the public, staff and animals should an escape or attack, take place. In all cases of animal escape or attack the priority is **public and staff safety**.

- 1 lynx,

who have come from the Bowmanville Zoological Park, 340 King St. East, Bowmanville, Ontario.

Procedure: In the event of an animal escape or attack, staff that observe or discover the incident shall immediately report to the head animal trainer. If possible one person should go to report to appropriate personnel, while a member of the staff stays at a safe distance observing the animal and its actions. If a member of the public or staff is at risk of attack or has been attacked, it is critical for emergency services to be alerted so medical help can be available as soon as possible. Staff at the scene shall keep the animal under observation from a safe location, attempt to close off doors or gates where possible to contain the animal, without putting themselves at risk administer first aid to any injured person until assistance arrives, and assist with crowd control. The head animal trainer will delegate a person to go and procure the bear spray and capture gun and dart kit, while they determine whether or not the animal can be contained without sedation. Darts will be prepared with the appropriate drug dosages for the animal, and the head animal trainer will decide whether it is appropriate to administer a dart. If other capture techniques are not possible, a dart will be administered by one of the trained animal care personnel. If a dart is administered, the zoo veterinarian will be contacted by cell phone and will stay in cell phone

contact during the darting procedure. The animal will be sedated and transported back to its holding, and then reversal of the sedation will be performed if necessary.

Veterinary Care: Our animal trainer staff have been rigorously instructed on the use of Capchur rifles, drug administration and reversal, and drug effects on the cardiovascular and respiratory system. Furthermore they have had extensive target practice with the Capchur rifle and have demonstrated accuracy with dart administration. The zoo veterinarian is available by cell phone and will where possible make her way immediately to the area of recapture.

Notification of Authorities: Authorities will be notified immediately if there has been an animal attack causing human injury, or if there is imminent risk to humans during an animal escape.

Activity co-ordination: The venue and animal care staff will, at the beginning of each date, discuss responsibilities, and exchange cell phone numbers to be used in the event of an emergency. The filming of these animals is scheduled to happen during the time period of Feb 17 to March 1st. These dates are tentative and may vary depending on production.

This is an operational exiting animal compound with double gates and a 12' perimtere fencing, which is completel enclosed with access only through the gates.

It is a 9acre lot with 3 acres dedicated to training and housing animals broken up by several smaller gated and secured facilities on the property for properly housing animals.

This facility has previously housed tiger, so they are familiar with proper care and maintenance for the animals along with the trainers who will be close to the animals at all times.

As not all animals are required for filming at the same time, as indicated in the application, the same enclosures will be used for different species. The transfer cages, overnight housing and offsite facilities were designed with public safety and animal welfare in mind. At night time all large predators will be placed inside the double locked trailers for security measures. While at the filming location the two tigers will be kept in specially designed arenas and enclosures. The arenas are 12 feet tall, lined with hot wire, and are designed with collapsible mesh. All animals that are being transported for the purpose of the show have been hand raised and frequently travel in the trailers. As a result, the animals are desensitized to noisy crowds, being close to people, and all other aspects of performing on the road, thus removing their need/want to leave their keepers or enclosures.

What measures are in place should wildlife escape? The Bowmanville Zoological Park has specific policies and procedures set in place in the event that an animal should escape from its enclosure. In the event of an animal escape or attack, staff that observ or discover the incident shall immediately report to the head animal trainer. If possible one person should go to report to appropriate personnel, while a member of the staff stays at a safe distance observing the animal and its actions. If a member of the public or staff is at risk of attack or has been attacked, it is critical for emergency services to be alerted so medical help can be available as soon as possible. Staff at the scene shall keep the animal under observation from a safe location, attempt to close off doors or gates where possible to contain the animal, without putting themselves at risk. Certified staff should administer first aid to any injured person until assistance arrives, and assist with crowd control. The head animal trainer will delegate a person to go and procure the bear spray and capture gun and dart kit, while they determine whether or not the animal can be contained without sedation. Darts will be prepared with the appropriate drug dosages for the animal, and the head animal trainer will decide whether it is appropriate to administer a dart. It was our intent to contact the BC permitting office each time we enter and exit the province (as listed in the requirements of approved applications) with different animals should the application be approved.

As provided in the application there will be 4 animal wranglers present while Bowmanville Zoo's animals are in British Columbia. Their resumes were attached to the application: \$.22 s.22 is the head animal wrangler. Bowmanville Zoo has a policy for working with large predators, 2 trained individuals must be present whenever a large predator is moved. Please see below our Policy which has been reviewed by the Ontario Ministry of Labor. Please see Madison Thompson's attached resume.

Bowmanville Zoo will notify the permitting office by either email or fax based on the permitting offices request each time the animals enter and exit British Columbia. We do recognize that this is already a requirement for exiting British Columbia for approved applications.

Production welcomes the presence of a Conservation Officer (COS) during all aspects of the animal filming to be on set. Such a presence would ensure immediate awareness and response to any animal escapes, concerns, etc. The cost of the conservation officer will be paid by production.

Transportation schedules as it relates to production needs will be established approximately one week prior to the start of the shoot date and will be distributed to the conservation officer, local police and SPCA and local authorities.

When not on set or in transit, the animals will always be maintained at the Abbotsford facility and are available at any time for a facility inspection by a COS.

Further there is always a representative of the American Humane Society on set during any and all animal filming.



BOWMANVILLE ZOOLOGICAL PARK'S PROTOCOL!

WORKING WITH EXOTIC PREDATORS (BIG CATS AND WOLVES)

Created 2007, edited 2010, 2012, 2014

The Bowmanville Zoological Park (BZP) is a unique facility that prides itself on being able to work a wide variety of species both on and off leash. Part of BZP's enrichment program for these animals involves them being moved without stress to different outside enclosures on a daily basis, taking part in daily training sessions, working in a film production environment and taking part in live educational shows. Many of the animals that participate in these events are large carnivores including; lions, tigers, jaguars, and wolves.

BECOMING A TRAINER

The Bowmanville Zoo has selected a few individuals and trained them specifically to work free contact with large exotic predators. Currently they are as follows; the zoo director and head trainer. There are a number of individuals currently in the process of being trained to work with these animals and currently can only do so in the presence of either the head trainer or zoo director.

In order to become a trainer, the candidate must first show high levels of dedication, husbandry and management to the animals under their care as a keeper. The next step is to read the appropriate literature to understand the basis for training animals and the philosophies of Bowmanville Zoo. One of the required readings is "Don't Shoot the Dog: The New Art of Teaching and Training" written by Karen Pryor. After completing the assigned readings and testing the candidate will enter discussions with the zoo director, curator and head trainer about working with other animals in the zoo BEFORE it will even be considered that the candidate will work with the large predators. Understanding that working with a predator is very different from working with hoof stock, birds or primates. Working with different species first will help the candidate put what they have read into practice.

Once the director, curator and head trainer feel that the candidate is ready to begin working with the large predators, they will work under their guidance, including numerous training sessions and in depth discussions. A candidate needs to understand that training animals involves a continuous learning curve. Once the director, curator and head trainer feel confident that the candidate is capable of working with these animals alone, they will be tested on their performance, both a written and practical test. This performance test will not only encompass their animal training ability, but their compliance with Bowmanville Zoo's animal handling protocol.

RESPONSIBILITIES OF A TRAINER

A trainer is responsible for the following:

- 1. Their own safety, the animal's safety, the back-up individual's safety, co-workers safety, guest safety and the safety of all animals around them.
- 2. Making the keeper on the cat barn aware of what animals need a change in diet due to a trainer's training schedule. Sometimes an animal's diet needs to increase or decrease depending on the type of training being done. A trainer is responsible for writing out any changes in the cat barn log book, verbally letting the BACK keeper know, and bring it up in morning meeting. There is a specific location in the Cat Barn Log Book for trainer comments including diet change.
- 3. Making sure all training equipment is put away properly after each use. If a trainer does not put away their equipment then they are demonstrating their lack of care for the training program. This action is not acceptable as not caring for equipment will lead to their early destruction and ultimately it is a health and safety concern.
- 4. Ensure all carnivore stations are stocked and have all necessary equipment
- 5. Ensure that the backup person has the proper back-up equipment and are properly following policies and procedures. If they are not, it is the trainer's responsibility to say something to them and then to management. Never move an animal without all of the proper equipment since it is a dismissal able offence
- Capture equipment is present and in working order when going offsite, and secured appropriately.
- 7. Transportation cages are checked and safe if taking the animal off property

SECONDARY PERSON: THE BACK-UP

Whenever a large predator is taken out of its enclosure on leash by a trainer, a back-up individual MUST be present. Under no circumstances is a trainer to do this alone. Should a trainer attempt to move a big cat alone, they will be dismissed. The back-up individuals must have taken part in an orientation and training session that teaches dealing with emergency situations, behavioural observations in animals, Capchur pistol usage, as well as the policies of Bowmanville Zoological Park. Once the training session has been completed and they have successfully passed the testing process, each individual is to sign a form stating that they have participated in the seminar and understand their responsibilities to themselves, the animals, as well as to the other people they will be assisting.

Management will select individuals who they feel will best serve as a back-up. The candidate's ability to think quickly in stressful situations will be taken into account. The candidate must be able to properly deal with any situation that may arise. If a red light situation is to arise, the back-up must remember that they are a tool for the trainer to use. Listen to the trainer unless they are unconscious. All of these scenarios will be addressed in training and outlined below.

MANDATORY EQUIPMENT

Any time a large predator is moved from their cage by leash to another location, two individuals MUST be present, a trainer and a back-up. The individuals MUST have with them the prescribed equipment for moving large carnivores. The trainer is to be working with the animal; therefore the back-up is to carry all equipment needed for emergency situations. The list is as follows:

- 2 Crooks
- 1 Catch up rope
- 1 Meat stick
- 1 Radio (minimum)
- 1 Utility belt containing:
 - 1 Bottle of traveling bear spray
 - 1 Emergency care kit complete with:

Rubber tourniquets
Gauze squares
Abdominal pads
Laminated map to the hospital

The reason for having the additional crook is to ensure that both individuals have a tool to help deal with a situation if an emergency was to arise. The bear spray is to be used ONLY if absolutely necessary, as the reaction of each animal will be different, and the possibility of human exposure exists. A radio MUST be present as it is the life-line if an emergency situation was to occur. This will allow individuals to make all other staff aware of what is going on and for help to be called if needed.

There are NO CIRCUMSTANCES under which one of these items is to be missing. Failure to follow these instructions will result in severe consequences or dismissal.

Bowmanville Zoological Park's PROTOCOL FOR MOVING BIG CATS

Any time a big cat is moved from one location to another there is a protocol that MUST be followed. There MUST be two people at all times, a trainer and a back-up. Only people trained to be the back-up are allowed to be the second individual.

The second person MUST be carrying 2 crooks, a catch up rope, a meat stick, a radio, and the utility belt with all necessary items. The detailed list is described above.

Before the animal trainer goes in with the animal, the sliding mesh door or the solid sliding door to the cat barn and the door to the carnivore holdings MUST be closed and locked. The purpose for this is that it will contain the animal if an emergency was to occur. If on an offsite be sure that all containment doors are closed i.e. door to the trailer. The trainer can then proceed into the cage with the animal. At no time is there to be anyone else within the closed off area (between the closed holding door and the mesh door) unless cleared by management prior to.

Before the trainer exits the cage/enclosure with the large cat, the back-up individual MUST radio everyone to make it known that a large cat is being moved through the zoo.

The back-up will state "JUST SO EVERYONE IS AWARE, WE ARE MOVING (animal name) FROM (start location) VIA (exact path being taken) TO (end location). ARE PERIMETER FENCES SECURED?". The back-up and trainer MUST wait for all active area radios to acknowledge the call before leaving the cat barn.

All active AREA radios will respond "NAME, LOCATION, GOT THAT. PERIMETER FENCE SECURE HERE". If the trainer and/or back-up are unsure if they heard an individual radio in a response, they MUST ask that person for a repeat before moving. All active radios may ask the back-up to repeat any information they did not hear clearly. Once all active AREA radios have responded, the trainer and back-up are allowed to begin moving the specified animal. When a large cat is being moved, NO other animals are to be moved. Keepers are to wait until the cat has reached its destination, or, if necessary, move the animals just before the large cat departs, but only with the express permission of the trainer handling the cat.

While en route, the back-up is to proceed through all doors, gateways, around corners, etc. first. This ensures that the pathway is clear, safe, and secure for the movement of the animal, and prevents those without a radio from walking in the path of the cat. At all times, trainers and back-ups should be thinking ahead and anticipating potential incidents or accidents before they can occur. The back-up is not to enter the enclosure/cage with the trainer unless cleared by the trainer. When the cat is securely

locked in the cage/enclosure, the back-up can then radio "(name of cat) IS AWAY". Once this is done, keepers can once again move their animals.

These same basic procedures are to be followed while offsite at a live educational show, film work or for any other purposes.

TV & FILM WORK: Once Bowmanville Zoo has been contacted to provide an exotic predator for production work there are a number of steps that are taken.

- 1. The offsite co-ordinator ensures that all staff involved with the filming are made aware of the date we are expected to arrive on set. Normally this information is provided to their staff on a call sheet. This is the production team's responsibility.
- 2. The offsite co-ordinator also makes production aware that a health and safety meeting will take place upon our arrival to site location.
- 3. The offsite co-ordinator informs the production team that a OSPCA representative should be present the entire time that we are on set. This is productions responsibility to acquire them. We can give our contacts should they request them.
- 4. The offsite co-ordinator will obtain all permits should they be required and animal health certificates should they too be requested.
- 5. The head trainer for the specific production is to ensure that all capture equipment is packed and fully stocked before leaving zoo property. This can be coordinated with our veterinarian.
- 6. It is the responsibility of both the trainer and the back-up individual to have a health and safety meeting with production those that are on and off set. This is to happen upon arrival to set location.

Topics to be covered:

- a) conduct of production staff around the predator (no touching, photographs, video)
- b) conduct of production staff while the predator is on set
- c) which production staff are allowed on set while the animal is out
- d) what to do in an emergency situation
- e) NO production staff policies for hanging around our animal trailers
- f) any other relevant safety information that both the trainer and back up feel that is appropriate for the specific production.

Remember that the animal team is in charge not the production staff. Only proceed once they understand our safety policies.

7. All production staff are to be made aware right before the animal is taken out of the trailer/transfer cage and brought on set. A predetermined route is first to be assessed upon arrival and again right before the animal is to be moved. Make sure all non-trained staff, Bowmanville Zoo employee or

production are clear from route.

Before the predator is taken out be sure you have:

- a) cleared a direct path to set which is clear from production staff, any debris, or food
- b) it is safe for our animal to go onto set
- c) production is aware of our arrival onto set and that it is locked off
- 8. CHILDREN ARE NOT PERMITTED ON SET WITH ANY LARGE PREDATOR.

LIVE EDUCATIONAL SHOWS: Once Bowmanville Zoo has been contacted to provide an exotic predator for a live educational show such as X-treme Wild there are a number of steps that are taken.

- 1. The offsite co-ordinator ensures that all staff involved with the event/venue are made aware of the date we are expected to arrive and depart.
- 2. The offsite co-ordinator also makes the event/venue aware that a health and safety meeting will take place upon our arrival to the location.
- 3. The offsite co-ordinator will obtain all permits should they be required and animal health certificates should they too be requested. Should the local area require we notify the police of our arrival we will do so. Such is the case when we are traveling across Canada.
- 4. The offsite co-ordinator will create an offsite package which lists all important information, contacts and permits. It is the responsibility of the head trainer for that specific event to bring this package to the event/venue.
- 5. The head trainer for the specific event is to ensure that all capture equipment is packed and fully stocked before leaving zoo property. This can be coordinated with our veterinarian. A review can be set up for the use of all capture equipment by either: the veterinarian, zoo director or curator.
- 6. The head trainer is responsible for loading all public barriers and mesh arena for the event/venue. In addition to all of the appropriate back-up equipment and animal husbandry needs.
- 7. It is the responsibility of both the trainer and the back-up individual to have a health and safety meeting with the event/venue staff that are directly involved or in charge of the event. This is to happen upon arrival to set location.

Topics to be covered:

- a) conduct of staff around the predator (no touching, photographs, video)
- b) conduct of staff while the predator is out for the show
- c) which staff if any are allowed on behind the public people barrier while the animal is out during the show
- d) what to do in an emergency situation
- e) our NO event/venue staff policies for hanging around our animal trailers

f) any other relevant safety information that both the trainer and back up feel that is appropriate for the specific event/venue.

Remember that the animal team is in charge not the event/venue staff. Only proceed once they understand our safety policies.

All event/venue staff are to be made aware of when the animal will be used in shows. Normally a show schedule has been arranged beforehand.

Before the predator is taken out be sure you have:

- a) cleared a direct path to performance area which is clear from none animal staff, any debris, or food
- b) it is safe for our animal to go on
- CHILDREN ARE NOT ALLOWED TO INTERACT WITH LARGE PREDATOR FOR ANY REASON. THEY ARE ALWAYS TO REMAIN OUTSIDE OF THE PUBLIC BARRIERS.

As the animal team remember that you are responsible for your safety, the safety of your co-workers and the guests/ people around you. Do not proceed if you are unsure.

BIG CAT EMERGENCY PROTOCOL

This protocol has been put into effect by the Bowmanville Zoological Park to ensure that all possible measures are taken to preserve the health and wellbeing of its trainers in the event of an emergency. While we recognize that not all eventualities can be foreseen and prevented, the Bowmanville Zoo is committed to making all necessary preparations to reduce the risks associated with emergency situations.

The following will outline the procedures that are to be followed in the emergency situations described.

1. A trainer has been life-threateningly injured by a large cat

While there are numerous ways a large cat could injure a trainer, this procedure will focus only on if a large cat has managed to injure its trainer resulting in extreme blood loss and possible death in a very limited time frame. Specifically, this can occur if the cat manages to rupture the aorta, the carotid, or the femoral arteries. Such an incident is termed a red light situation. It is focused on this situation, because unless the trainer is unable to direct the back-up, i.e. a life threatening injury,/unconscious, the trainer will be overseeing and instructing the back-up on what to do and where to be.

In the instance of a red light situation, the first response of the back-up, is to contact the supervisor using the radio, then proceed to use the shepherds crook, if possible, in an attempt to free the afflicted person from within the reach of the cat. If this is not possible, the back-up will use the bear spray to separate the trainer from the animal. If possible, all care should be made not to spray the trainer with

the bear spray. The supervisor will then delegate other staffs responsibilities. When calling over the radio during an emergency, it is important to remain calm. Do not shout, speak clearly and concisely to avoid wasting time repeating information. The radio call should consist of the location of the back-up and trainer, the trainer who is injured, and a request for assistance. Once this radio call has been made no other radio communications should be made, other than those pertaining to the emergency.

Once the cat has been separated from the trainer, the back-ups first priority will be to secure the cat. If it is inside an enclosure, the back-up's only responsibility will be to secure the trainer, by removing the trainer, and locking the door to the enclosure. If the cat has run away, or cannot be secured, protocols for an escaped cat will be followed, with the back-up remaining with the trainer. However, if the cat remains in the area, it poses a further risk to any staff helping with the injured trainer, and must therefore be secured. The back-up is then to secure the trainer, by dragging him out of reach of the animal. Once the trainer is secured, the back-up is to place pressure on the wound using gauze pads and slow the bleeding of the trainer. The back-up should place one hand over the wound with adequate pressure to stop the blood flow. The back-ups sole job will be to apply pressure to the wound. Standard gauze will be located in the utility belt and should be used to cover the wound and apply pressure.

If the emergency has occurred outside of the confines of an enclosure and/or the animal has escaped the enclosure, the procedure will be the same as for any escaped animal; however priority will be given to the injured party. Staff will only assist with the escaped animal once the injured party has been secured.

Order of people in charge of escaped animal at time of emergency:

ONSITE

OFFSITE:

Animal Escapes - Zoo Open & Closed

RED ALERT - Animal hazardous to the public (i.e. large carnivores, elephants)

Communication

- Person discovering escaped animal will immediately establish radio contact with other zoo personnel. Person
 will announce "Red" and then the name of the escaped animal and location in the zoo. Person will maintain
 radio contact and continue to observe animal at a safe distance until another employee arrives on the scene.
 The first person (while there primary job is to monitor the animal and its movement) will begin crowd control
 as appropriate. Large Predators are not to be moved with a trainer while the zoo is open to the public.
- While one employee continues to watch the animal, the next person to arrive goes to the office and obtains appropriate equipment and returns with a vehicle.
- 3. All animal employees meet at the scene of the escaped animal. Notify the office and gift shop personnel.
- 4. The gift shop person will call the veterinarian (905-623-4431 or 905-442-3608 or 905-623-9012) and have them drive to the area of the escaped animal. No one will be allowed to enter the zoo; restaurant and office personnel will remain at their own phone in case needed. No other radio communications should occur except for those pertaining directly to the escaped animal.

Visitor Safety

- The entire park must be cleared of all visitors, all volunteers and guests as calmly and quickly as possible through the main entrance gate. We understand that this may not always be possible given the location of the escaped animal. If necessary use barns and buildings to keep the visitors safe.
- All restaurant, mechanical ride, maintenance and gift shop and splash pad staff will coordinate and help with
 the clearing of the park by remaining at the entrance gate to let out stragglers or to let in emergency vehicles.
 Do not return to the animal area unless asked to do so by the person in charge. All staff will be instructed by
 management via radio.

Animal Procedure

- 1. Equipment
 - a) The following equipment will be kept in the cat barn, elephant barn, and carnivore stations throughout the zoo for emergencies:
 - Ropes
 - Meat Sticks
 - Crooks
 - Fire Extinguisher
 - Pepper spray

- b) The capture gun and supplies are known to management and trainer/backup staff only. Anesthesia agent locations are known to management and trainer/backup staff only.
- c) Veterinarian will arrive with capture gun, blow gun, pole syringe and drugs as deemed necessary.
- d) The firearms and supply location are known only to those with the FAC license. See above.

2. Capture Procedure

Because of the hazardous nature of the emergency, only the animal staff, management staff, veterinarian and other authorized personnel will be involved in the actual capture.

- a) First keeper still observing movement of animal.
- b) Back-up person proceeds directly to the animal in a vehicle with the necessary equipment to back up the observer. Firearms are to be used only as a last resort to protect any person from bodily harm. All other options are to be explored prior to the option of deadly force.
- c) The veterinarian and authorized person will prepare appropriate capture darts and proceed to the scene with back up equipment and drugs.
- d) By this time, a plan will be ready for immobilizing the animal. Nets, cages, etc., will be gathered. One person must be completely in charge and their instructions followed without hesitation.

ANIMAL ESCAPE POLICY BOWMANVILLE ZOOLOGICAL PARK

Purpose: This policy outlines the responsibilities and actions of staff if an animal escapes from its containment, or in the event of an animal attack on the public or a staff member.

Policy: While every effort is made to contain animals, it is necessary to have procedures in place in the event an animal escapes from its containment. This policy outlines the measures to be taken for the protection of the public, staff and animals should an escape or attack, take place. In all cases of animal escape or attack the priority is **public and staff safety.**

Procedure: In the event of an animal escape or attack, staff that observe or discover the incident shall immediately report to the head animal trainer. If possible one person should go to report to appropriate personnel, while a member of the staff stays at a safe distance observing the animal and its actions. If a member of the public or staff is at risk of attack or has been attacked, it is critical for emergency services to be alerted so medical help can be available as soon as possible. Staff at the scene shall keep the animal under observation from a safe location, attempt to close off doors or gates where possible to contain the animal, without putting themselves at risk administer first aid to any injured person until assistance arrives, and assist with crowd control. The head animal trainer will delegate a person to go and procure the bear spray and capture gun and dart kit, while they determine whether or not the animal can be contained without sedation. Darts will be prepared with the appropriate drug dosages for the animal, and the head animal trainer will decide whether it is appropriate to administer a dart. If other capture techniques are not possible, a dart will be administered by one of the trained animal care personnel. If a dart is administered, the zoo veterinarian will be contacted by cell phone and will stay in cell phone contact during the darting procedure. The animal will be sedated and transported back to its holding, and then reversal of the sedation will be performed if necessary.

Veterinary Care: Our animal trainer staff have been rigorously instructed on the use of Capchur rifles, drug administration and reversal, and drug effects on the cardiovascular and respiratory system. Furthermore they have had extensive target practice with the Capchur rifle and have demonstrated accuracy with dart administration. The zoo veterinarian is available by cell phone and will where possible make her way immediately to the area of recapture.

Notification of Authorities: Authorities will be notified immediately if there has been an animal attack causing human injury, or if there is imminent risk to humans during an animal escape.

- The permit holder must not display the CAS for public viewing, including public contact and media
 use, other than what is required for commercial filming and production of the TV Series "Zoo season
 2".

• Within 72 hours of a CAS individual leaving British Columbia, the permit holder MUST submit to the Fish and Wildlife Branch via fax (250-387-0239) or by email (FishandWildlife@gov.bc.ca or ControlledAlienSpecies@gov.bc.ca) an affidavit by a person other than the permit holder (e.g. veterinarian, registered professional biologist) attesting to the fact that the CAS individual, identified as on the face page of this permit, has left British Columbia and the date of departure.

You have the right to appeal this decision to the Environmental Appeal Board within 30 days from the date of issue of your permit. For more information on the EAB appeal process, see Appendix 1, attached to this letter, and the following website: www.cab.gov.bc.ca.

APPENDIX 1

REPORTING REQUIREMENTS:

Within 72 hours of a CAS individual leaving British Columbia, the permit holder **MUST** submit to the Fish and Wildlife Branch via fax (250-387-0239) or by email (<u>FishandWildlife@gov.bc.ca</u> or <u>ControlledAlienSpecies@gov.bc.ca</u>) an affidavit by a person other than the permit holder (e.g. veterinarian, registered professional biologist) attesting to the fact that the CAS individual, identified as on the face page of this permit, has left British Columbia and the date of departure.

GENERAL CONDITIONS:

- The permit holder must comply with all laws applicable to the activities carried out under this permit.
- This permit extends to the permit holder's employees and volunteers, but only when they are engaged in the activities authorized by this permit on behalf of the permit holder.
- The permit holder must not authorize an employee or volunteer under the age of 19 to handle a CAS individual.
- 4. The permit holder must ensure that no person handles a CAS individual under authority of this permit unless the person has at least 2 years of experience working with controlled alien species of that taxonomic Family.
- 5. This permit extends to a person authorized to practise veterinary medicine in BC while that person possesses a CAS individual for the purpose of veterinary medical treatment, but is only effective for the first 72 hours after the person takes possession of a CAS individual for any given treatment.

NOTE: If veterinarian is in possession of a CAS individual for the purpose of longer term treatment (greater than 72 hours) the veterinarian will need to apply for a Rescue Centre permit.

- 6. The permit holder must ensure that any person transporting a CAS individual under authority of this permit carries a copy of this permit on their person.
- The permit holder must not display the CAS for public viewing, including public contact and media use, other than what is required for commercial filming and production of the TV Series "Zoo season 2".
- 8. The permit holder must not house a CAS individual in the same enclosure as wildlife or a domestic animal (to reduce the possibility of the transmission of disease and parasites).
- The permit holder must take all steps reasonably necessary to ensure that public safety is not jeopardized by any action taken under authority of this permit.
- 10. Prior to the CAS species individual named on this permit entering the Province of BC and the commencement of activities carried out under this permit, the permit holder must notify the Fish and Wildlife Branch (email: Nurie-Aliperti@gov.bc.ca) and the Conservation Officer Service (email contact: Inspector Chris Doyle: Chris.Doyle@gov.bc.ca; phone (not for wide spread distribution) 604-892-7823) the details pertaining to locations and times for transporting and locations and times for commercial filming.
- 11. On demand of an officer under the Wildlife Act, the permit holder must allow an officer safe and secure access to inspect the containment of the CAS species individual that is the subject of this permit during times of transport, housing and filming.
- 12. The permit holder must ensure that the CAS individual named on this permit is under the control of a qualified animal wrangler when the CAS individual is out of its enclosure for commercial filming.

- The permit holder must immediately notify the Fish and Wildlife Branch (email: <u>FishandWildlife@gov.bc.ca</u> or <u>ControlledAlienSpecies@gov.bc.ca</u>; fax: 250-387-0239) should a CAS individual cause harm to any person or animal.
- 14. The permit holder must ensure that no CAS individual is released or escapes.
- 15. The permit holder must immediately notify the Conservation Officer Service (1-877-952-7277) or the Ministry of Forests, Lands and Natural Resource Operations, Fish and Wildlife Branch Regional Manager if a CAS individual escapes or is released.
- 16. The permit holder is responsible for all costs associated with the keeping and care of the CAS, and any damage, loss or injury to persons or property caused by the CAS.
- 17. The following applies to each CAS individual and the term "described" means "described in the attached detailed enclosure description applicable to the taxonomic group to which the CAS individual belongs." e.g. a detailed enclosure description for Pythonidae applies to each CAS individual that is a member of the Family Pythonidae.

The permit holder must do the described things, including, without limitation, the following:

- (a) keep the CAS individual only in an enclosure
 - made of materials described,
 - constructed in the described way.
 - padlocked in the described way, and
 - which includes the described elements;
- (b) while the CAS individual's enclosure is being cleaned
 - move the CAS individual to the described secure area, and
 - take the described security measures;
- (c) maintain the described features in the CAS individual's enclosure in the described way, and
- (d) keep no more than one CAS individual in the described enclosure unless the detailed enclosure description provides for a greater number, in which case, no more than that number.

The permit holder may depart from the strict observance of a specific requirement in this paragraph by substituting an alternate measure, but only if that alternate measure will clearly result in persons and animals being no less safe than if the specific requirement had been strictly observed.

18. The following applies to each CAS individual and the term "described" means "described in the attached public safety plan applicable to the taxonomic group to which the CAS individual belongs." e.g. a public safety plan for Pythonidae applies to each CAS individual that is a member of the Family Pythonidae.

The permit holder must do the described things, including, without limitation, the following:

- (a) not allow the CAS individual to come into contact with people except in the described way;
- (b) ensure in the described way the safety of those that come into contact with the CAS individual;
- (c) in the described way, prevent the CAS individual from escaping or coming into unintended contact with other people;
- (d) if the CAS individual escapes, notify others in the described way and recapture it in the described way;
- (e) if the CAS individual is transported.
 - transport it only in the described way,
 - · transfer it to its transport container only in the described way, and
 - follow the described emergency plan if it escapes during transport
- (f) if the CAS individual is being transported into or from BC, transport it into or from BC only in the described way.

Application of this Act to controlled allen species

6.6 (1) Sections 3, 82 (4), 89, 93, 94 (1), 95 and 107 (2) apply in relation to controlled alien species as if those species were wildlife.

Release or escape of animals

- 77 (1) A person who releases or abandons an animal or from whose captivity an animal escapes
 - (a) is, despite section 11 (4) of the *Livestock Act*, liable to the government for loss or damage to wildlife or wildlife habitat caused by the animal, and for all costs incurred by the government in pursuing, recovering, holding or destroying it, and
 - (b) is not entitled to any compensation from the government if the animal is destroyed under section 79
 - (2) If a person releases or abandons an animal, other than a domestic animal, the person commits an offence.
 - (3) If an animal, other than a domestic animal, escapes from the possession of a person, the person commits an offence if he or she fails to make every reasonable effort to recover the animal.
 - (4) This section does not apply if the person is authorized by the regional manager to release the animal.

Destruction of animals

79 (1) An officer may kill an animal, other than a domestic animal, that is at large and is likely to harm persons, property, wildlife or wildlife habitat.

Documents not transferable

- 81 Except as authorized by regulation or as otherwise provided under this Act, a licence, permit or limited entry hunting authorization is not transferable, and a person commits an offence if the person
 - (a) allows his or her licence, permit or limited entry hunting authorization to be used by another person, or
 - (b) uses another person's licence, permit or limited entry hunting authorization.

Failure to pay fine

- 85 (1) This section applies if a person
 - (a) fails to pay, within the time required by law, a fine imposed as a result of the person's conviction for an offence under this Act or the *Firearm Act*, and
 - (b) has been served with notice of this section.
 - (2) In the circumstances referred to in subsection (1),
 - (a) the person's right to apply for or obtain a licence, permit or limited entry hunting authorization under this Act is suspended immediately and automatically on the failure to pay the fine,
 - (b) all licences, permits and limited entry hunting authorizations issued to that person under this Act are cancelled immediately and automatically on the failure to pay the fine, and
 - (c) the person commits an offence if, before that fine is paid, the person
 - (i) applies for, or in any way obtains, a licence, permit or limited entry hunting authorization under this Act. or
 - (ii)does anything for which a licence, permit or limited entry hunting authorization under this Act is required.

Entering premises

- 89 (1) For the purpose of ensuring that this Act and the regulations are being complied with, an officer may enter and inspect any premises or enclosure in which live wildlife or live fish is kept but, at the request of the owner or occupier, the officer must produce proof of identity.
 - (2) Despite the *Trespass Act*, an officer exercising duties under this Act may enter any land, whether enclosed or not but, at the request of the owner or occupier of the land, the officer must produce proof of identity.

Production of licence or permit

- 97 If a person who is required to hold a licence, permit or limited entry hunting authorization issued under this Act
 - (a) fails to produce it for inspection to an officer on request, or
 - (b) fails or refuses to state his or her name and address to an officer on request,

the person commits an offence.

REGULATIONS

Here are some, but not all, relevant excerpts from the Controlled Alien Species Regulation made under the Wildlife Act:

Possession

3 A person must not possess a prohibited species individual unless the person holds a permit authorizing the possession of that prohibited species individual.

Breeding

- 4 (1) Subject to subsection (2), a person who possesses a prohibited species individual must prevent the prohibited species individual from breeding.
 - (2) A person who possesses a prohibited species individual referred to in subsection (1) may allow the prohibited species individual to breed if
 - (a) the person operates a zoo or is an educational or research institution,
 - (b) the person holds a permit authorizing the person to allow that prohibited species individual to breed, and
 - (c) the breeding is in accordance with a management plan approved by a regional manager.

Release prohibited

5 A person must not release a restricted species individual or a prohibited species individual or allow a restricted species individual or a prohibited species individual to be released.

Shipping or transportation

5.1 A person must not ship or transport in British Columbia a prohibited species individual unless the person holds a permit authorizing the shipping or transportation of the prohibited species individual.

This excerpt from the Permit Regulation, made under the Wildlife Act, is relevant:

8 A person who holds a permit under the Act or the Permit Regulation commits an offence if he or she fails to comply with a term of the permit.

ADDENDUM TO APPENDIX 2 - PUBLIC SAFETY PLAN

Additional details regarding transport and containment (as provided by the permit holder to the Fish and Wildlife Branch on February 22, 2016 and February 24, 2016):

There are no other animals on the set other than Jean Cardinal's tiger. There are no other animals being housed with this tiger at the offset housing.

The tiger is loaded in a cube van truck to travel in this travel cage from the Cinezoo to Dorval Airport then onto Air Canada. The flight time is 4 hours and 23 minutes – animals are not allowed to fly over 5 hours. This flight will be direct from Dorval to Vancouver.

Jean Cardinal's assistant trainers will fly out to Vancouver in advance to meet the tiger when he arrives. The tiger is the last freight loaded on the plane and the first offloaded. The tiger will be offloaded into an enclosed trailer with double locks. Another trainer who possesses the permit of a shotgun and tranquilizer dart gun will be added to the delivery of the tiger from the airport to the off-set housing location (6566 Bradner Road, Abbotsford).

The tiger will be transferred to a much larger enclosure while at the offset housing and exercised every morning and evening. The tiger will also have a large cage to move to the movie set and to relax in during filming. The cage to travel in is an approved IATA cage. There will be 24 hour security on the tiger wherever he goes.

The tiger will be moved in the same trailer that he is picked up in from the plane. It is 24 feet long and 8'6" in width and the tiger will have circulation vents in the roof. This trailer will accommodate a large cage to bring the animal to set. The cage contains a built in water supply. Jean Cardinal has flown this animal to other shows and sets.

The housing of the tiger will be in a large cage to transport him to the set inside the enclosed trailer. Once at the set, the tiger truck and trailer will be brought into the compound where we are going to film. The compound where the filming takes place is a 10 foot steel fence. The interior of the compound will have a hot wire within which the tiger will work. No one except trainers will be allowed into the compound.

The tiger will be transported in a cage in an enclosed trailer with double locks. There will be four trainers with the trailer and one American Humane Association officer with the trailer.

A safety trailer contains electric fence, bear spray, CO2 fire extinguisher. Canes, ropes and heavy duty leashes are available and used if needed. The tiger is in a double contained holding at the set, inside a hot wire which is inside a 10 foot high steel mesh fence.

The tiger will be removed from the trailer and walked on a leash by two trainers from Point A to Point B, where the tiger will work. Then the tiger will be allowed to work free from Point A to Point B, but a cable leash is still attached to his collar while working free. There will be veterinarian present at the film location at all times. There is also two City of Vancouver police officers present all day during filming.

Should the tiger escape, there are two police officers, one trainer licensed with a shotgun. The tranquiller gun is loaded with a combination of ketaset and rompen.

We will be contacting the Conservation Officer Service (COS) to monitor everything we are doing when the tiger arrives. The transport routes and schedules would be relayed to the COS.
