





ISSUE: Next steps for the *Heritage Conservation Act* burial policy review

BACKGROUND:

Given the recent situation concerning Grace Islet and the intersection of First Nations social, cultural and heritage interests with private property rights in British Columbia, a review of the burial sites policies under the *Heritage Conservation Act* (HCA) was undertaken. The review resulted in nine (9) recommendations which have been presented for consideration to executive within the Minister of Forests, Lands and Natural Resource Operations. For context, the Executive Summary of this review may be found in **Appendix 1**.

For reference, since 1994, the Archaeology Branch has issued 3,003 Alteration Permits and there have only been six (6) instances where the Province has not been able to resolve conflict through other means and instead have had to enter negotiations to purchase a parcel of private property – since 1994, 99.9% of cases where alteration permits have been issued they have managed successfully and only 0.2% of situations have required financial settlements.

ISSUE: Next steps for the *Heritage Conservation Act* Burial Policy review

BACKGROUND:

Given the recent situation concerning Grace Islet and the intersection of First Nations social, cultural and heritage interests with private property rights in British Columbia, a review of the burial sites policies under the *Heritage Conservation Act* (HCA) was undertaken. The review resulted in nine (9) recommendations which have been presented for consideration to executive within the Minister of Forests, Lands and Natural Resource Operations. For context, the Executive Summary of this review may be found in **Appendix 1**.

For reference, since 1994, the Archaeology Branch has issued 3,003 Alteration Permits and there have only been six (6) instances where the Province has not been able to resolve conflict through other means and instead have had to enter negotiations to purchase a parcel of private property – since 1994, 99.9% of cases where alteration permits have been issued they have managed successfully and only 0.002% of situations have required financial settlements.

Appendix 1

Executive Summary of internal review of the Heritage Conservation Act Burial Policy

Overview

British Columbia is home to 706 archaeological sites known to contain human remains of First Nations peoples. A majority of these sites are concentrated around the south coast of the Province. As development on private property in the province increases, these sites are being impacted with increasing regularity. These sites are protected under the *Heritage Conservation Act*, which requires property owners to go through a permitting process to ensure that development minimizes impacts to the sites to the greatest extent possible. Archaeology Branch staff utilize a number of mitigation tools to manage development within this context, and mediate agreements between landowners and First Nations. However, in some cases development on property is not feasible without substantially damaging the site, potentially justifying intervention by the Province to negotiate the purchase of property in order to ensure its continued protection.

While the Province has not been required to purchase properties in very many cases (12 properties have been purchased since 1976), all twelve purchases had the same underlying elements:

- Significant burial sites covering a substantial portion of the property
- High media profile and increasing public involvement
- Challenging relationships with stakeholders and First Nations
- Incremental costs of development continuing to accrue until a negotiating mandate was approved

The most recent case involving Grace Islet resulted in a commitment by the Minister of Forests, Lands and Natural Resource Operations to undertake a review of the Archaeology Branch's policies and procedures as they relate to the protection and management of First Nations burial sites.

As a result of the analysis undertaken, it is recommended that a number of policies and processes be developed to enable an effective decision-making framework for staff to identify those key sites that require provincial intervention at an early stage, in order to ensure protection of the site and manage costs and risk to the Province. As well, additional capacity for the Branch is proposed to enable the Archaeology Branch to undertake the necessary engagement and education activities with stakeholders, and manage communications on an ongoing basis.
