



Re: Annual overview referral for tenures expiring between April 1, 2012 and March 31, 2013

The purpose of this letter is to provide you with information pertaining to tenures expiring between April 1, 2012 and March 31, 2013. Please find enclosed with this letter a spreadsheet listing all potential replacement applications expiring in the coming year within the FIRST NATION'S traditional territory and a map showing their shapes and locations.

As the expiry date of a *Land Act* tenure approaches, the Ministry of Forests, Lands and Natural Resource Operations (FLNR) reviews the tenure file and considers it for replacement/renewal. Effective June 1st, 2008 FLNR has been consulting with First Nations on replacement applications. The intent of the information provided with this letter is to give the FIRST NATION a preliminary view of *Land Act* tenures expiring within your traditional territory between April 1, 2012 and March 31, 2013. This preliminary referral should enable you to identify replacement files of concern needing immediate attention, but also files where you feel that no further consultation is required. It is also important to note that some of the current tenure holders will not be replacing their tenures; the list provided to you is meant to show *potential* replacement applications.

Please note that this referral is considered a preliminary overview of replacement applications. As the expiry date of each replacement file approaches you will also receive a file specific referral package, unless you have advised our office that additional consultation is not required. The referral package will be similar to the one you receive for new applications; it will provide detailed information regarding the expiring tenure and a 45 day comment period will be applied.

Your referral responses are a valuable source of information that assists FLNR in our assessment of Crown land applications and we would like to thank you for the time and effort you dedicate to them.
