# Forest sector competitiveness agenda summary of actions

Key competitiveness actions include:

## Value Added Sector Action Plan

The value-added sub-sector includes innovative and entrepreneurial companies throughout British Columbia. In 2012, B.C. had 589 value-added businesses, and provided close to 12,500 full-time jobs, with estimated sales of \$2.8 billion.

As part of its focus on competitiveness, the B.C. government undertook a value-added review which involved BC Wood, the Independent Wood Processors Association, Forestry Innovation Investment Ltd., FPInnovations and the ministries of Forests, Lands and Natural Resource Operations; Jobs, Tourism and Skills Training; and International Trade.

Recommended actions to rebuild and improve the value-added sector, and position it for the future include:

- Establish a pilot program to improve access to the U.S. market for new, small value-added exporters that don't have a lot of experience. Forestry Innovation Investment Ltd. is providing \$200,000 to assess existing export programs and what additional activities may be of assistance to the sector.
- Pursue opportunities through provincial and federal programs to address labour and training issues impacting the value-added sector.

## B.C. Pulp and Paper Sustainability: Sector Challenges and Future Opportunities

The pulp and paper industry directly supports 12,000 well-paying jobs in B.C., and supports smaller communities by purchasing goods and services and through municipal taxes. It is a major producer of bioenergy in North America, and offers a value-added product from residual chips, shavings and sawdust from sawmills.

The B.C. Pulp and Paper Sustainability Project, part of the forest sector competitiveness agenda, was led by a working group with members from all nine of the province's pulp and paper companies, key B.C. government ministries, FPInnovations and the UBC Pulp and Paper Centre.

## **Forest Fibre Action Plan**

Released in September 2015, the Forest Fibre Action Plan focuses on increasing efficient utilization of lower-quality wood and increased access to wood residue for secondary users, including the wood bioenergy sector and other non-lumber manufacturers, such as pulp and paper and oriented strandboard. Key actions include:

- Implementation of protocols for primary and secondary harvesters to ensure the efficient removal of residual fibre.
- Development and implementation of biomass handling guidelines for forest planners and machine operators to support integrated planning and harvesting operations.
- Commitment to continuous improvement on policies related to residual forestry licence to cut and fibre supply licence to cut to ensure tenures are working effectively.

The Ministry of Forest Lands and Natural Resource Operations has developed a comprehensive agenda aimed at addressing current and future challenges in B.C.'s forest industry.

Called Strong Past, Bright Future: A Competitiveness Agenda for B.C.'s Forest Sector, this document outlines actions the government is taking and will be taking to improve the industry's competitive position by maximizing the value of B.C's forest and tapping into innovative solutions.

The document is built around three key inter-related goals—healthy resilient forests, a diverse globally competitive industry, and stable communities and First Nations partnerships. Each one of these goals depends on the other to realize its full potential.

Some of the challenges facing B.C. forest industry include:

- Reduced timber supply in the wake of the pine beetle epidemic
- Rising log-hauling costs due to shift in location of marketable timber
- Increased international competition, changing world markets trade barriers that hinder market growth.

Government's plan for addressing these and other challenges focuses on:

# **BCTS Performance Metrics**

- · High level: BCTS just under targets, but Majors harvest down significantly.
- BCTS is going to substantially achieve its 2015/16 Volume Sold target of 13.3 million m<sup>3</sup>.
- However, BCTS Volume Sold on the coast is behind its target, primarily as a result of the Strait of Georgia Business Area projecting to sell about 20% less than their target of 1.43 million m³ due to First Nations objectives and aspirations.
- Coast harvest for major licensees to the end of February 2016 is down from previous years
  and the ministry forecast for 2015/16 has dropped from 11.8 million m<sup>3</sup> for majors and other
  licenses (not including BCTS) to 10.8 million m<sup>3</sup>, the lowest level in the past five years.
- On the Coast a total of approximately 3.6 million m<sup>3</sup> of unharvested timber is available under existing (sold) Timber Sale Licences.

- The AAC linked to these areas was administratively set when the Pacific TSA was established and BCTS' long-standing contention is that the AAC wasn't sustainable.
- BCTS initiated a TSR in 2014 and that work is well-advanced (data package is now complete
  and out for public review) and staff continues to provide CFPA with meaningful

# Uncut Policy including 10 year cut control

Existing Unharvested Volume (Undercut, Uncut) Policy:

- Forest Act (section 75.8) requires that unharvested volumes within a TFL be returned to the Crown and allows government to issue new tenures from that volume.
- There is no legal requirement to make any unharvested volume available for issuance under other forms of agreement.
- Current policy allows REDs to make unharvested volume disposition decisions.

#### **TFL 19**

- Approximately 1.38 million m<sup>3</sup> of undercut are currently available for potential disposition in Tree Farm Licence (TFL) 19, held by Western Forest Products (Western).
- The Ehattesaht Supreme Court decision that consultation was owing, and the province needed to consider the economic interest of the First Nation re: undercut.
- Consultation has recently been completed with the EFN and the Mowachaht/Muchalaht First Nation, both of whom have asserted traditional territory overlapping the TFL.
- Western was also consulted and raised concerns about the impact of the decision to their tenure.
- The decision to dispose of the undercut volume is expected to be made soon.

Our groups are disappointed to learn that industry (CFPA, Teal Jones) rejected our invitation to conduct a field visit to the Central Walbran Valley for the purpose of discussing our common interests and strengthening conversations about future management in the area. We are therefore uncertain about what this situation means to future shared talks for moving forward.

We are conscious that we have opposing views for the future management of the Walbran SMZ, especially the 486 hectare Central Walbran area. However the Walbran Valley is a too important a rainforest ecosystem to not conduct a dialogue. We feel our parties have a collective responsibility to work towards a shared assessment of the ecological, economic and cultural values in this area for the long term.

We would like to reiterate our proposal of early April to continue the dialogue. As a suggestion we propose Thursday, May 26, 9:30 - 12:00 am in Victoria for a face-to-face-meeting.

As our efforts to raise awareness about the lack of protection for endangered old-growth rainforest on Vancouver Island continue we are focusing on the facts and highlighting solution options. In the meantime we have put on hold the specific activities that we were requested to refrain from, for example Wilderness Committee's Walbran Wednesday.

In December, Teal Jones stated publicly that their company has "no immediate plans to harvest block 4424, nor are there immediate plans to proceed with other cut blocks within "the bite". We assume the bite is a reference to the unprotected, intact 486 hectares area 'north of the river' including the Castle Grove area. As we acknowledged at the time this commitment was a good step into the right direction that allows time to explore solutions and we thank Teal Jones for this initiative. Given the current situation we would appreciate clarification knowing for how long this statement remains valid. We believe a solution space until at least April 30, 2017 would be helpful to allow a positive conversation for the future management of the Walbran.

We look forward to hearing from you and continuing this important dialogue.

First Impression

**Q415 results slightly better than expected –** Potlatch reported adjusted EBiTDA was \$23MM, above our forecast of \$22MM and consensus of \$19MM. The company generated adjusted EPS of \$0.09 in Q415 compared to our estimate of \$0.02 and consensus of \$0.05.

Resource EBITDA down 18% y/y – Timberlands contributed \$23.6MM of EBITDA in Q4. In the Northern region, total fee harvest volumes were down 8.6% y/y, with sawlog volumes dropping by 8.9% y/y and pulpwood volumes 5.0% lower. In the Southern region, total fee harvest volumes were 41.9% higher than a year ago, with sawlog volumes increasing 6.5% y/y and pulpwood volumes 39.2% higher. Log Lines reported a 11.1% y/y decline (+0.9% q/q) in average delivered prices for Douglas-fir #2 logs in the PNW in Q415. Timber Mart-South pine saw timber prices fall 2.8% y/y in Q415. (+0.5% q/q) and pulpwood prices declined 3.9% y/y (+2.4% q/q). Potlatch noted that its Northern sawlog realizations were 10% lower q/q (-10% y/y) while pulpwood prices rose 2% q/q (-5% y/y). The company's Southern sawlog realizations declined 11% q/q (-13% y/y) due to a lower mix of hardwood logs, while its Southern pulpwood prices were down 3% compared to the prior quarter (-6% y/y).

Real Estate EBITDA flat y/y - Real Estate generated \$6.3MM, unchanged y/y. Potlatch saw a QoQ decline in Q415 due to the timing of sales.

Wood Products EBITDA down \$10MM y/y – The lumber/plywood business contributed \$0.6MM in EBITDA with revenues declining by 9.8% y/y. Lumber realizations declined by 19.6% y/y (vs. 15.2% for RL Composite) while lumber shipments were 5.7% higher. Mgmt cited lower lumber prices compared to Q3, down 6% q/q, partially offset by a 6% increase in shipments.

Management outlook – For Timberlands in Q116, Potlatch expects to harvest 850K-875K tons, with slightly more than half the volume in the North. Sawlog mix in the first quarter is expected to be ~90% in Northern Resources and ~45% in the South. Sawlog prices are guided for down in both regions, with wetter logs in the North impacting prices by 5%-10% and a lower mix of hardwood in the South. Mgmt expects lumber shipments to remain flat q/q with prices up 5% in Q1. Real Estate is guided to sell 20K-25K acres in 2016 (land basis of ~35%—40%). Overall Capex guidance for 2016 is \$19MM.

As you can appreciate, the hot dry weather continues to elevate the forest fire danger on the Coast and in our Tree Farm Licence 46 (TFL 46). Our company has been particularly hard hit by the recent wildfires including the current fire on TFL 46 at Lizard Lake and also the Woods Lake fire located at our West Harrison Operating Area. The Wildfire Branch has reported that both of these fires were caused by the negligence of humans recreating within our forest tenure areas.

It is our understanding that the Friends of Carmannah/Walbran are planning a rally at the Walbran Valley on Saturday August 22 with the potential for a large crowd. As this area is within TFL 46, we are concerned that another forest fire may start due to the public's negligence. A fire would not only stretch the Wildfire Branch's resources to extinguish the fire, but also destroy timber that our company is depending on in the near future to fulfil our customer's needs.

We are requesting that you designate TFL 46 a specified area under Section 11 of the Wildfire Act that restricts access to only authorized personnel while the risk to fire is high.
