Thank you for your letter of August 8, 2017, regarding telecommunications infrastructure in areas impacted by wildfires in our province. My colleague, Jennifer Rice, Parliamentary Secretary for Emergency Preparedness to the Minister of Public Safety and Solicitor General, has asked me to respond to your letter.

More than ever, we have seen how critical it is to have reliable connectivity, especially during this unprecedented wildfire season. Connectivity allows for instant communication and necessary resources for emergency responders such as GPS mapping, image sharing and natural disaster monitoring. This is especially true for first responders and workers on the front lines and for citizens and businesses affected by the wildfires.

I would like to address your comment regarding temporary tower infrastructure in wildfire areas. My staff contacted TELUS on this matter and the company confirmed that they have not installed any temporary telecommunications infrastructure in areas affected by wildfires in B.C. My staff also contacted the BC Wildfire Service situated in the Ministry of Forests, Lands, Natural Resource Operations and Rural Development, which has installed temporary telecommunications towers to boost existing cellular signals to support forestry personnel working in the area. The mobile cellular towers are designed and built for disaster mitigation and not for permanent placement.

Connectivity is a powerful socio-economic driver that supports the delivery of accessible and responsive services that citizens count on. The Province relies on the private sector to provide internet and cellular services throughout British Columbia. Telecommunications companies are

regulated federally by the Canadian Radio-Television and Telecommunications Commission (CRTC), therefore, the Province cannot compel internet service providers where to make their investments and provide their services. My ministry does, however, work with internet service providers and other levels of government to address the Province's goal of achieving high-speed internet access to all British Columbians. We support programs to incent internet service providers to expand infrastructure and services into areas where companies would otherwise find it difficult to establish a business case.

- Connecting British Columbia Program. Through funding from the Province, the program
 helps pay for infrastructure required to deliver high-speed internet connectivity to rural and
 remote areas of the province. More information is available at this link:

- BC Broadband Satellite Initiative (BCBSI). Citizens who live in remote areas can get high-speed Internet through satellite service. The BCBSI helps offset the one-time satellite installation fee for residents in areas of B.C. where there are no other options. I also want to make you aware of a program launched on August 14, 2017, to assist small businesses, First Nations and not-for-profit organizations located in areas that have been under evacuation order or alert.

I would like to raise with you concerns about access to fibre from Fulida Holdings, the owners of Neucel, the specialty cellulose mill in Port Alice.

As you are most likely well aware, the mill – which was long an economic anchor for the North Island – has not been operating for more than two years. Fulida has been working on strategies to reopen but it will take significant resources: an estimated \$485m is needed for capital investment in the century-old mill to make it viable. However, Fulida does have a Chinese, state-owned, enterprise potentially willing to make that investment.

One of the main roadblocks in moving forward is the access to fibre. The mill would need approximately 1.2 million cubic metres for continual supply. The investor would like to be able to secure some form of long term agreement to guarantee that supply.

I would like to request a meeting with you and officials from Fulida to discuss potential options. The investment in refurbishing and the opportunity to restart the mill would have a significant impact on the North Island, and indeed BC's, economy.

I very much look forward to hearing from you.

I would like to thank you for meeting with me earlier this afternoon to discuss the important issue of information sharing with those affected by the Elephant Hill wildfire in Pressy Lake. I share your commitment that all those impacted by the wildfire in Pressy Lake receive the information they need to help them begin to recover from the disaster.

We recognize that those who have suffered devastating losses as the result of the wildfires in the Pressy Lake and Elephant Hill areas need support and staff from my ministry. To that end, the Ministry of Forests, Lands, Natural Resource Operations and Rural Development (FLNRO) has made it a priority to identify and expedite the release of information of interest to the residents of Pressy Lake. These efforts have included careful consideration of the privacy protections included within the *Freedom of Information and Protection of Privacy Act* (FOIPPA). Government staff have also been working to maximize and expedite the release of information while preserving the integrity of routine and ongoing fire investigations.

We understand that those who have suffered devastating losses as the result of these wildfires may need access to information as soon as possible in order to rebuild. Staff at FLNRO had already begun the process of providing a preliminary release of information on the Pressy Lake wildfire to residents and property owners as early as Friday, September 29th. FLNRO will continue to provide important materials proactively in order to ensure residents have the information they need. All records released will meet the legal standards of the *Freedom of Information and Protection of Privacy Act* so that personal privacy is never compromised. In all cases, government will seek to expedite and maximize the release of available information while streamlining our services to those in need.

Dear Minister Donaldson,

I write today to ask for your assistance on a serious matter of public interest regarding the restriction of access to the backcountry on Vancouver Island and most specifically in my constituency of Mid Island-Pacific Rim.

Private Managed Forest Land Companies are erecting and locking gates, hiring security and preventing access to the backcountry that has been available for generations. These restrictions include limiting and controlling the public's access to provincial and regional parks, camping sites, and recreational areas. I am receiving reports of company security purposely locking the public behind the gates with constituents having to pay up to 150 dollars to get the gate unlocked. Constituents are stuck waiting behind the gate until it is unlocked, which can cause serious issues if a medical emergency was to arise. This is certainly escalating tensions and the public patience is wearing thin.

In 2004, 10s of thousands of hectares of forest lands were removed from TFL 44 and given to Weyerhaeuser with few stipulations. One of those stipulations was that traditionally used roads and access were to be kept open to the public. Current actions of restricting public access by these companies are in direct defiance of the conditions stipulated.

Last year 100s of individuals from all over Vancouver Island came to a rally to express their concern and anger over losing their way of life and recreational business opportunities.

We need to enforce the agreed-to-conditions and ensure that the public are allowed access to their provincial and regional parks, camping sites, and recreational areas.

Thank you in advance for addressing this important issue.

Dear Ministers Donaldson and Fraser,

In an effort to increase engagement with our constituents and other governments within the North Coast riding, my office has reached out to coastal First Nations informing them of the New Democrat government's proposed ban on the grizzly bear trophy hunt and ending the grizzly bear hunt within the Great Bear Forest.

The feedback my office received from Kelly Brown, director of the Heiltsuk Integrated Resource Management Department (HIRMD), the stewardship arm of the Heiltsuk Nation, is a recommendation to contact the HIRMD office to arrange face to face/government to government discussions on this important matter. My interpretation is that submitting comments online will not suffice for an issue so important to the Heiltsuk people.

Considering the extensive work the Heiltsuk and other coastal First Nations have done on the grizzly bear trophy hunt and in the spirit of moving forward with a new relationship with Indigenous people it is, in my view, worth considering engaging Indigenous people and Indigenous leaders in a markedly different and much more respectful way.
