Thompson Habitat Officer Terms and Conditions

The following Terms and Conditions are provided pursuant to 39 (1) of the *Water SustainabilityAct* Regulation, and are only in effect for extenuating circumstances related to flooding, or potential flooding.

The intent of this document is to provide the applicant the opportunity to clear an obstruction, or pending obstruction, from a culvert or bridge during a flood event, or an impending flood event, when there exists a potential danger to life or prope ty. The applicant is required to submit a plan, in accordance with a Notification application, either prior to initiating works, or within 24 hours of works being initiated. The application is at the following site:

Damage to the environment, beyond that accounted for in the Terms and Conditions, must be remediated within 6 months from when the works occurred, and reported to the Habitat Officer within 72 hours from when the damage occurred.

- 1. Debris removed from the stream channel is to be placed above the high water mark, such that it will not be reintroduced into the stream, and will not result in sediment delivery into the stream;
- 2. Minimize the disturbance to riparian vegetation; and
- 3. Restore denuded lands such that they do not contribute to sediment delivery to the stream within 6 months of the work.

I have attached a KMZ showing the location of the slide and also a clip from Google Earth of the location off the Munro FSR and the proposed channel relocation. I have also attached 2 photos of the slide.

I am confirming your phone call this afternoon advising that the channel relocation work can commence tomorrow morning, March 29th. A contractor will be onsite at 0800 tomorrow morning to start work. The relocation should take about 2 days to complete. I will be onsite on Thursday for the opening of the new channel. Suzan Lapp will be on site tomorrow to assist the contractor with site clearing and stripping. A Geotech consultant, engaged by Gorman Bros. Lumber will also be onsite tomorrow as will staff from Gorman Bros. Lumber that holds the current road permit.

The new channel will be approximately 75 m long by 4 m wide and will mostly follow an old high water channel that is located north of the toe of the slide. The channel will be constructed in the dry and flow will be introduced gradually to minimize sedimentation. The District of Peach will be kept informed as the work proceeds.

We will submit a Notification as you requested after the restoration work is completed.



While the District of Lake Country may have been in contact with "the Ministry" on some projects, there is a legal requirement under the *Water Sustainability Act* for the local government to notify a Habitat Officer within 72 hours of completing the works. Financial authorization through EMBC is not the same as the legal requirement to do the works under the WSA. As far as I am aware, the District of Lake Country has not yet notified a Habitat Officer (someone in my Ecosystems section); I do not have any information on any of the projects mentioned below.

Do you have a timeframe for the post-event assessments? While that information will likely answer some of the questions from my end, an initial description/photos of all projects using the supplied forms should be submitted as soon as possible. Specifically, for shoreline protection projects (riprap) please confirm that the size/shape of the installed riprap rock armouring is appropriate as determined by an engineer. Please provide the design specifications if you have them. Also confirm that the rock used is not acid-generating (leach test). There may be additional information requirements identified during our review.

Please let me know if you have any questions.

I'm writing this email on behalf of the District of Lake Country. The District has appointed me to carry out flood damage recovery following this past spring's storm events.

The District of Lake Country recently received that attached Ministry documents from Chelsea Smith.

In looking through documents and correspondence, although the District did notify the Ministry on the larger Flood Response Projects, it appears that the District may have missed notifying your Ministry of some of the minor works carried out in relation to flooding.

These works are:

- 1. Fourth Street Beach Access shoreline protection and Pixton Road shoreline protection and
- 2. Okanagan Lake Pumphouse structural protection

For these three initiatives, rock was placed to prevent high water and wave action deterioration of District infrastructure. The District is in the process of carrying out post- event assessments of these works under the Province's EAF program.

Is the Ministry requiring the 72 hour reporting at this late date or would it be preferable to submit them with the post- event assessments once they have been completed?

Hello,
2017 was a record year for flooding in the Okanagan. In response to this historic event, local governments throughout the Okanagan constructed berms, placed erosion protection works, dredged streams and removed debris to protect public safety and infrastructure. You are a receiving this email because you may have been involved in your local government's emergency response to flooding. If you are aware of additional contacts in the local government please forward on this message to their attention.
Under the Water Sustainability Regulation, local governments are authorized to do certain emergency works in and about a stream (includes lakes). As part of this authorization, local governments are required to report all works to a Habitat Officer within 72 hours. This is a legal requirement whether the works were authorized and/or funded by Emergency Management BC (EMBC) or completed using local government resources.
Now that the flood threat is reduced, I am following up with local governments to ensure that all reporting requirements are met. Please find attached guidance that was developed a few years ago and also disseminated through CTL PREOC this year. Please send the completed forms to the Habitat Officer identified in the guidance document for your area. The Habitat Officer will be reviewing the works and may follow up with additional terms once water levels recede. Also attached is a flood emergency works and recovery fact sheet for local governments.
To assist in meeting reporting requirements, the Ecosystems and Water staff may be able to participate in site visits to verify site conditions and provide recommendations. If you are interested in this option, please let me know so that I can schedule a site visit. I anticipate a half to full day, with your staff providing a tour of completed emergency works. Please be prepared to provide as much information as possible on the works (i.e., when and how works were completed, engineering/design considerations, environmental considerations, best practices employed, equipment/materials used).
If you are not interested in site visits, then I look forward to your submission of the reporting forms as soon as possible.

Under the Water Sustainability Regulation (B.C. Reg. 36/2016), local governments are authorized to construct or place erosion protection works or flood protection works during a flooding emergency. As per Section 38(5) of this regulation, local governments who do such works must (a) report the authorized change to a Habitat Officer within 72 hours after making the change, and (b) comply with the terms and conditions, if any, specified by a habitat officer for the protection of an aquatic ecosystem. As the Habitat Officer responsible for your area, I have reviewed the following reported emergency works for 2017:

- Culvert replacement on unnamed stream at Barkley Road (subsequently submitted under Water Sustainability Act file No. R8003946)
- Erosion protection (rip rap) placement along 300 m section on shoreline along Pixton Road to protect hydro poles and roadway
- Erosion protection (rip rap) placement along 10 m section on shoreline to protect Okanagan Lake pump house
- Erosion protection (rip rap) placement along 7 m section on shoreline to protect
 4th Street walking trail and boat launch

I provide the following terms and conditions related to the completed emergency works:

- Any materials, such as rip rap or gabion rock, placed within the stream must not contain substances (e.g., acid-generating rock) that could be harmful to fish, wildlife or aquatic ecosystems
- Any areas that were disturbed as part of the works must be promptly restored and any soil exposed at the worksite must be promptly revegetated; any remediation requiring changes in and about a stream will require authorization under the *Water Sustainability Act* (WSA)

Regarding the erosion protection (rip rap) described above it is recognized that these emergency works may have been constructed without either design or supervision by a suitably qualified Professional Engineer and as such may **not** provide adequate erosion protection for future flood events. As these emergency works provide at least some degree of protection against further erosion, and if the terms and conditions described above are followed, they may stay in place. Any improvements or upgrades to these emergency works will require authorization under the WSA. Application to obtain authority under the WSA can be made through FrontCounter BC².

As 2017 was an exceptional year for flooding, we recognize that local governments may not have been able to report all works within the legislated time frame. For future flood events, be sure to follow the guidance provided in the document *Emergency Works Guidance for Local Government, Thompson Okanagan Region* and, where possible, the provincial best management practices (BMP) for instream works³. Please contact me if you require a copy of these documents. It is the proponent's responsibility to ensure their activities are in compliance with all legislation, including the *Wildlife Act* and the *Fisheries Act*, as well as with local government bylaws and regulations. 


Figure 1. Peachland Creek Slide location off Munro FSR at ~2 km - date of slide - March 28, 2017
