This is Minister XX. I am joined by XXXX. I'm calling to speak with you directly about our government's decision on Site C.

I'm calling to tell you directly about the decision the government has just made on Site C. It may not be the decision you expected or wanted, but as you know, we made the decision to proceed with Site C.

This was a very difficult and complex decision, the toughest decision our government has faced to date. The views you [and your organization] presented were seriously considered by me and my cabinet colleagues.

Our campaign commitment was to send Site C to the BC Utilities Commission - something which should have always been done by the previous government.

Although Site C is not a project we favoured, and not a project we would have built, our government has made the decision to complete the project.

I know this decision comes as a disappointment to you [pause to allow for a response, take time to hear out the concerns].

I know you campaigned vigorously against Site C. I respect and honour your commitment to our province and to the Peace River Valley. The concerns you raised have been heard and respected.

In making this decision, we were determined to make the most of the situation.

Our government has a bold agenda on addressing climate change, pursuing reconciliation....and you are an important partner in those initiatives.

So, while we may have to agree to disagree on this issue, I want you to know that my door is always open to you as we continue to work together.
