Dear Mr. Doug Donaldson,

It has been over a month now since a vortex of fire fanned across the once beautiful community of Pressy Lake, late into the night of August 12, 2017. The devastation that followed the wall of flames is apocalyptic-like, and resembles ones worst fears of meeting hell on earth. Pressy Lake residents would like to invite you to visit this community and speak with us about our experience and observe the asphyxiating haze of smoke that lingers as a reminder of Mother Nature's attempt to violently strip the existence of Pressy Lake away from this world. A current visit is scheduled for MLA Ms. Jackie Tegart and Ms. Donna Barnett, on September 23, 2017, at 1100 hours.

Some members of the community were fortunate to have their homes and personal property spared; however, 33 residences and 24 outbuilding structures were destroyed. The community as a whole is surrounded by burnt and blackened trees and miles of deadfall that this generation, and likely the next generation, will never see as treed areas again. The magnitude of impact that this fire has had on Pressy Lake truly cannot be described with words and has yet to be fully realized.

The reason for my letter, Mr. Donaldson, is to request your support in a pursuit of an answer to the following question: why was there no Structural Protection Units placed at Pressy Lake prior to August 12, 2017? The fear that Pressy Lake was not being protected was evident when the area was evacuated on Jul 29th, 2017. The Thompson-Nicola Regional District live streamed an update for the Elephant Hill Fire in Clinton, on August 4th, 2017. During this meeting. I posed the guestion to BC wildfire service information officer Mr. Cliff Champon. asking, "what structural protection is in place for Pressy Lake?" The response, "I don't know where Pressy lake is," was gut wrenching. At this moment, my heart sank, as did the heart of this entire community. I knew nothing was being done ahead of the fire to prepare the structures and area immediate to Pressy Lake. On the other hand, on the same date, August 4th, 2017, structural protection unit specialists sent by the Fire office of BC, were joined by firefighters from Wildfire Service BC, Green Lake South volunteer fire department, Lac la Biche fire department and the North Saanich fire department, to prepare South Green lake for the fire. Collaboratively, this team implemented Fire Smart techniques and set-up level 2 and level 3 structural protection units on properties located along the south side of Green Lake. Pressy Lake is located 9 kilometers south of Green Lake, and evidently 9 kilometers closer to the approaching fire. While I do understand the instrumental role the volunteer fire department for Green Lake played in implementing structural protection measures, why would provincial government resources be allocated to prepare the community that is located furthest from the fire, with no structural protection measures being taken to protect Pressy lake?

Prior to the fire reaching Pressy Lake, contact was made with Wildfire service BC information officers Ms. Noelle Kekula and Ms. Claire Allen. Both information officers were unable to report if structural protection units were being placed at Pressy Lake properties. Not being able to get information from individuals with boots to the ground has proven to be frustrating. Several attempts have been made to obtain information about structural protection at Pressy Lake from the TNRD as well; however, I have repeatedly advised at this time they were only able to report what information was relayed to them via BC wildfire service, which was nothing. Why was there no push to ensure these properties were protected in the two weeks leading up to the fire?

On all accounts from the residents that stayed behind until immediately before the fire, or until the fire passed, when the fire reached Pressy Lake on August 12, 2017, it was unstoppable. It

was too late, and nothing was going to stop the force of this fire. The news that our community had been devastated by fire was first heard from local residents and also online media sources. Evacuees from the area continued to plead for information and plead for confirmation that measures were taken to protect our beloved community with the hopes that our community remained standing. Requests fell silent on the ears of TNRD and BC wildfire service for information, and in time I was advised by TNRD representatives and Wildfire Service Information Officers to submit requests for information through the Freedom of Information act. I spoke directly with the Deputy Chief Commissioner, Mr. Ron French, from the BC Fire office, and he too encouraged me to submit an information request if I wanted to know what was done for structural protection at Pressy Lake. The wildfire service of BC and the Fire office of BC are accountable to this community, what happened?

After photographs were released to residents which spoke of the lack of structural protection that was done for our community, I submitted an information request to the BC Wildfire Service office and to the Fire office of BC and to TNRD. Since that date, I have been contacted by two senior analysts at the Freedom of Information office, encouraging me to withdraw my requests. I have been told that the information in my request will be "difficult to obtain," and that following the fire the information will become protected, since there will "likely be some sort of investigation."

Mr. Donaldson, residents are fully aware that regardless of whether structural protection measures were implemented or not, Mother Nature may have pushed the fire through the community of Pressy Lake on the night of August 12, 2017; however, this does not mean that structural protection would not have saved the 33 residents and 24 outbuildings that were lost to the fire. **Pressy Lake needs your support and leadership right now**. Please stand with us. We need to know why Pressy Lake was not protected and there has to be accountability placed on the organizational decisions that resulted in Pressy Lake being decimated by this fire to prevent a repeat of this event in the future. The community of Pressy Lake will never be what it once was and desperately needs assistance and compensation to help rebuild uninsured losses, and to initiate habitat recovery and enhancement programs amongst the devastation. Learning what happened is the first step.

Our first priority is public safety and then the protection of private property, as well as livestock and pets. We do not factor the cost into the decisions surrounding how the fires are fought. If our professional wildfire service needs a resource to fight these fires, they will be authorized to use that resource. It's not the politicians who make the decisions about the resources we use, it's the professionals.

This has been the worst recorded fire season on record, both in terms of area burned – now more than double the area of Prince Edward Island – and in terms of cost. It's been the professionals in the wildfire service that have kept people safe and managed to limit the amount of damage to property thus far.

Thanks for taking the time to chat with me the other day about the massive Elephant Hill wildfire. As I am sure you are aware a couple days ago the fire broke through the containment lines on the Northeast side. It also grew to 182 thousand hectacres...it's greatest size since it's inception on July 7th...nearly two months ago!

I have composed a letter of my feelings of which our conversation is mentioned.

That said I feel I should forward this correspondence to your desk as I currently plan to bring a request (to the TNRD Board) for the Province to send a "Transition Team" to connect and help the folks who have been drastically affected by this wildfire that seems to have a life of it's own with no mercy shown to our Interior Constituency. I hope to have this request on the TNRD Board agenda at our next meeting just before UBCM.

A Transition team would not only calm the stormy seas of anger and exasperation that continues to build as the fire continues to grow but would show a NDP presence in our area countering the growing suggestion the "Interior" is not a priority of this government.

We can hopefully have a short conversation at UBCM but I urge the Ministry to consider sending a Transition Team to our area. This is a catastrophic...once in a lifetime event...unlike has ever been seen I our Province...turning peoples lives upside down every day that Elephant Hill spews it's flames of fury. These folks need help!

The simple announcement of this action would give a huge "shot in the arm" of HOPE to these wonderful folk who have had so much taken from them for so very long...with no end in sight.

The sad saga continues. This is no longer just a wildfire season in our Province... it is wildfire scenario beyond our wildest imagination.

Myself, as a Director and Vice Chair of Thompson Nicola Regional District Area I and Chair of Gold Country has been immersed as this terrible tragedy unfolds before our eyes.

My constituency alone has 51 families who have lost their homes. Countless businesses have closed and those that haven't continue to lose money. Infrastructure, livestock, pets...the devastation in numbers is astounding but the devastation in emotions, in loss of valued family memories, in your sense of any kind of stability each and every day is compounded by the tenacity of the Elephant Hill fire.

A wildfire that is still rated "out of control". A fire that has burned for over 7 weeks and is now at it's greatest size...168 thousand hectacres!!!

I have attended at least a half dozen wildfire meetings...signed a few evacuation orders in absence of the Chair and talked to many, many of my constituency.

The message is clear. Frustration, exhaustion, desperation. They want ONE phone number. ONE contact for answers to their questions or where they can go to get them.

This is a senior population....searching web sites, hoping emails get answered...is NOT the answer for these folks.

I had a serious chat with Minister Donaldson about the gravity of our situation and strongly suggested a "Transition team" should be created and sent to our area so our constituency can feel they are being heard. Today would not be to soon for these folks who have struggled with nearly two months of wildfire alerts, evacuations...smoke and health issues...not to mention many have NO homes to go to!!! Today the smoke showed up in Spences Bridge again. It seems neverending.

A presence in the epicentre (maybe Cache Creek) of this fire would not only soothe the souls of the Loon Lake, Boston Flats and Ashcroft Indian Band folks who lost their homes but of all those whose lives have been taken over by this fire and their futures have been threatened.

I urge the immediate formation of a transition team. Hope is what is needed...a Transition team can be the vehicle to provide it.

You and I have both lived long enough to know that long term smoke exposure can't help but have a negative impact on our lungs and general well being. In 1992, California started equipping their forest fire fighters with masks that made a significant difference: http://articles.latimes.com/1992-12-08/news/mn-1859 1 safety-masks. Of note from that article is the increased effectiveness of fire fighters when they could actually breathe effectively. "When state forestry firefighters in SunoI, between San Jose and Oakland, and Vina, near Chico, were equipped with full-face, air-purifying masks for part of a summer season, it not only eased the burden on their lungs but enhanced their firefighting ability."

Obviously I'm guite concerned for the health \$.22

mainland, and the fact that the State of Emergency has been extended now to August 18, I believe this should be a wake up call to ensure our fire fighters have the right protection as they protect our province.

Also – adding Vivian with FLNRO – the backcountry issue is a complicated one. Alberta is able to shut down huge areas of land while it is more difficult in B.C.

The off-road vehicle ban is a step toward keeping people out, but we have seen a huge increase in people hoping for a complete ban.

On the last bullet - people will not be asked to return home because of severe breathing issues. People are being asked to return if able/possible. ESS problems come up because we're dealing with volunteers on the front lines who have been doing things the same way for decades (ie – no evac order go home). We have been doing outreach to get them informed of better practices and have been seeing some improvement. We are also making the following clear through our PIOs in the field and on our media calls:

- ESS Reception Centres will continue to provide aid until it is safe for evacuees to return home.
- Emergency Social Services will continue to be provided on a case-by-case basis to those that cannot return home for health or safety reasons. If you require an extension on services, contact your local Reception Centre.
- At this time, anyone who is from a community where an evacuation order has been downgraded to an alert or rescinded altogether should return home unless a serious medical condition prevents them from doing so.
- Doctor's notes are not necessary for ESS around smoke-related health issues.

I am a president of the Interlakes Economic Association and I have been working with the group wanting to pursue the use of the high capacity pumps and water cannons for structure protection against the Elephant Hill Fire. You have asked your staff to get information for you. Please feel free to get me a written list of the information you require and I will see that that information is forwarded to immediately.

I have watched for two months as this fire approaches my community. The IEA conducted a community profile three years ago and it proved the tax assessment base in the area of Bridge Lake, Sheridan Lake and Deka Lake exceeds \$600 million dollars. That is more than all of the village of 100 Mile House including its industrial base! I trust you have seen the damage to structures at Loon Lake and Pressy Lake. Conventional methods are not working with this fire.

We are having difficulty getting up to date information from the Wildfire people, but I spent all day travelling to all fronts of this fire. If we get hit with the wrong shift in wind direction and strength, we have mere hours before millions in dollars value of structures will be in the direct path of this raging monster. I welcome you to confirm my findings with your people.

I trust you will treat our situation as you would if you were looking at the fire out your window every night as we are when we try to go to sleep. Repeating the same actions over and expecting a different result is the definition of insanity.
