Proposal to Lease Crown Land for Combined Sunshine Coast Facility

Proposal to Lease a Portion of District Lots 4076, 4077, and 4078 by the Sunshine Coast Rod & Gun Club, a non-profit Amalgamation of the Sechelt Peninsula Rod & Gun Club and the Gibsons Wildlife Club

Introduction

Due to the recent explosive growth of residential development throughout the south coast of British Columbia, many gun clubs and outdoor education facilities are experiencing the encroachment of residential subdivisions into what were recently exclusively rural areas. Due to the required safety precautions of these organizations, many clubs are facing the prospect of being unable to utilize their land for the purpose it was intended. As a result, many clubs are searching for suitable land on which to move their organizations and upgrade facilities so as to make them significant, both socially and economically, to local communities.

With this in mind, the Sechelt Peninsula Rod & Gun Club and the Gibsons Wildlife Club (both registered non-profit societies; registration numbers S4530 and S4945 respectively) came together with a proposal approximately three years ago to amalgamate under one non-profit organization, the Sunshine Coast Rod & Gun Club. At that time, a search began for a suitable parcel of land. After an extensive search, the Sechelt Peninsula Rod & Gun Club, on April 29, 1994, submitted a notice of intention to apply for a disposition of Crown land (a portion of District Lots 4076, 4077, 4078 Crown land, Group 1, New Westminster District) (see Figure 1) for the purpose of constructing a new indoor/outdoor shooting sports and outdoor education facility.

This document has been compiled in response to BC Lands' letter of July 5, 1994 (File # x-ref 2405875; see Appendix 1). BC Lands requested that, after a period of one year, a formal proposal be put forward regarding the above-mentioned notice of intent.

Specifically, this document will:

- demonstrate that there is no suitable alternative land available (other than unencumbered Crown land);
- show the club is classified as a non-profit organization incorporated according to the Society Act;
- demonstrate that activities of the new club facility will be of demonstrable benefit to all members of the community;
- make clear that membership/usage will be open to the general public (i.e., not for exclusive use); and
- show that the proposed site will not compete with private sector organizations.

The following sections outline in detail the specifics of the proposal.

The Proposal

Since the first discussions of amalgamation and a new facility, both the Sechelt Peninsula Rod & Gun Club (SPRDC) and the Gibsons Wildlife Club (GWC) have been actively searching for a suitable site. Not only is residential development becoming a more serious issue with regard to safety and noise, but present sites are also limited as to their applications as community facilities.

History of the Decision to Procure a New Site

In 1993, for safety reasons due to the encroachment of residential development into a previously rural area, the RCMP closed the outdoor range at the Gibsons Wildlife Club. At that time, members of the Sechelt Peninsula Rod & Gun Club and the Gibsons club met to discuss the reality of residential development quickly approaching the boundaries of each facility. Rather than attempt to find two new locations, members unanimously decided to propose amalgamation into one non-profit organization, the Sunshine Coast Rod & Gun Club. For this reason, it was imperative that suitable land be procured.

The assets of both groups were proposed to be sold and used to construct one new, large, modern facility. Both groups wanted to ensure that the Sunshine Coast retained an outdoor club facility, and that a new site be found in an expedient manner; if the clubs were required to shut down on short notice, both clubs may disappear from the Sunshine Coast community. This would adversely affect the 200 current Sechelt Peninsula Rod & Gun Club members and the 65 members of the Gibsons Wildlife Club. However, a new, combined facility would provide potential membership of up to 500.

Another important factor in the decision to procure a new site was the fact that a considerable amount of indiscriminate use of existing Crown lands occurs with regard to firearms and motorsport uses. This situation is both unsafe and unacceptable to residents and recreational users of public lands (i.e., hikers, mountain bike enthusiasts, etc.). With a new recreational

facility, there would no longer be any reason for inappropriate uses of Crown lands in what is an increasingly urban area.

Proposed Site

The search for a central site on the Sunshine Coast has carried on for more than three years. An area of expanded Crown land in the Wilson Creek area (District Lot 4076, 4077, 4078 Crown land, Group 1, New Westminster District; approximately 1.5 km north of the Sechelt/Gibsons airport; see Figure 1) has been deemed the only site on the lower Sunshine Coast with the following requisites:

- is presently unprocured;
- contains enough area for a safe backdrop for outdoor ranges;
- the security of a non-residential land base surrounding it (i.e., land will likely never be developed as residential);
- is dry, well-drained, and fairly flat; and
- is presently minimally or non-productive with regard to forest uses (i.e., covered with only small, scrubby pine trees).

District Lots 4076, 4077, and 4078 are the only land parcels on the lower Sunshine Coast which fulfill the above conditions. Private land does exist in the area of the application, but is owned by a large forest company and part of a privately managed forest. Officials of both clubs have spoken with company representatives and have been assured that the company is not interested in selling any land in the area; in other words, no residential development will occur around the perimeter of the proposed site. Also, if the clubs were forced to purchase private land, costs would be prohibitive to funding both the construction of a first class facility and its operation and maintenance (i.e., hydro, water, etc.).

A facility such as is being proposed requires a considerable land base for safety and operational reasons. For example, current facilities do not allow for more than one activity to occur simultaneously; the proposed site will allow multiple activities to take place, allowing safe and efficient operation for club members and visitors. The relatively large lot size will allow safe distances and treed buffers between activity areas and the clubhouse, caretaker's residence, and parking lots at the western end of the site. The steeply sloped east end of the site (approximately 45%) provides an excellent backstop for the rifle and outdoor handgun ranges. The orientation of these ranges will be northeasterly and, as such, all shooting with single projectiles will be away from populated areas into the hill; this range orientation allows for the recommended safety zone of 4,000 yards.

The selected site appears ideal for the uses proposed; it is unproductive with regard to forest values, central to the entire Sunshine Coast, geographically suitable, safe, and is in an area unlikely to be developed in the foreseeable future.

Funding

Funds for construction of the new facilities would be raised through the sale of both the existing Sechelt and Gibsons sites (6.1 ha and 3.6 ha, respectively). These are two valuable

pieces of land which, upon sale, will supply adequate funds to build and operate the new club facility.

The Facility

The Sunshine Coast Rod & Gun Club complex will consist of an expansive, modern network of indoor and outdoor shooting ranges, archery ranges, sporting clays, trap and skeet. The club would also house conference and meeting rooms, a banquet room complete with catering-suitable kitchen, and full shower/washroom facilities. The entire site will be wheelchair accessible and secured with perimeter fencing (see Figure 2).

The Sunshine Coast Rod & Gun Club complex will be available to public groups and private agencies for events, training, and recreation. Examples of suggested users of the new club facilities are:

- Sunshine Coast Search and Rescue (Provincial Emergency Program);
- Archery Club;
- outdoor training groups (i.e., CORE);
- mountain bike clubs;
- outdoor survival training;
- RCMP;
- cadets;
- boy scouts; and
- Junior Forest Wardens.

The complex will also be available for private functions such as conferences, meetings, dances, etc. (see Figure 3).

Benefits to the Community

Due to the urban pressures outlined earlier, shooting/recreational ranges are being shut down in various parts of the Lower Mainland. As a result, many rod and gun clubs are looking for alternative locations to practice and compete in their sport. With this proposal, we have an excellent opportunity to attract not only responsible, established shooting, trap-skeet, outdoor rifle, and pistol groups from all over the Lower Mainland for practice and tournaments, but also community groups, search and rescue operations, and youth groups, among others.

With the merger of the local outdoor groups, there is an opportunity to create new economic development by virtue of this venue. As well, this location not only provides a single, safe environment for these activities but will also contribute to satisfying the increasing demands for recreation opportunities for Sunshine Coast residents. Currently, although restricted by the constraints outlined above, only the two local existing clubs provide the services which

will be available at the proposed facility. No existing organizations will be adversely affected by the proposed amalgamation and combined club facility.

The planning department of the Sunshine Coast Regional District (SCRD) is currently considering the feasibility of a comprehensive multiple use recreation corridor along the BC Hydro right-of-way linking District Lot 1313 at Reed and Henry roads with the area above the airport. The proposed Sunshine Coast Rod & Gun club facility location fits well with some of the SCRD's initial ideas for forest recreation in this area of the proposed corridor, as well as into the SCRD's vision of a recreational area for activities not suitable for more urban areas (i.e., motorcross, motorsports, etc.).

In short, the proposed site and facility is a valuable opportunity to not only create much needed recreational space for the community, but also to create economic benefits in the form of visits from other clubs for tournaments, training, or conferences. The economic ripple effect to local businesses is expected to be positive.

Conclusions

In the many meetings prior to submitting this proposal, a variety of benefits to the proposed location were discussed, not the least of which were safety concerns and economic benefits. While the Sechelt Peninsula Rod & Gun Club and the Gibsons Wildlife Club require a new venue for their organizations' activities, it is believed that the amalgamation of the two groups into the Sunshine Coast Rod & Gun Club will positively benefit the community both socially and economically.

The new, modern facilities will be a place where outdoor groups can meet to practice and compete in their chosen sport. It will also be a place where community groups and families can come together for conferences and meetings, dances, and family reunions. Visitors to the Sunshine Coast utilizing club facilities will positively impact the local economy through purchase of groceries, shooting supplies, entertainment, and lodging. Also, the increased safety to the community can not be understated, especially when current uncontrolled firearm activities on Crown lands will be diminished with the availability of a full-use facility. In short, residents, visitors, and local businesses will benefit from this venture, one which will only be possible with the lease of the proposed site.









As a result of encroachment by residential development, it is becoming difficult to maintain outdoor shooting facilities for both the Sechelt and Gibsons Rod & Gun Clubs.

Applications for Community Use

The Ministry's Community Land Use Policy permits applications from community organizations. There are two alterative methods for dealing with applications of this type. These are a follows:

- a) Local government may make application on behalf of community organizations. Application must be endorsed by a resolution of the municipal council or regional board. Where an application is made for a free Crown Grant, the resolution should include an undertaking by the local government to retain title to the land, and to use the land for the purpose that is subsequently approved.
- b) Community organizations may make application.
 Applications must be accompanied by written confirmation that the relevant local government board or council declines to apply for Crown land on behalf of the organization, but does not object to the proposed use.


For a community organization to apply for Crown land, (under Item B) the group of individuals must form a "Non-Profit Organization" incorporated under the guidelines of the <u>Society Act</u>. Applications must be accompanied by the following:

- i) A Certificate of Incorporation with certified copy of the Constitution and Bylaws indicating they have formed a non-profit organization and that they are entitled to hold land.
- ii) The appropriate documentation indicating the organization is exempt from payment of property tax, pursuant to Section 13(q) of the <u>Taxation</u> (Rural Area) Act, by virtue of the fact that its activities are of demonstrable benefit to all members of the community: and
- iii) The documentation showing that the organization is exempt from payment of income tax, pursuant to the federal Income Tax Act, by virtue of the fact that no income is payable, to or available for the personal benefit of any proprietor, member, or shareholder.
