RE: Tourism & Forest Industry Conflicts in the Discovery Islands

January 3, 2018

Dear Green MLA's,

The Discovery Islands are British Columbia's second most valuable wilderness tourism destination (after Tofino/Pacific Rim). Tourism revenues in 2017 are expected to exceed sixty million dollars, employing over 1200 people full time or seasonally full time. Resort, lodge, and marina infrastructure is capitalized to about 1/2 billion dollars. In terms of revenue, taxation, and employment, tourism here greatly exceeds that of the forest industry. Despite this, the tourism sector here is consistently treated as a bystander when it comes to viewshed management. This attitude appears to be continuing under FLNRO Minister Donaldson.

I'm sure you know the forest industry in BC has acquired tremendous power over the last century and is able to dictate control on the landscape to the detriment of other economic stakeholders. Many forestry dependent communities have difficulty diversifying their economies because they are held captive by legislation consistently favouring the forest industry. Wilderness tourism in BC has become a valuable economic engine for the province and needs your help to protect it and the natural environment upon which we depend.

In 2013, after nearly a year of publicly embarrassing the government, the Working Group was formed with the financial and political support of former government MLA's, Liberal FLNRO Minister Steve Thomson, and JTSK Minister Shirley Bond. While in government, the aforesaid Ministers had hoped to create a tourism/forestry working group model which could be applied to other regions of BC where conflict between tourism and forestry exists. Supporting members of the tourism sector include the Discovery Islands Chamber of Commerce and the Cortes Island Tourism & Business Association. The forest industry was instructed to cooperate and work with tourism businesses to decrease the impact of clear cuts in high value scenic corridors within the Discovery Islands. Cooperation and concessions on the part of the forest sector was voluntary but some forest licensees chose not to participate at all.

After 4 years of meetings with the forestry sector, outcomes have fallen well short of our expectations. While there have been some successes, many important viewsheds remain highly vulnerable and will be seriously impacted over the next few years. Despite modest requests from tourism, most forest licensees have not been forth coming with adequate reductions in VQO (Visual Quality Objective) impacts (a.k.a. talk n' log).

Last summer, more than 50 Humpbacks and two pods of Orcas frequented our waters enabling many operators to guarantee whale sightings on tours. Whale and wildlife watching tours alone contributed about ten million dollars to the local economy. This sector is expected to grow significantly in the coming years, yet the scenery along whale watching corridors is being compromised by logging as I write this.

Discovery Islands communities are not forest industry dependent economies. Tourism and retirement are the key economic drivers today. Thirty years ago, provincial tourism revenues were one quarter the size of the forest industry. Today revenues are equal to, or exceed the forest industry at 17 billion dollars. Despite the high contribution of wilderness tourism to the provincial economy, the government still considers our needs secondary to those of the forest sector. This needs to change.

Despite two requests, we have been unable to meet with FLNRO Minister Donaldson to explain our situation and get help. Minister Donaldson seems to have time to travel to China to further promote the export of unprocessed logs to that country yet can't find the time to speak with his own citizens. My request to you is to insist that Minister Donaldson meet with us so appropriate viewshed management of the Discovery Islands can finally take place.

I have received a number of letters from community members in Ymir, BC, who are concerned about their limited supply of drinking water being further impacted by proposed logging in their local Quartz Creek watershed. One reads:

"BCTS plans to log the Ymir watershed. While I have no opposition to the notion of responsible logging, I have done research on Quartz Creek Watershed, and this plan seems extremely shortsighted. Ymir's drinking water supply is very limited. They barely have enough water to drink. Quartz Creek is very shaded; any more heat would lead to evaporation and put Ymir in a position where it doesn't have enough drinking water. This water is also Ymir's firefighting water. If they don't have enough firefighting water it is a public health and safety issue. Please help us. We have no other viable drinking water source."

Can you please advise if this situation has been noted by your ministry? And if so, what is being done to evaluate or address the community's concerns?

Thank you for your letter of August 2, 2017, regarding the proposed logging operations in the Quartz Creek watershed and the concerns of the community of Ymir.

First, I would like to assure you that the Ministry of Forests, Lands, Natural Resource Operations and Rural Development recognizes and appreciates the concerns of the Ymir residents. Ministry staff are aware that Quartz Creek provides the only source of water for approximately 400 residents and that the watershed provides many other important values.

BC Timber Sales (BCTS) is working closely with the Ymir Community Watershed Action Team and other community members. BCTS is reviewing the concerns identified through communication with the public and will move forward in a manner that takes in to account these concerns. I understand BCTS staff met with Honourable Michelle Mungall, MLA for Nelson-Creston, to discuss the proposed operations in detail.

The proposed operations are currently in an information gathering phase. BCTS hired a professional hydrologist to complete a preliminary hydrological assessment of this drainage, which concluded changes to the flow regime, including peak flow timing and water yield, are unlikely to occur. Additionally, BCTS has three further hydrological assessment planned for this drainage and will base its decisions on the recommendations made by these professionals.

Dear Minister Donaldson,

I have received a number of letters from community members in Ymir, BC, who are concerned about their limited supply of drinking water being further impacted by proposed logging in their local Quartz Creek watershed. One reads:

"BCTS plans to log the Ymir watershed. While I have no opposition to the notion of responsible logging, I have done research on Quartz Creek Watershed, and this plan seems extremely shortsighted. Ymir's drinking water supply is very limited. They barely have enough water to drink. Quartz Creek is very shaded; any more heat would lead to evaporation and put Ymir in a position where it doesn't have enough drinking water. This water is also Ymir's firefighting water. If they don't have enough firefighting water it is a public health and safety issue. Please help us. We have no other viable drinking water source."

Can you please advise if this situation has been noted by your ministry? And if so, what is being done to evaluate or address the community's concerns?

Dear MLA Furstenau:

Thank you for your letter of August 2, 2017, regarding the proposed logging operations in the Quartz Creek watershed and the concerns of the community of Ymir.

First, I would like to assure you that the Ministry of Forests, Lands, Natural Resource Operations and Rural Development recognizes and appreciates the concerns of the Ymir residents. Ministry staff are aware that Quartz Creek provides the only source of water for approximately 400 residents and that the watershed provides many other important values.

BC Timber Sales (BCTS) is working closely with the Ymir Community Watershed Action Team and other community members. BCTS is reviewing the concerns identified through communication with the public and will move forward in a manner that takes in to account these concerns. I understand BCTS staff met with Honourable Michelle Mungall, MLA for Nelson-Creston, to discuss the proposed operations in detail.

The proposed operations are currently in an information gathering phase. BCTS hired a professional hydrologist to complete a preliminary hydrological assessment of this drainage, which concluded changes to the flow regime, including peak flow timing and water yield, are unlikely to occur. Additionally, BCTS has three further hydrological assessment planned for this drainage and will base its decisions on the recommendations made by these professionals.
