- The Province currently works through Council of Haida Nation (CHN) and feels extremely proud of the work undertaken toward reconciliation by both provincial staff and the CHN.
- Those involved in the occupation are not, to the Province's knowledge, represented by the CHN, which means that negotiated resolution may be limited.
- We must continue to work as partners in reconciliation and work to understand our perspectives, while we continue to transition Haida Gwaii through continued reconciliation.
- The overall economic health of communities on Haida Gwaii needs to be a focus of the all involved. The importance of current tenures for island employment must be recognized, understood and allowed to move forward.
- The Province fully encourages and supports the significant opportunities to pursue further reconciliation with the CHN and future meetings have already been scheduled to this end.

Background

- The logging that people are seeing was developed under one of the strictest Land Use Orders in the Province, the Haida Gwaii Strategic Land Use Agreement, creating an extremely robust ecosystem based management regime.
- Approximately 52% of the Haida Gwaii islands are protected areas.
- Current allowable annual cuts (AACs) were based on sustainable projections of timber supply; a new process is underway to determine an AAC for all of Haida Gwaii by the Haida Gwaii Management Council.
- There is recognition that harvest levels for cedar are an issue. In 2012, the previous chief forester established voluntary maximum limits for cedar harvest in the major management units on Haida Gwaii. Actual harvests have been within the limits, with the exception of one where a partition has since been established by the chief forester on recommendation of the Haida Gwaii Management Council.
