#### **Plenary session on Emergency Preparedness**

<!--[if !supportLists]-->• <!--[endif]-->I'm Doug Donaldson. Minister of Forests, Lands, Natural Resource Operations, and Rural Development.

<!--[if !supportLists]-->• <!--[endif]-->I've said it so much that it's starting to sound like a cliché: but it's true – we're in a truly unprecedented fire season.

<!--[if !supportLists]-->• <!--[endif]-->The numbers are a little staggering.

<!--[if !supportLists]-->• <!--[endif]-->As of yesterday, there were 158 fires burning across the province.

<!--[if !supportLists]-->• <!--[endif]-->Thirty eight hundred staff are involved in fighting these fires - including fire fighters and support staff.

<!--[if !supportLists]-->• <!--[endif]-->It's an enormous effort, with 182 aircraft involved as well.

<!--[if !supportLists]-->• <!--[endif]-->At the peak, there were 47,000 people under evacuation order, and tens of thousands more under evacuation alert.

<!--[if !supportLists]-->• <!--[endif]-->Since April 1, the wildfire service has responded to 1,212 fires. More than a million hectares burned.

<!--[if !supportLists]-->• <!--[endif]-->It's also unprecedented in terms of costs: Government has spent about \$473 million battling these blazes so far.

<!--[if !supportLists]-->• <!--[endif]-->Despite all that, thanks to the hard work of firefighters from across the province, and with the aid of firefighters from Quebec, Alberta, Mexico and Australia, there has been no loss of human life and while we've seen loss of private property, including homes, it could have been much worse.

<!--[if !supportLists]-->• <!--[endif]-->Of course, it's not over and we will see a continuation of the fire season well into the summer.

<!--[if !supportLists]-->• <!--[endif]-->Today we're talking about response and recovery, and I want to highlight one story which is symbolic of why we're here, I think.

<!--[if !supportLists]-->• <!--[endif]-->On July 18, I was sworn in as the minister of Forests, Lands, Natural Resource Operations and Rural Development. Two days later, I was in Kamloops, meeting with evacuees, touring the fire operations centre and hearing from local

governments.

<!--[if !supportLists]-->• <!--[endif]-->And that day, with Minister Farnworth, I met with the Tk'emlúps te Secwepemc. When hundreds of people, and some of their animals, had no place to go, the Tkemlups took them in. They opened up their powwow grounds to trailers, RVs, cars and tents.

<!--[if !supportLists]-->• <!--[endif]-->They didn't care where they were from.

<!--[if !supportLists]-->• <!--[endif]-->All that mattered was that people needed help.

<!--[if !supportLists]-->• <!--[endif]-->I know that the Tkemlups are not alone in their generosity. We've heard countless stories about people giving their time, their possessions and themselves to assist strangers for no other reason than that they needed help.

<!--[if !supportLists]-->• <!--[endif]-->In meetings over the past two days, I've heard more than a few people point out that we're on this land together and that our futures are inextricably intertwined. We all rise together or we fall apart. We're all in it together.

<!--[if !supportLists]-->• <!--[endif]-->In large part, that's been the reaction to this unprecedented natural disaster. We came together, like we saw in the generosity of the Tkemlups opening up their land to people from across the southern Interior.

<!--[if !supportLists]-->• <!--[endif]-->We have tremendous capacity when we remember our common purpose.

A preliminary estimate is that about<sup>s.13,s.17</sup> r have been impacted by this summer's wildfires. This is equivalent to about one year's worth of Interior allowable annual cut.

There will be some areas within the fire perimeters that is unsalvageable, other areas that are salvageable and areas that fires missed and remain green.

Ministry staff are assessing the areas burned by wildfires and will be prioritizing areas for reforestation and wildlife habitat restoration.

Already, some of the timber that was harvested to make fireguards has been sent to mills for processing.

The ministry will also be issuing salvage licences to licensees and First Nations and expediting approvals of cutting permits for forest companies operating in the burnt areas. Licensees are responsible for reforesting the areas they harvest. The ministry will be reforesting other areas.

Ministry staff will be engaging with First Nations as a timber salvage strategy is developed.

As part of Budget Update 2017-18, government allocated<sup>s.17</sup> wildfire risk reduction, wildlife habitat restoration – including reforestation, and promoting FireSmart. This includes funds that were directed to the Forest Enhancement Society of B.C. The B.C government has already begun a co-ordinated recovery and community rebuilding process.

### **Wildfire Recovery:**

The Ministry of Forests, Lands, Natural Resource Operations and Rural Development is leading the provincial government's support for First Nations and communities in terms of wildfire recovery.

There are four key components of the long-term plan we're building:

We are working closely with the federal government's to ensure they keep their commitments in supporting British Columbians as we recover from this year's wildfires.

We will be engaging with First Nations and communities – to ensure all provincial government agencies are providing the necessary programs and supports to assist wildfire recovery efforts.

UBCM provides a good opportunity for us to hear individual local government concerns first hand.

A key component of economic recovery is getting timber to mills. To that end, forestry staff are working closely with licensees in expediting cutting permits and issuing salvage licences.

Timber that was cut down to make fireguards is already being milled.

Forestry staff are also prioritizing areas for reforestation – not only to rebuild timber supply for mills – but to restore wildlife habitat.

These efforts will build on accomplishments to date:

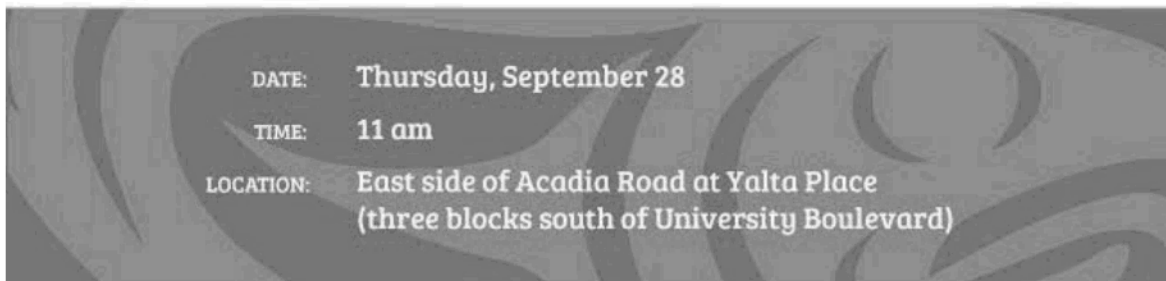
