I Ken:

I was talking to Jennifer when she was up last week and mentioned the Barkerville Airstrip. When we were under the Ministry we looked after the strip but I know that the trust did not take on the responsibility for it under their agreement. There will be some maintenance work necessary over the next couple of years.

The lines should be repainted and the declination markings need to be re-measured and painted on the strip also the should be new wind-socks purchased as the old ones are getting really faded and I have had a couple on comments from pilots about them. The strip should be swept and the brush cut back each year we would get the highways maintenance contractor to run their brush cutter around the perimeter when they are doing the roads in the area. The trees between the strip and the highway are getting tall again and will require cutting back in the near future. We did them about ten to twelve years ago.

I guess my question is how should this be handled, and do you have any money available for the minor work (mowing & sweeping) for this year? I guess the other work should go into a work plan for the next couple of years. I'm hesitant to take on any work there with any of our crew, as we may seem to be accepting responsibility for the strip, when it isn't in our Site Agreement and specially as we did not include it on our insurance policy.

Please let me know your feelings on this and we will work with you to keep the strip safe and operational.
