- The Disabled Access Pass (DAP) was cancelled in 2003 – all recipients were notified of the change to the current process by mail, at that time.
- Unfortunately not all individuals that were once eligible for the DAP program necessarily still qualified for the new program.
- The current process relies on the Ministry of Social Development & Poverty Reduction (MSDPR)'s program (not changed since 2003) which considers an individual's level of disability as well as their financial need. Individuals who are eligible for MSDPR's PWD benefits qualify for BC Parks camping fee exemption for park visitors with disabilities.
- The camping fee exemption, established under the Park Act and its regulations, doesn't permit BC Parks from waiving this policy or exempting on an individual basis.
- MSDPR has staff available that can provide assistance to individuals, who are struggling with the length/complexity of the process. The toll free # at MSDPR is **1 866 866-0800**.
- In the meantime, the constituent may want to take advantage of BC Parks' senior's camping rate (1/2 camping fee) that is still in effect across the province until June 14. It is also available again on the day after Labour Day.

## **Re: Follow Up from BC Seafood Alliance Reception**

We are so pleased that you could join our fishery members to celebrate the variety and quality of wild seafood at the BC Wild Seafood Reception in April. We hope you enjoyed tasting both familiar and less familiar species thanks to the skill and talent of the Steamship team and our guest chef Ned Bell. We're delighted to have a partnership with Ned to promote sustainable seafood from Canada's West Coast.

If we can leave you with one message: it is that participants in the fishery, whether they be small family businesses or larger companies, are losing the confidence to invest in the future. This includes investment in new vessels, more environmentally friendly gear, new products and new markets and even in the resource itself. This is a result of the federal government's decision to seize almost \$25 million in surf clam quota from one company (Clearwater) in Atlantic Canada and give it to another group without compensation, its decision to cancel the Central coast roe herring fishery despite peer-reviewed science that allowed for a fishery that would have generated about \$12 million for BC fishing families and coastal communities, and some indication of other changes to licencing policy on both coasts, including further expropriation of people's livelihoods.

A fishing licence is not property but for decades there has been a consistent model whereby

licences were in effect evergreen—reissued every year. Now that model has been compromised and lenders are taking notice. Fishermen and processing companies are finding banks more reluctant to lend, requiring more security or higher rates of interest.

Both the Clearwater and Central coast roe herring decisions were supposedly in the name of Reconciliation. No question from us that Reconciliation is a national imperative but as the judge in the recent *Abousabt et al* case said: it is voluntary relinquishment (willing buyer/willing seller) that promotes Reconciliation.

We ask you therefore to raise with your federal colleagues the need for stability, predictability and a clear and fair process for transferring additional access to First Nations (in BC Indigenous people and organizations already control about one-third of licences).

Without this predictability our ability to supply food to Canada and the world, and provide jobs and incomes to communities will be severely compromised.

And of course we are always ready to meet to answer any questions you may have. Thank you again for joining us.
