Thank you for your email of September 8, 2017, to Honourable George Heyman, Minister of Environment and Climate Change Strategy, regarding the water licence application by s.22. I am responding directly as the administration of water licences is part of the mandate of the Ministry of Forest, Lands, Natural Resource Operations and Rural Development.

Ministry staff in the Surface Water Authorizations section of the South Coast Natural Resource Region have now initiated review of s.22 application, and I have been informed that additional information is needed to support further progress of this file. As s.22 initiated his request through your office, could you please inform him that it would be beneficial if he could provide ministry staff with the following information:

- Recent bi-weekly discharge measurements for s.22 for a minimum of one year, and preferably for two years;
- An assessment of the potential impacts of the proposed diversion on other ground and surface water licence holders in the area;
- An Environment Flow Need assessment prepared by a Qualified Professional.

Harrison: Part of the future of BC outside the Lower Mainland and the Island, of course, is our critical forest industry. Now that Canada has been hit with another round of punishing softwood duties by the US what's the future in that area and what do you propose be done?

Stone: First off, let's remember John Horgan said that he was going to solve the softwood lumber dispute by just flying to Washington and sitting down with a few folks. He went and did that. How has that worked for us? Not so well. We've got to focus on the immediate needs, first and foremost. We have a fibre supply challenge that is bearing down on us really quickly. We do not understand why this government will not issue permits to cut burnt stands from the wildfires this summer or to cut stands of spruce beetle-impacted trees that's largely in the Prince George and north area. Local companies are banging their heads on the wall trying to access fibre and we've got all kinds of burnt stands and beetle kill wood that's still viable if we cut it now, if we cut it through this winter, but you have to have the permits to do that.

So got to get on with that. There's some innovative, value-added opportunities that I'm proposing for BC's communities. We've got to continue to diversify our markets for exports overseas. And at the end of the day we've got to ensure that forestry continues to be a priority sector for BC, and that means the Premier and his cabinet need to get out of Victoria and they need to go and spend some time in Kamloops and Quesnel and 100 Mile and Williams Lake, Prince George. They haven't done that yet. They haven't sat down with stakeholders to talk about what needs to happen to bolster the forest industry, particularly with the headwinds facing the industry these days.

Harrison: Been some debate about whether the government is issuing permits as expeditiously as necessary to get that burnt timber out to market but the Forests minister said, today, in fact, that they are indeed doing that and they've issued 21 permits with many more on the way.

Stone: Yeah, and just is simply not true. We'll be pursuing that further with the minister. They are being very cagey about this. There have been a few permits that have been issued. They have not been issued to cut down burnt stands on Crown land, which is where the majority of the timber is. They have not been issued to cut spruce beetle kill wood in the Prince George Timber Area, for example. So that's a misleading statement from the minister and it's very disappointing. We've got all kinds of families that want

to know that they're going to have jobs in the mills up and down the Thompson Cariboo Chilcotin in the forthcoming months and years and we have a government that's sitting on their hands and not doing enough to ensure that the fibre supply's there.

A statement from the premier would look something like this:

We have long agreed with these campaigners that more needs to be done to protect the health of our vital forests, which for 16 years were left degraded by the Liberal government. Doug Donaldson, the minister of Forests, Lands, Natural Resource Operations and Rural Development, met in October with the groups who held the rally Tuesday night. They shared with him a thoughtful and comprehensive analysis with what they see as the problem and offered some solutions. Their discussion paper is being studied by the ministry right now and we'll have more to say about that once the analysis is complete.

Minister Donaldson's mandate includes working with First Nations and communities to modernize land use planning to effectively manage BC's forest and old growth. I know he takes that very seriously and I'm looking forward to the solutions he brings forward.
