I just did. It appears to be written by the legal team.

The First Nations agree to the January 30<sup>th</sup> meeting.

They look forward to BC's response to the presentations made at the Alert Bay Longhouse on October 10, 2017; presentations on fish health testing (perhaps from the Min of Ag - DFO scientists dispute); report on the future of aquaculture (likely MAACFA report, which is not specifically addressing the future of AQ) and a review of regulations for fish plants; they look forward to how BC will follow through on UNDRIP under the Canadian constitution and how to forge new relationships with First Nations on a G-G basis.

After consultation then establish protocols on tenures with each Nation.

They are happy to involve Dan George.

If DFO is involved then the draft must change.

The last page is a draft to Charlie Short of First Nations expectations for the meeting.

OK well, this will be ongoing.

following this summer's wildfires. As the Assistant Deputy Minister, Local Government Division, Ministry of Municipal Affairs and Housing, I am pleased to respond on behalf of Honourable Selina Robinson, Minister of Municipal Affairs and Housing, and Minister Donaldson. I apologize for the delay in responding.

I am sorry to hear that your<sup>s.22</sup> fire this summer. I appreciate that losing something like this is not just about losing the structure; it is also about losing something your father created.

Your email seeks assistance to relax the building and zoning requirements in the Thompson Nicola Regional District (TNRD) for homes/cabins that were lost in the wildfires this summer. Local governments are required to adhere to provincial legislation and regulations, including the BC Building Code, and must ensure that their bylaws and processes conform both to principles of good practice and to all legal requirements under the *Local Government Act*. The TNRD has authority over land use planning, including zoning and implementation of building requirements outside of the municipalities. Given their authority, I would encourage you to contact staff at the TNRD as they are in the best position to advise you of what options may be available to address some of the concerns you have raised.

Since the date of your letter, I understand that the TNRD has hired Mr. Bob Finley into the

position of Recovery Manager, specifically to coordinate efforts with property owners who suffered damage or loss during the fires. Hi Doug,

We have been trying unsuccessfully to line up a short meeting with you to discuss the direction your government seems to be taking with regard to moose hunting in your own riding in North Skeena. You will likely recall our 2017 meeting with you where we documented our serious concerns with the Wildlife Branch bureaucracy and their divide and conquer attitude. You seemed supportive of a return to some real consultation via the Skeena Hunter's Advisory Committee (SHAC) process that has successfully operated for 23 years. This process was created and supported by our MLA Jackie Pement and the NDP government back in the day. The bureaucrats have been trying to marginalize the SHAC for quite some time now. They appear to having great success with that.

A recent 41-page document describing a "roundtable agreement" on moose regulations in North Skeena is nothing short of a promotion of trophy hunting. While there is no conservation concern for bull moose in the North there is a push for antler tine restrictions that promote the harvest of the largest and oldest bull moose in the population. BC's licensed resident hunters consider moose to be a species that should be managed as a food source first and foremost, while guided non-residents want them managed for their "trophy" antlers.

The roundtable process I speak of was initiated by the previous Liberal government and its direction was questionable from the start, to say the least. Approval for gas pipeline routes through the North hinges on First Nation's approval, and the process was designed as an end to that mean for the Liberals. Hunting guides quickly saw the process as an opportunity to drive a wedge between the different groups that hunt moose in the North. B.C.'s licensed resident hunters were eagerly traded off by everyone at the table, including those that should know better.

We had thought that the NDP was clearly supportive of B.C.'s licensed resident hunters, who had been pushed aside by the Liberals when their government arbitrarily abandoned the provincial allocation policy agreement in favor of the guided non-resident hunters. We had thought that situation would be rectified once the NDP took power. The opposite seems to be coming true.

It is time the B.C. government stood up for its resident hunters when it comes to the licensed hunt for moose. Please do not cave in to the trophy-hunting lobby in North Skeena.

I am sure you have heard that a First Nations Group has erected a blockade on the Date Creek 400 road, stopping the logging contractor from accessing the Timber Sales License.

### **Background**

BC Timber Sales completed the consultation of the Timber Sale License (TSL) with the Kispiox River Watershed Chiefs, as per the watershed agreement signed by the Chiefs and facilitated by the watershed facilitator Bill Blackwater Jr. It is my understanding that the TSL was accepted by the affected Wilp Chief Brenda Stewart and that all consultation was complete. I would suggest you contact BCTS timber sales manager Gordon Haley in Terrace for more details.

Timber Sale License (TSL) A67762 was auctioned by BC Timber Sales in

November of 2017, with my company having the highest bid, therefore the TSL was awarded to us.

Operations commenced in mid December with falling, skidding and processing. On January 10th our contractor notified me that a First Nations Group had demanded they leave the work place, citing the First Nations Group had not been consulted regarding the harvesting of the TSL. The First Nations group is represented by Chief Tii Ba Sa and Rosalind Gawa (not sure of the spelling) and her daughter Debra Starr. On January 11th I was on site and a paper sign was nailed to a log saying "you got one week to move off 400 block date creek".

On Monday January 15th there were people blockading the date creek 400 road not allowing the logging contractor to enter the work site.

On January 17, 2018 the MFLNRO, BCTS, myself and our logging contractor met with the First Nations Group (11 representatives) at the BCTS office in Hazelton. The First Nations laid out their case as to why they have a claim to the area and how they were not consulted.

"The basis for this meeting was to jointly honour the implementation of the United Nations Declaration on the Rights of Indigenous Peoples and to confirm a commitment to a consent-based government-to-government process focused on the current fish farm

operations in the Broughton area, and protection of wild salmon.

“We have agreed to immediately embark on government-to-government discussions to address the issues and concerns about fish farms in the Nations’ traditional territories, based on free, prior and informed consent.

“Today’s meeting was the next step toward finding solutions together, which will include shared priorities and decision-making.

“We are prepared to do the necessary hard work to find a path forward together in the Broughton Archipelago in keeping with and enacting the principles of the United Nations Declaration on the Rights of Indigenous Peoples.”
