I just saw the probable hunting regulation changes, or lack there of for the East Kootenays.

This was an opportunity to right the ship and you, your team, and the government dropped the ball on this one. Our elk numbers are pathetically low, and for what used to be a world-class resource, this should be of high concern. To think we will still be shooting spikes and antlerless elk sickens me. Where will the bull recruitment come from if we keep shooting the crop of 1.5yr old bulls? Many of these may have ended up migrating as well. Our migratory herd is nearly decimated. What is your plan to return their numbers to historic levels?

You said that many stakeholders were involved in this process. Judging from the lack of change, I'm going to guess the ranching community was highly involved. What about the many letters and comments from the hunting community that stands for conservation and a quality experience while out hunting? Were they considered? Doesn't seem like it...

I'm not going to explain again what elk hunting means to me and what I put into it as I've already explained that to you in past letters. So please don't question my observations from the time I spend in the field. I'm doing my part by writing to you. I will question you though as you have the capacity to make changes.... you've decided not to.

This is on you and your team, Tara. Please do the right thing and get our elk herd back where it should be, which is way more than we have now.
