I am writing to confirm our meeting for January 30, 2018, for further government-to-government discussions about open pen fish farms in the Broughton Archipelago. We look forward to continuing to engage with you and to continue to build our government-to-government relationship that reflects the United Nations Declaration on the Rights of Indigenous Peoples.

In preparation for our meeting we offer a suggestion for your representatives and provincial officials to meet in advance. Our goal is for frank and forthright discussions about our respective perspectives, challenges, concerns and assumptions, with the objective of setting the table for our meeting on January 30, 2018. As with any government-to-government discussion, the work done in advance of the meeting can significantly aid us in making progress and, hopefully, in identifying areas of mutual agreement. If you agree to these early discussions, please contact Charlie Short, Executive Director of Coast Area Operations, by phone at 250 387-1721 or by email at charles.short@gov.bc.ca. Furthermore, we suggest and respectfully request that Dan George, of Four Directions Management Services, facilitate these advance discussions.

For the meeting of January 30, 2018, I can confirm that the ministers and deputy ministers from the Ministry of Agriculture, Ministry of Environment and Climate Change Strategy, and Ministry of Indigenous Relations and Reconciliation will be joining me and my deputy minister. It is also important that representatives from Fisheries and Oceans Canada (DFO) be part of these government-to-government discussions given the significant role the DFO plays with regards to licensing and siting salmon aquaculture facilities in the province, as well as their shared objective in reconciliation with First Nations. We expect to hear back soon from Minister LeBlanc confirming the DFO representatives who will be participating in these discussions. To that end, we have booked the meeting for Vancouver and will follow up with a specific location closer to the date.

We recognize the importance of the words that were spoken in the Alert Bay Big House and also acknowledge that you are now looking for a response on behalf of the Province of British Columbia. To that end, we believe there is much for all of us to continue to discuss and understand. We look forward to having these conversations with you. As you have heard from this government in the past, this is a challenging situation involving various perspectives. We are also aware of the strain that this situation is placing on Indigenous and non-Indigenous communities and families alike, pointing to the reality that there are no easy solutions. We are strongly committed to building a respectful relationship with you and to find a long-term resolution to the issues at hand.

We look forward to meeting with you and thank you for considering our invitation.

### Jan 30, 2018 meeting on Fish Farm tenures

#### Background/Context/Environmental scan:

Protests have taken place at a number of fish farms over the past few months. As well, various First Nations groups and other environmental advocates have continued to express long-held concerns about open-pen fish farms and the potential detrimental impact on wild salmon and the marine environment.

In an effort to find collaborative solutions to some of the concerns raised, the B.C. government has invited five First Nations from the Broughton Archipelago area to a meeting in Vancouver on January 30, 2018. They are the 'Namgis (nhum-geez), Kwikwasutinuxw Haxwa'mis (quick-wasut-uh-nook), Dzawadaenuxw (dza-wa-day-noowh), Mamalalikula (ma-ma-leelah-kwalah) and the Gwawaenuk (gwah-way-ee-nook).

Minister Doug Donaldson, Environment Minister George Heyman, Agriculture Minister Lana Popham and Scott Fraser, Minister of Indigenous Relations and Reconciliation will attend the meeting with the five First Nations groups.

In a letter confirming their attendance, the five First Nations ask government to deal with the "urgent matter of open-net fish farms" within their territories. They also ask that the fish farm tenures in the Broughton Archipelago, which are set to expire soon - "not be renewed".

Set against the backdrop of new concerns about fish farms, protests, and the Jan 30<sup>th</sup> meeting, FLNR ministry staff recently informed three tenure holders: Cermaq, Marine Harvest and Grieg Seafood Ltd of the application process for tenure replacement and that their respective tenure's to use Crown land foreshore for their aquaculture operations in the Broughton Archipelago are set to expire in June.

This is normal practice, as part of the review and decision making process regarding the replacement of these tenures.

### Purpose:

The purpose of this communications plan is to clearly articulate government's commitment to finding solutions to address various concerns about fish farms.

### Goals/Objectives:

The goals of this plan are to:

- Communicate that there is a desire by government to establish a dedicated process to discuss and recommend specific solutions for the Broughton area tenures in collaboration with affected First Nations. This is in keeping with government's commitment to implement UNDRIP.
- Communicate government's legal requirement to consult with First Nations on any renewal of tenures for fish farms in the Broughton Archipelago.

• On Saturday, Aug. 19, 2017, media reported about 300,000 salmon escaped a fish farm net in the San Juan Islands. No escapes took place in B.C. waters, however several B.C. First Nations have expressed concerns regarding the escape.

- By August 31, 2017 protesters from the 'Namgis, Tlowitsis and Mamalilikulla First Nations had occupied the Swanson Island fish farm and members of the Dzawada'enuxw and Kwikwasutinuxw Haxwamis First Nation led by Chief Okwilagame (Willie Moon), began occupying Midsummer Fish Farm near Port Hardy. The Port Elizabeth fish farm near Gilford Island was also briefly occupied.
- October 19, 2017 occupations at the Swanson Island Conservancy cabins and the Midsummer Island fish farm were re-established and are ongoing. A small occupation outside the Premier's constituency office in support of the fish farm protests is also ongoing.
- On November 2, 2017 a rally was held at the BC Legislature, with participation from approximately 200 people, including hereditary and elected leadership from Musgamagw Dzwada'enuxw, Namgis, Mamalilikulla and other Nations opposed to fish farms.
- On Nov 27, a video showing blood coloured effluent pouring into Browns Bay near Campbell River from a nearby farm salmon processing plant has been reported in the media. Young wild Chum and pink salmon are film swimming feet away from the waste cloud. It is claimed that the effluent contains a dangerous fish virus known as PRV.

- As part of the tenure application review process, other agencies, First Nations, local
  governments and the public are always consulted. We are confident we can find a path
  forward with First Nations in the Broughton that respects their Aboriginal rights and title.
- The Department of Fisheries and Oceans is the lead agency with respect to fish farms in Canada; all discussions on aquaculture licensing must include them.
- The federal government licenses the production and growing of the fish, and the
  province's role is to provide the land tenure for the anchor that positions the pens to the
  ocean foreshore.
