
# Background:

There has been a long standing position taken by the Tsilhqot'in Nation Government (TNG) that they do not want to see Taseko develop New Prosperity within the traditional territory of the Xeni Gwet'in. The TNG have opposed all exploratory work by the company that would support the development of a mine.

In May 2017 TML applied to the Cariboo-Chilcotin Natural Resource District (DCC) for an OTLC to support a NOW which was not yet approved by the Ministry of Energy, Mines and Petroleum Resources (EMPR).

EMPR approved the NOW in July 2017. TML then approached DCC requesting when the issuance of OLTC would occur. During 2017, DCC was engaged heavily with fire response and recovery efforts. TML was informed that it may take some time to issue the OLTC. Subsequently the Federal Canadian Environmental Assessment Agency (CEAA) and the TNG petitioned the BC Supreme Court, on different grounds, to halt TML from conducting activities associated with the NOW.

Both petitions were dismissed by the BC Supreme Court, with the latest occurring on August 23, 2018. Taseko requires the OLTC to harvest crown timber and the district manager is required under Section 14 of the *Mineral Tenures Act* to issue an OLTC on request of the holder of the mineral rights in this area. In addition to the Province's consultation with the TN regarding both the NOW and OLTC, which commenced in November 2016, DCC took additional steps to engage with TML and TNG and provided possible conditions that could be included in the OLTC.



Taseko has given notice to the TNG and the Province that they are preparing to conduct activities authorized in the NOW no earlier than September 1, 2018 and have contacted DCC to request a timeline for issuance of the OLTC.

The OLTC, with additional conditions, is prepared and ready to be sent to TML for signing. Once returned DCC intends to issue the OLTC.

EMPR approved the NOW in July 2017. TML then approached DCC in July 2017 askingrequesting when the issuance of OLTC would occur. During 2017, DCC was engaged heavily with fire response and recovery efforts, TML was informed that it may take some time to issue the OLTC. Subsequently the Federal Canadian Environmental Assessment Environmental Assessment Agency Office (CEAAO) and the Tŝilhqot'inTsilhqot'in Nation National Government (TNO) petitioned the BC Supreme Court, on different grounds, to halt TML from conducting activities associated with the NOW.

Both petitions were dismissed by the BC Supreme Court, with the latest occurring on August 23, 2018. Taseko requires the OLTC to harvest crown timber and the district manager is required under Section 14 of the *Mineral Tenures Act*, to issue an OLTC on request of the holder of the mineral rights in this area. Most recently, on August 30<sup>th</sup> the Tsilhqot'in National Government issued a media release stating that "the Tsilhqot'in community of Xeni Gwet'in is assembling for a peaceful gathering and harvesting camp at Fish Lake and Little Fish Lake", adjacent to the New Prosperity mine site. Additional camps are anticipated on key forestry access roads, in response the Province's recent allocation decision on Annual Allowable Harvest for moose in the region.

#### "Dasiqox Tribal Park" – Declared by TNG

The Dasiqox Tribal Park is a declaration by Yunesit'in, and Xeni Gwet'in. The tribal park is on 300,000 hectares of land surrounding Fish Lake, also called Teztan Biny, about 125 km southwest of Williams Lake. There are significant natural resources within the proposed tribal park including but not limited to:



the proposed New Prosperity Mine site; Amarc's Ike property and significant areas of scheduled timber harvesting.

#### IF PRESSED regarding the OLTC

- The province's Statutory Decision Maker is legally required under the *Mineral Tenures Act* to issue the Occupant License to Cut requested by the company.
- Because this is a statutory obligation, there is no flexibility or discretion in issuing this permit.
- B.C. has consulted extensively with the Tsilhqot'in on the proponent's Notice of Work and Occupant License to Cut applications, including conditions that could be included that would help minimize impacts to Tsilhqot'in rights and interests.
- The Occupant License to Cut is directly tied to the work to be undertaken under the NOW, which the BC Supreme Court has considered and upheld as being valid.

# IF PRESSED regarding UNDRIP and "Free Prior and Informed Consent"

- The suggestion that the United Nations Declaration is reducible to a veto on development is disingenuous and inaccurate.

**REGARDING:** Tsilhqot'in Opposition to New Prosperity Mine

#### **BACKGROUND**

In July 2017, EMPR authorized Taseko Mines Ltd. (TML) to undertake an exploration program that includes new/modified trails, test pits and drill sites. After the BC Supreme Court dismissed injunctions from both the CEAA and Tsilhqot'in, on August 23, 2018, Taseko provided notice to BC and to the Tsilhqot'in, that they intend to start works under the Notice of Work (NOW), not before September 1.

Imminently, Taseko is anticipating receiving an Occupant License to Cut (OLTC). Taseko requires the OLTC to harvest Crown timber, and the district manager is required under Section 14 of the *Mineral Tenures Act* to issue an OLTC on request of the holder of the mineral rights in this area. Provincial District staff took additional steps to engage with TML and the Tsilhqot'in, and provided possible conditions that could be included in the OLTC.

#### **ISSUE**

The issuance of the OLTC will create significant tensions with TNG, who are adamantly opposed to the New Prosperity Mine project. TNG has publically announced they will appeal the decision, seek an injunction to prohibit drilling, and support a "peaceful gathering and camp" at Teztan Biny (Fish Lake) and Yanah Biny (Little Fish Lake). TML has notified the RCMP, and MIRR has notified and engaged its Critical Incidents & Emergency Management (CIEM) team.

TML has indicated that they will be accessing the project site on Friday, September 7<sup>th</sup> with helicopter support, and trucks accessing the site on Saturday, September 8<sup>th</sup>.

#### Access

Most recently, on August 30<sup>th</sup> the Tsilhqot'in National Government issued a media release stating that "the Tsilhqot'in community of Xeni Gwet'in is assembling for a peaceful gathering and harvesting camp at Fish Lake and Little Fish Lake", adjacent to the New Prosperity mine site. Additional camps are anticipated on key forestry access roads, in response the Province's recent decision to proceed with a limited licensed hunt for moose in the Chilcotin. C

Chief Joe Alphonse has directed staff to communicate with forestry licensees that community members will be shutting down Raven Lake and Mackin Creek Forest Service Roads, to 'protect moose'.

#### **SUMMARY**

- B.C. has consulted extensively with the Tsilhqot'in on the proponent's Notice of Work and
  Occupant License to Cut (OLTC) applications, including conditions that could be included that
  would help minimize impacts to Tsilhqot'in rights and interests. FLNR's statutory decision maker
  is in the process of issuing the OLTC.
- The area covered by the declared Dasiqox Tribal Park is of great interest and importance to the
  public, industry stakeholders, and indigenous communities. The Province has offered to
  advance discussions with the Tsilhqot'in about this geographic area through the Accord working
  group.
- A number of provincial and regional initiatives already operate in the spirit of UNDRIP, such as
  revitalizing the environmental assessment process, incorporating traditional Indigenous
  knowledge into resource management, and engaging in an in-depth way with the Tsilhqot'in on
  moose recovery and other joint stewardship initiatives.
- In recognition that the proposed New Prosperity Mine site rests on culturally sensitive land, the
  province will be looking a engaging TNG in a unique way that respects the spirit of UNDRIP and
  the intent of the provincial draft 10 Principles.

In addition to that earlier consultation, the province recently undertook further engagement with Tsilhqot'in on additional conditions that could be attached to the OLTC to avoid and minimize, to the extent possible, impacts on Tsilhqot'in rights and interests arising from the OLTC.

Mike indicated you were looking for an update on the Dasigox Tribal Park:

The Dasiqox Tribal Park, an initiative of the Xeni Gwet'in and Yunesit'in communities of the Tsilhqotin, was announced on October 4, 2014. The Province did not participate in the development of the initiative and has not formerly endorsed the proposal other than acknowledging that it represents a clear statement of Tsilhqot'in values and interests in the area identified. Work by the two communities has progressed to the point of the release of the Community Vision and Management Goals for Dasiqox Tribal Park in April of this year. There are 8 Management Goals in the Dasiqox proposal related to:

- Water
- Forests and Vegatation
- Wildlife and Habitat
- Hunting, Fishing, Harvesting Plants and Animals
- Cultural Continuity and Language
- Health and Well-being and time on the Land
- Sustainable Livelihoods
- Cumulative Effects and Managing Impacts

The Nengay Deni Accord includes a Leadership Table comprised of Provincial Ministers and the Chiefs of the six Tsilhqot'in communities. At the June 5th Accord Leadership Meeting a short term (4 month)workplan was endorsed which included the scoping of issues and options related to the Dasigox Tribal Park. Following discussions with the Tsilhqot'in Tribal Park Coordinator FLNR staff agreed to provide as the next step in the scoping exercise the provincial perspective on the Dasigox goals. For each of the Dasigox goals we are identifying Provincial interests, legislative tools and considerations related to their application. An initial draft should be complete next week. While the engagement in a land use planning exercise may be a potential option, the scoping exercise isn't directed towards that outcome. There are a number of existing legislative and policy tools that may be a more appropriate way to address Tsilhqot'in concerns. While the New Prosperity project is a significant driver in the development of the Dasigox proposal, forestry practices in the area are also of concern to the Tsilhqot'in. As a short term response we will commit to a joint review of forestry practices in Dasigox and the application of voluntary practices by licencees and, where appropriate, the use of legal tools to establish interim measures to address Tsilqot'in concerns. I will be providing an update on the Dasigox scoping work to Tsilhqot'in representatives at the Sept 13/14 Working Group meeting.

# Taseko New Prosperityand Tsilhqot'in

### ADVICE AND RECOMMENDED RESPONSE:

- This is a longstanding and complex matter, and the Province is well aware of the concerns expressed by <u>Tsilhqot'in and Tasekoboth parties</u>.
- Our government is committed to working with the TNG government\_to government to deal with land use management within the framework of the Nengay Deni Accord and the Tsilhqot'in Stewardship Agreement.

TNG September 6 letter to PJH and MMM seeking cultural heritage protection from exploration activities

 We have received the letter from the Tsilhqot'in National Government and are still reviewing the Tsilhqot'in's request.

# If asked about the Occupant Licence to Cut:

The statutory decision—maker <u>has decided on issuing the licence will consider the application</u> in accordance with the legislative authority granted to <u>them him</u>.

#### **KEY FACTS REGARDING THE ISSUE:**

The B.C. Supreme court dismissed the Tsilhqot'in National Government's (TNG) Petition for Judicial Review, which challenged the adequacy of consultation and accommodation prior to the July 2017 issuance of a permit amendment for exploration work relating to Taseko's New Prosperity Site Investigation Program.

The court stated that "both the consultation process and degree of accommodation were such that the honour of the Crown was maintained, and adequate reconciliation efforts were made in the circumstances... The petitioners do not raise any material issues with the process or the extent of the consultation... I find that the reasons for the 2017 Approval provided adequate justification, transparency and intelligibility."

TNG responded with a media release several days after the court ruling, in which they called on the provincial government to "step up" and "do the right thing," and asserting that "drilling work is

in direct violation of the current BC NDP government's mandate given by Premier Horgan in every Minister's mandate letter issued in July 2017, the current Federal Government's commitment to fully implement the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) at the UN General Assembly in August 2016, and the Truth and Reconciliation Commission's (TRC) Calls to Action."

On Aug. 29, new counsel retained by TNG informed the Province that they are appealing the decision and may be seeking an injunction from the Court of Appeal to prevent Taseko from undertaking the drilling program until their appeal is decided - unless Taseko agrees to withhold doing the work until the appeal is decided. Taseko responded that, having waited since July 2017, they now intend to proceed with the work.

On Aug. 30, TNG issued a news release stating that members were "assembling for a peaceful gathering and harvesting camp at Teztan Biny (Fish Lake) and Yanah Biny (Little Fish Lake)."

Unconfirmed reports were received on Sept. 5, indicating TNG Elders had occupied a site near Fish Lake.

On Sept. 6, 2018 in a letter to Premier John Horgan and Minister of Energy, Mines and Petroleum Resources, Michelle Mungall, the <u>TNG Tsilhqot'in National Government</u> requested the minister <u>use a invoke her</u> power under s. 17(1) of the *Mineral Tenure Act* to protect and preserve Teztan Biny (Fish Lake), Yanah Biny (Little Fish Lake) and Nabas (the surrounding area).

Taseko Mines Ltd has commenced assessment, survey and layout work, but no work involving any form of mechanical disturbance at this time.

TNG has also reiterated their calls for the establishment of a park, Dasiqox Tribal Park, "to protect this critical area for future generations."

The proponent has applied for Taseko is in the process of receiving an Occupant Licence To Cut, which is necessary to cut down trees for the exploration work under undertake the scope of the work that the Notice of Work granted. That application is currently with the Statutory Decision Maker (at FLNRO) for consideration.

However, the proponent has indicated its plans to begin work on Sept. 1, since there is a degree of work that the company can proceed with whether or not the Occupant Licence To Cut is issued.

Previously, on July 5, 2018, the BC Supreme Court ruled in favour of the TNG's request for an interim injunction to stop Taseko from undertaking the drilling program authorized by the 2017 notice of work, until the court gave a decision on the petition. The injunction was set to expire on Sept. 10, 2018 or upon release of the court's decision on the petition.

#### **BACKGROUND:**

On Dec. 5, 2017 the Federal Court of Canada dismissed Taseko's two judicial review applications challenging the federal government's rejection of the New Prosperity proposal.

In dismissing Taseko's applications, the Federal Court of Canada determined that there had been no breach of procedural fairness and that the findings of a panel tasked with evaluating the impacts on the environment of tailings were "reasonable."

Taseko had challenged the federal panel report and process, as well as the federal decision.

On January 3, 2018 Taseko submitted notices to appeal the Federal Court's findings.

### Amendments to Notice of Work permit:

In July 2016, Taseko began preparations for an exploration program to collect data for permitting under the provincial Mines Act, and for potential redesigns of New Prosperity. Taseko applied under the Mines Act for permits, including an amendment to an existing permit, MX-3-131, and a licence under the Forest Act.

In July 2017, the Ministry of Energy and Mines issued an amendment to permit MX-3-131 to Taseko for the New Prosperity Site Investigation Program. The CEAA then wrote to Taseko, asking if the permit work included anything connected to New Prosperity, and also asked whether any of the activities were designated activities under CEAA 2012.

Taseko responded that the work was not connected to New Prosperity.

The CEAA took the position that the activities proposed were contrary to s. 6 of the CEAA 2012 and therefore those activities would constitute a federal offence. Taseko responded, disputing the view that the activities were unlawful.

In August 2017, the federal government filed an injunction petition enjoining Taseko from carrying out the work outlined in Permit MX-3-131. The following month, Taseko filed its own petition, maintaining that Section 6 of CEAA 2012 doesn't apply to the activities that Taseko has been provincially authorized to perform pursuant to Permit MX-3-131 issued under the Mines Act.

TNG has asked the EAO to terminate the amendment review process given Taseko does not have federal approval of the New Prosperity Project nor the ability to conduct the NOW activities, which puts Taseko's ability to demonstrate a substantial start of the project by January 2020 in question.

Concurrently with its review of the amendment, between February and May 2018, the EAO conducted a process on whether it is possible for Taseko to substantially start the Project by January 14, 2020 and the appropriateness of the Associate Deputy Minister refusing to amend the Certificate. EAO noted that it would not be in the public interest to review a proposal that has no utility.

The EAO has received submissions from Taseko and Indigenous groups. The EAO is

considering the submissions and will be concluding this process shortly. The EAO continues to work on the assessment of the proposed amendment.

New Prosperity, a proposed conventional open-pit mining project with a 20-year operating life and a production capacity of 70,000 tonnes of mineral ore per day, is 125 km southwest of Williams Lake. The mine would be located outside of the declared <u>aboriginal</u> title area of the Tsilhqot'in Nation, but within an area where the Tsilhqot'in Nation has established Aboriginal rights. The Tsilhqot'in National Government has recently declared <u>a proposed</u> Dasiqox Tribal Park area, which includes the area where the mine would be built. The most recent capital cost estimate <u>for the proposed mine</u> is \$1 billion, with annual operating costs of \$200 million.

#### **Current Activities**

- Tsilhqot'in National Government (TNG) is a tribal council representing six member bands. Tsilhqot'in communities are not party to the BC Treaty Process.
- The 2007 Tsilhqot'in court case, referred to as "the William case" after previous Xeni Gwet'in Chief Roger William, who filed on behalf of Xeni Gwet'in and the Tsilhqot'in Nation, was the first time the SCC granted aboriginal title in Canada. This was in June 2014.
- On June 21, 2016, the Tsilhqot'in Nation filed a Notice of Civil Claim seeking a declaration that aboriginal title exists on submerged lands, private lands and Indian reserves within the declared title area. They have advised this is a protective claim against a litigation period and do not intend to advance the claim. However, in June 2017 the case was served to the Province of BC.
- ➢ On March 26, 2018, Prime Minister, Justin Trudeau delivered a statement of exoneration on behalf of the Government of Canada to the Tsilhqot'in Nation and the descendants of six Tsilhqot'in Chiefs. In 1964, five Tsilhqot'in Chiefs were hanged for murder after they led their nation's war efforts in response to a colonial road crew attempting to build a road through their territory without any legal agreement with the Tsilhqot'in Nation.¹ Premier Horgan issued a statement in support of Trudeau's exoneration.
- On November 1, 2018, Premier Horgan and Chief Joe Alphonse signed a letter that renewed commitment to the Nenqay Deni Accord, to make progress on the eight 'pillars of reconciliation'.

### **Other/Completed Negotiations**

Nenqay Deni Accord, signed on February 11, 2016, is a five year framework agreement that establishes a shared vision, principles and structures to negotiate a comprehensive reconciliation between the Tsilhqot'in Nation and the Province. The Accord has established five implementation tables, jointly chaired by representatives of the Province and the Tsilhqot'in, to guide progress in the following areas: Tsilhqot'in Governance; Economic Development; Social, Culture, Education and Justice; Lands and Resources and Declared Title Area Implementation. The Province currently is preparing a Treasury Board submission to secure funding for Year 4 and Year 5 of the Accord.

- Moose Co-Management Agreement (Sept 2018): The Province and TNG have been working on moose recovery for many years. This fall, a Moose Co-Management Agreement heightens commitments that support growing more moose for all. A key priority for 2018 is jointly hosting a Moose Solutions Roundtable, where neighboring nations and stakeholders will be invited to constructively discuss solutions.
- > Tsilhqot'in Stewardship Agreement (2017-2020): Five of six communities signed on to the 3 year renewal of this Strategic Engagement Agreement (Yunesit'in chose not to).
- Collaborative Emergency Management Agreement (April 2018): focuses on improving emergency management within the six Tsilhqot'in communities, including enhancing the role and capacity of Tsilhqot'in communities in mitigation, preparedness, response and recovery pillars of emergency management, and exploring opportunities for partnership.

## **Issues/Opportunities:**

- Aboriginal Title Area Transition: transitioning benefit and control of the aboriginal title
  area has been a focus of the Land and Resource Sub-Table under the Nenqay Deni
  Accord. Five "Bridging Agreements" were renewed in spring 2018, in lieu of a final
  arrangement, to ensure continuity for provincially authorized activities in the short
  term.
- Prosperity Mine: The proposed Prosperity mine is located within Xeni's caretaker area
  of the proven aboriginal rights area (not the aboriginal title area). Xeni and the
  Tsilhqot'in Nation remain steadfast in their opposition to the project. In 2017, MEM
  granted a Notice of Work for a series of drill holes; in August, FLNR issued a long
  awaited OLTC with specific conditions, and TNG initiated court injunction which ends
  later in November.

## Ministry of Indigenous Relations and Reconciliation Tsilhqot'in National Government

- Dasiqox Tribal Park: In October 2014 the Xeni Gwet'in along with the Yunesit'in announced that they had declared an area of approximately 3,000km2 in the Taseko Lake area in the South Chilcotin. The declared park area is outside of the Tsilhqot'in title land. The area of land covered by the tribal park is rich in natural resources and contains many known ore bodies, including the Prosperity site. BC has maintained that the area in question remains under Provincial authority. The Nenqay Deni Accord Working Group is discussing Tsilhqot'in interests relating to the declared Tribal Park.
- **Tourism Operators**: Tourism operators around the Aboriginal Title Area have lobbied provincial and federal governments to resolve the conflict around bear viewing, access uncertainty and use of roads in the Declared Title Area, or to 'buy them out'. Currently, appraisal work is underway, to inform the province's options.
- Forestry Tenures and Revenue Sharing:
  - o Each Tsilhqot'in community is pursuing a First Nations Woodland Licence.
  - Forestry Consultation and Revenue Sharing Agreement offers were declined by the Tsilhqot'in. To secure an accommodation option for FLNR decision makers, the Tsilhqot'in have been provided with \$1.6m per year for the last four years.
  - Forest Tenure Opportunity Agreement for the Nenqay Deni Accord volume commitments are with the TNG for signing
- ➤ Moose Recovery. TNG and FLNR representatives actively engaged in discussion around management options for licensed moose hunting prior to the October hunting season. Licensed hunting opportunity has been reduced, in consideration of TNG's concerns, and uncertainty around impacts from wildfire; through discussions, TNG maintain there should be no licensed hunt. A moose co-management agreement was signed September 28<sup>th</sup> committing both the Province and the TNG to working together to manage moose. One of the deliverables from the agreement is a Moose Solutions Roundtable that is set to take place early December.
- ➤ Williams Lake Timber Supply Review (TSR) decision was made in 2015 after significant engagement with the Chief Forester. TNG remains concerned over the rate of cut, and the Annual Allowable Cut particularly post 2017 wildfire season. The Chief Forester met with TNG representatives in July 2018.
- Mushroom Picking. Post wildfire, the Tsilhqot'in set up a permitting system to manage volume and stewardship behavior of mushroom pickers. TNG prepared a press release in August 2018, thanking everyone for their partnership through the season.

For a while now we have been tossing around the concept of IPCAs as part of the discussions around Canada's target 1 and biodiversity targets. I have been suggesting we need to engage with nations to flesh out the concepts for a made in BC approach to IPCAs but first need to get our own thinking straight. I also think that IPCAs may represent at least a partial solution to the issue of Parks as TSL. Unfortunately we have been caught in a bit of a decision swirl around this topic and have not received a formal mandate from DMs. Based on what I am hearing it's my thinking that we are cleared to start working on the concept and need to "just do it". I am hoping that we can find some time to sit down and together figure out who from each of our agencies we can task with developing a discussion paper on IPCAs?

Because of the growing interest in indigenous conservation areas (CFN, TNG, Haida, others) time is of the essence if we are to be prepared to respond meaningfully to nations. I will ask my assistant to find us a half hour. Please feel free to suggest others who should be part of the conversation.

Hi Jav.

Very glad to hear the support for the closure to steelhead retention in the Chilcotin watershed. We will have that regulation change request in to the Director ASAP and expect that it will be in place by next week sometime.

Also glad to hear that TNG wants to work with us on a guardian program on the Chilcotin River for this period where steelhead are in the system and vulnerable to fishing. We don't need to wait for the regulation change to get this up and running.

Due to the end of the fiscal year approaching we will have to deal with funding the project in two stages.

The initial piece, from when we start until the end of the month will have to be done through direct invoice from the TNG to FLNRORD Fish and Wildlife section. We will have to get together to develop a plan for this initial period.

We will then follow-up with a contract commencing on April 1 to the end of the steelhead fishing season and have to develop a second schedule and plan for this portion.

Please let me know who we should connect with at TNG to develop the schedules and work plan for this project. Lee Williston, our Senior Fisheries Biologist will be our lead for the Chilcotin steelhead guardian project and will connect with your lead early next week. Let me know if you have any other questions.
