Good morning Minister,

Last week you asked us a question regarding the opportunity for wood as a part of seismic upgrading. While we don't have details on the specific technical options, the information Nikki gathered below indicates that there is a significant opportunity for expanding wood use in this work: EDUC's Seismic Mitigation Program has **165 schools** that remain to be addressed for seismic strengthening, partial or full replacement.

- 15 currently in design or tender stages,
- 36 in preliminary business case development,
- 114 slated as future priorities ( future year business cases)

Potentially a real opportunity for use of wood and engineered wood products for those upgrades, especially for the 114 still slated as "future priority" (i.e. no design/budget has yet been assigned).

We will defend B.C.'s interests in the softwood lumber dispute and make sure forest workers, families and communities have the support they need to mitigate the impact of these duties.

We'll also continue to pursue growth in other markets for B.C. wood products both at home through expanding innovation in wood products and abroad by maintaining and expanding Asian markets."

We're working closely with the federal government, other provinces and B.C. companies to seek a fair hearing of the issues through all the channels that are available to us.

We believe that an independent tribunal will find that the current U.S. allegations against Canada are as unfounded as the ones they brought in the past.

Hi Mary,

Briefly, yes both species are listed as endangered under the Species at Risk Act, a designation that goes back to May of 2016. Provincially, they are listed as "Critically Imperiled."

Of course, the federal Department of Fisheries and Oceans is the lead agency. Staff informs me that:

- **DFO is in the process of amending the recovery strategies** for both of these species to reflect new scientific information. These documents have completed provincial reviews and a provincial response was sent to DFO in October 2017.
- Amendments include the redefinition of critical habitat to include all riparian vegetation (from native vegetation) and identified 5 additional reaches of critical habitat for Salish Sucker and 1 additional reach of critical habitat for Nooksack Dace in Bertrand Creek. The Critical Habitat Order currently in place does not include this critical habitat.
- **In fall 2017, DFO indicated that they would be engaging with external review by First Nations and stakeholders: landowners, neighbours, and partners regarding the changes in the proposed strategies.** Notice of consultations within the Pacific Region are posted to [DFO's website](#). There is also an additional opportunity for feedback during the 60 day public consultation period upon the posting of the document as proposed.

Hi Larry Pynn is looking for ministry's response to yesterday's Forest Practices Board report.

I propose sending him these points from the issues note attributable to me as ministry spokesperson. Any concerns?

- The ministry welcomes the board's report.
- Under the Forest and Range Practices Act and regulations, government sets legal objectives to protect biodiversity. Conservation designations such as old growth management areas and wildlife habitat areas also protect about 95% of at-risk plant communities.
- There is a gap in existing legislative requirements, and as recommended by the board the ministry will look at options to address that.
- As well, the ministries of FLNRORD and Environment will update the Identified Wildlife Management Strategy to ensure it properly identifies those plant and animal species most at risk.
- BC Timber Sales will carefully consider the board's recommendation regarding revising its protocol to include consideration of younger occurrences of plant communities in consultation with appropriately qualified professionals.

### **New funding programs to drive innovation and economic priorities in the North**

#### **January 16, 2018 - For immediate release**

Northern Development Initiative Trust announced two new funding programs today that will support innovation projects in traditional northern B.C. industries and key community-based strategic economic priorities. The Northern Industries Innovation Fund and the Strategic Initiatives Fund will provide up to \$1.65 million annually in grant funding for projects throughout central and northern B.C.

These funds are part of the Trust’s ongoing response to mitigate the economic impact of the mountain pine beetle epidemic, with priority given to projects within the regions and communities most impacted by the pine beetle and decreasing timber supply.

#### **Northern Industries Innovation Fund**

Following the success of the Forest Innovation Fund, Northern Development has restructured the program with a commitment of up to \$750,000 annually to create the Northern Industries Innovation Fund and support innovation projects across a variety of northern industries. The Northern Industries Innovation Fund will provide rebate funding up to \$50,000 to a maximum of 50% of a project's budget for small and medium enterprises deploying innovative technologies in industries such as mining, energy, agriculture, aquaculture and forestry.

By supporting applied research, the development of new or improved products /services and the testing of innovative equipment or technologies, the program will help the northern B.C. businesses improve their competitiveness, generate incremental revenue and create jobs.

Eligible companies must be privately owned, incorporated, have less than 500 employees, revenues less than \$100 million and be operating within the Northern Development Initiative Trust region.

Applications will be accepted on an ongoing basis until the annual allocation for the fund is exhausted.

### **Strategic Initiatives Fund**

The Strategic Initiatives Fund is a new proposal-based program that allows municipalities and First Nations to apply for grant funding to support significant projects that focus on long-term economic transformation and sustainability.

The program is supported with a \$900,000 commitment from Northern Development with grant funding only limited by the annual funds allocated to the program, up to 80% of a project's value.

The program allows Northern Development to support strategic projects that may not otherwise fit into its suite of programs, but that are large in scale, regional in impact, enhance a community or multiple communities' ability to overcome economic challenges and will result in incremental capacity or strategic economic infrastructure within a municipality or First Nation.

Applications for the Strategic Initiatives Fund will be accepted until March 15th with funding decisions determined in April.

**Subject:** Water Licenses

Hi Tim,

For all water licenses licensed under the Water Sustainability Act there are several tools to manage water usage during times of water scarcity, the main tenant being "First in Time First in Right". This means when there are several water licenses held in one stream the senior licenses get the full amount, and junior licenses get their rights suspended if need be.

In the event a water license is not held, the company is still governed by WSA (as is the case with Nestle). There is a 3 year "grandfathering" transition after which point priority rights start to get impacted.

In the case where there is one licensee, and no ecosystem impacts, the licensee maintains rights to use all the water. Where there are ecosystem needs/fish, the minister has the ability to declare an Area of Water Scarcity, in which case the licensees, no matter priority, are suspended.
