NOTICE OF ESTABLISHMENT OF NOTATION OF INTEREST

RE: That part of District Lot 1944, together with that parcel or tract of Unsurveyed Crown Land in the vicinity of Pink Mountain (within Bloc I, 94-B-14, Block L, 94-B-15, Blocks B, C & D, 94-G-02 and Block A, 94-G-03), Peace River District, containing 12,462.91 hectares, more or less.

AUTHORITY: The undersigned has been charged with the administration of Crown Land under the *Land Act*; and

DECISION: The undersigned considers it advisable to establish Notation of Interest no. R148013 over the area identified on the attached sketch; then

AGENCY AND EFFECTIVE PERIOD: A Notation of Interest is established over Crown Land, highlighted on the attached sketch, to record the interest of the Ministry of Aboriginal Relations and Reconciliation in the area due to its importance for the purpose of prevention of unintended alienation of these lands prior to the final TLE settlement with Canada, effective September 9, 2014, for a period of 5 years. Applications for Crown Land in the above area are to be referred to the Ministry of Aboriginal Relations and Reconciliation for comment and consultation in the adjudication of such applications.

PRIOR RIGHTS: This Notation of Interest is subject to the following:

- (i) all subsisting dispositions and subsisting grants to or rights of any person made or acquired under the *Coal Act*, *Forest Act*, *Mineral Tenure Act*, *Petroleum and Natural Gas Act*, *Range Act*, *Wildlife Act* or *Water Act*, or any extension or renewal of the same, whether or not you have actual notice of them;
- (ii) prior dispositions under the *Land Act*; and
- (iii) the exceptions and reservations of interests, rights, privileges and titles referred to in section 50 of the *Land Act*.

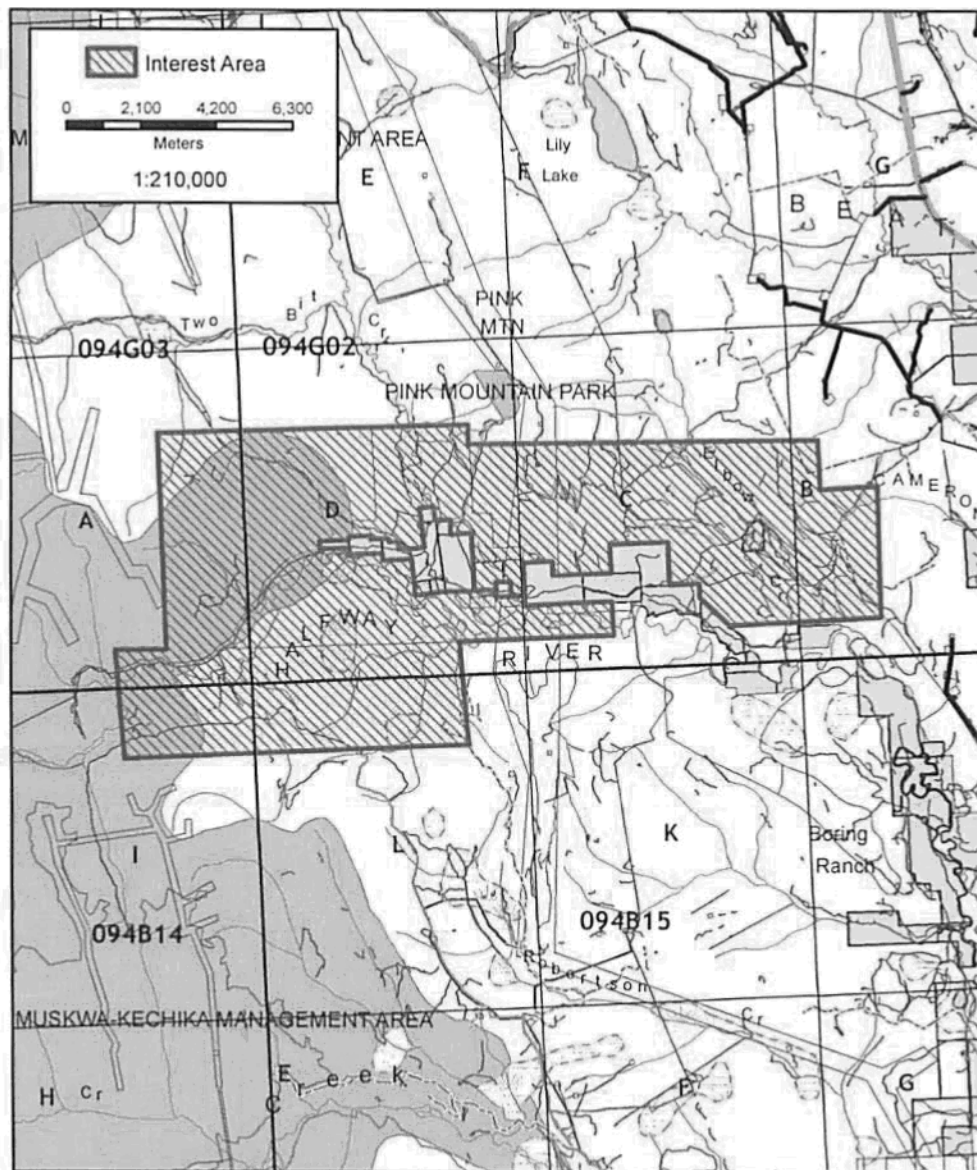

NOTICE OF ESTABLISHMENT OF SECTION 17 CONDITIONAL WITHDRAWAL FROM DISPOSITION

Re: That part of District Lot 1944, Peace River District together with those parcels or tracts of Unsurveyed Crown Land in the vicinity of Pink Mountain (within Block I, 94-B-14, Block L, 94-B-15, Blocks C & D, 94-G-02 and Block A, 94-G-03), Peace River District, containing 5,750.83 hectares, more or less.

WHEREAS: The undersigned has been charged with the administration of Section 17 of the Land Act; and

WHEREAS: The undersigned considers it advisable in the public interest to establish a conditional withdrawal from disposition over the area identified on the attached map; then

THEREFORE: The Crown land area outlined on the attached map is hereby conditionally withdrawn from disposition for a period of ten (10) years due to its importance to support negotiations and reconciliation with the Blueberry River first Nation. The area is hereby withdrawn from disposition under the Land Act for any purpose or use that is not compatible with the above.

THEREFORE: The subject Section 17 is intended to allow for Treaty Land Entitlement discussions and negotiations to occur between the Ministry of Indigenous Relations and Reconciliation and Blueberry River First Nation over the length of the tenure term. No Land Act applications are to be accepted within the Section 17 area with the exception of those that are compatible with the purpose of supporting negotiations and reconciliation with the Blueberry River First Nation.
